# IN THE HIGH COURT OF JUSTICE IN NORTHERN IRELAND.

KING'S BENCH DIVISION—IN BANKRUPTCY

Patrick Joseph McKeating, of 53 Great Patrick Street, Belfast, Tobacconist, was on the 31st day of August, 1936, adjudged Bankrupt.

PUBLIC SITTINGS will be held before the Court at the Royal Courts of Justice (Ulster), Belfast, on Friday, the 25th day of September, 1936, and on Friday, the 2nd day of October, 1936, at the hour of 11 o'clock in the forenoon, whereat the Bankrupt is to attend, and to make a full disclosure and discovery of his Estate and Effects. # IN THE HIGH COURT OF JUSTICE IN NORTHERN IRELAND.

KING'S BENCH DIVISION—IN BANKRUPTCY PATRICK BOOMER, of 197, Falls Road, in the County of the City of Belfast, Newsagent & Tobacconist, was on the 7th day of September, 1936, adjudged Bankrupt.
