DANGEROUS DRUGS ACTS (NORTHERN IRELAND), 1920-1932. WITHDRAWAL OF AUTHORITY. JAMES WILLIAM GILCHRIST.

WHEREAS James William Gilchrist, Pharmaceutical Chemist, whose registered address is 147 Antrim Road, Belfast, being a person duly registered under the Pharmacy and Poisons Act (Northern Ireland), 1925, has been convicted of an offence under the Dangerous Drugs Acts:

And whereas the said James William Gilchrist cannot, in my opinion, properly be allowed to be in possession of or to supply raw opium, coca leaves and Indian hemp, nor to carry on the business of manufacturing, selling or distributing any of the drugs to which Part III of the Dangerous Drugs Act, 1920, applies:

Now, therefore, after consultation with the Council of the Pharmaceutical Society of Northern Ireland, and in pursuance of the powers conferred on me by No. 6 of the Raw Opium Regulations, 1921, as extended by the Raw Opium, Coca Leaves and Indian Hemp Regulations, 1929, and by No. 7 of

Dangerous Drugs (Consolidation) the Regulations, 1928, as applied by the Dangerous Drugs Regulations (Northern Ireland), 1929, I hereby give notice that I withdraw, as from to-day's date, from the said James William Gilchrist the authority granted by the said Regulations to persons who lawfully keep open shop for the retailing of poisons to be in possession of and to supply raw opium, coca leaves and Indian hemp, or to manufacture any extract or tincture of Indian hemp or any preparation to which Part III of the Dangerous Drugs Act, 1920, applies, or to carry on the business of retailing, dispensing, or compounding the drugs or preparations to which Part III of the Act applies.
