AGRICULTURAL MARKETING (PIG INDUSTRY) ACT (NORTHERN IRELAND), 1934.

DETERMINATION OF PIG INDUSTRY COUNCIL FOR NORTHERN IRELAND.

The Pig Industry Council for Northern Ireland (hereinafter referred to as "the Council"), in exercise of their powers under Section Five of the Agricultural Marketing (Pig Industry) Act (Northern Ireland), 1934, hereby determine as follows:

As and from the 1st day of June, 1937, the Determination of the Council made with the approval of the Ministry of Agriculture for Northern Ireland on the 29th day of January, 1937, and amended with the approval of the said Ministry on the 30th day of March, 1937, shall be amended and have effect as follows:

The said Determination of the Council in so far as it relates to the prices applicable to pigs sold dead or alive the dead weight of which is under 1 cwt. 0 qr. 21 lb. shall provide that—

- (a) in the case of pigs sold dead which weigh not less than 1cwt. 0qr. 0lb. and not more than 1cwt. 0qr. 20lb. and are not unsuitable for bacon, the price per cwt. shall be 12/- less than the basic Wiltshire pig price;
- (b) in the case of pigs sold alive to Wiltshire curers under direct contract or to the Pigs Marketing Board (Northern Ireland) and resold to Wiltshire curers in Northern Ireland which

weigh not less than 1cwt. 0qr. 0lb. and not more than 1cwt. 0qr. 20lb. and are not unsuitable for bacon, the price per cwt. dead weight shall be 8/- less than the said basic Wiltshire pig price. The price per cwt. dead weight for pigs classified as unsuitable for bacon shall be 10/- less than the said basic Wiltshire pig price; and

- (c) in the case of pigs weighing less than 1cwt. 0qr. 0lb. dead weight there shall be no fixed price.
