RAW OPIUM REGULATIONS.**

Notice is hereby given that on the 16th day of May, 1938, the Minister of Home Affairs, in pursuance of Section 3 of the Dangerous Drugs Act, 1920, and Section 1 of the Dangerous Drugs Act (Northern Ireland), 1925, made Regulations for controlling and restricting the possession, sale and distribution of Raw Opium, Cola Leaves, Indian Hemp, and Resins obtained from Indian Hemp, and all preparations other than extract or tincture of Indian Hemp, of which such resins form the base.

**TRADE BOARDS ACT (NORTHERN
IRELAND), 1923.**

**BOOT AND SHOE REPAIRING TRADE
BOARD (NORTHERN IRELAND).**

The Trade Board established by the Ministry of Labour for Northern Ireland under powers conferred by the Trade Boards Act (Northern Ireland), 1923, for the Boot and Shoe Repairing Trade in Northern Ireland as defined in the Schedule to the Trade Boards (Boot and Shoe Repairing Trade, Northern Ireland) (Constitution, Proceedings and Meetings) Regulations, 1925, dated 30th July, 1925, hereby give notice that they propose to vary the general minimum time-rates and general overtime rates for male workers.

On request to the Trade Board particulars of the proposed minimum rates will be given if, in the opinion of the Trade Board, the applicant is likely to be affected thereby.

The Trade Board will consider any objections to their proposals which may be lodged with them within fourteen days from the Twentieth day of May, 1938. Such objections should be in writing and signed by the person making the same (adding his or her full name and address) and should be sent to the Secretary of the Boot and Shoe Repairing Trade Board (Northern Ireland), Office of Trade Boards, Stormont, Belfast. It is desirable that persons making objections should state, as far as possible, the precise grounds therefor.

MARKETING OF EGGS.

DETERMINATION OF WHOLESALE DEALERS' PRICES.

ORDER DATED THE THIRTEENTH DAY OF MAY, 1938, MADE BY THE MINISTRY OF AGRICULTURE UNDER SECTION ONE OF THE MARKETING OF EGGS ACT (NORTHERN IRELAND), 1936.

The Ministry of Agriculture, in exercise of the powers conferred on it by section one of the Marketing of Eggs Act (Northern Ireland), 1936, and of every other power enabling it in that behalf and in accordance with advice given by the Egg Marketing Committee for Northern Ireland hereby determines as follows, that is to say:—

1. Subject as hereinafter provided, the prices payable by licensed wholesale dealers for eggs delivered during the week ending Saturday, 14th May, 1938, shall be as follows:—

HEN EGGS.

(a) (i) For hen eggs purchased by a licensed wholesale dealer from a producer where the eggs were produced by the producer's own hens, 7d per lb.:

Provided that where the eggs were delivered by the vendor to premises used by a licensed wholesale dealer of Class A for the testing, grading and packing of eggs, or to the premises set forth in the Schedule to this Order, an additional half-penny per lb. shall be paid:

(ii) For hen eggs purchased by a licensed wholesale dealer of Class A from a licensed wholesale dealer of Class B, 7 5-16d. per lb.:

DUCK EGGS.

(b) For duck eggs purchased by a licensed wholesale dealer from a producer where the eggs were

produced by the producer's own ducks 10d per dozen:

Provided that where the eggs were delivered by the vendor to premises used by a licensed wholesale dealer of Class A for the testing, grading and packing of eggs, or to the premises set forth in the Schedule to this Order, an additional three-farthings shall be paid for each complete dozen so delivered.

2. Deductions shall be made from the foregoing prices at the following rates in respect of eggs of the descriptions specified:

- For each hen egg marked "Second" $\frac{1}{2}$ d.;
- For each hen egg marked "Reject" $\frac{3}{4}$ d.;
- For each duck egg marked "Reject" $\frac{3}{4}$ d.;

3. This Order may be cited as the Marketing of Eggs (Determination of Wholesale Dealers' Prices (No. 19) Order (Northern Ireland), 1938, and shall be construed as one with the Marketing of Eggs (Determination of Wholesale Dealers' Prices) Order (Northern Ireland), 1937.
