CIVIL AUTHORITIES (SPECIAL POWERS) ACTS (NORTHERN IRELAND), 1922 and 1933.

Whereas certain Regulations for Peace and Order in Northern Ireland are contained in the Schedule to the Civil Authorities (Special Powers) Act (Northern Ireland), 1922, and it is provided by sub-section (3) of section 1 of the said Act that the Minister of Home Affairs shall have power to make Regulations (a) for making further provision for the preservation of the Peace and Maintenance of Order, and (b) for varying or revoking any provision of the Regulations, whether contained in the said Schedule, or made as aforesaid, and that any Regulations made as aforesaid shall, subject to the provisions of the said Act, have effect and be enforced in like manner as Regulations contained in the said Schedule:

Now, therefore, I, the Right Honourable Sir Richard Dawson Bates, Bart., D.L., M.P., Minister of Home Affairs for Northern Ireland, do make the following Regulation for making further provision for the preservation of the Peace and Maintenance of Order, and the said Regulation shall be enforced and have effect in like manner, as Regulations contained in the said Schedule and the said Regulation now made, and the Regulations contained in the said Schedule shall have effect and be construed as if the said Regulation now made formed part of said Regulations in said Schedule, that is to say:—

3B. (1) It shall be unlawful for any person (other than a person selling by retail) to be in possession of, purchase, sell, transfer,

or otherwise dispose of potassium chlorate or aluminium powder in excess of 4lbs. avoirdupois without the consent in writing of the Inspector General, the Commissioner of Belfast, a County Inspector, or a District Inspector of the Royal Ulster Constabulary. (2) It shall be unlawful for any person selling by retail:—

- (i) to sell, transfer, or otherwise dispose of any of the aforesaid substances in excess of 4 lbs. avoirdupois to any person unless such person produces an authority in writing from the Inspector General, the Commissioner of Belfast, a County Inspector, or a District Inspector granting permission to purchase and be in possession of the amount specified in the authority;
- (ii) to have in his possession more than 6 lbs. of the substances to which this Regulation refers, without the consent in writing of the Inspector General, the Commissioner of Belfast, a County Inspector, or a District Inspector of the Royal Ulster Constabulary.
- (3) A person selling these substances by wholesale shall provide and keep a register in which shall be entered within twenty-four hours full particulars of the amount and the description of all such substances received or disposed of by such person, which particulars shall include the names and full addresses of the persons from whom the said substance was received, or to whom it was disposed of, and the date of each transaction. The said register shall be open for inspection at all times by the District Inspector of the Royal Ulster Constabulary of the District, or any member of the Royal

Ulster Constabulary authorised by him, and any person so receiving or disposing of such substance shall at all times when so required by the aforesaid Police Authorities, show to the said Authorities all stock on hands of such substance, together with all invoices, consignment notes, receipts, or permits which may be required to verify any entry in the Register, and shall allow copies and extracts to be taken by such authorities, and shall allow such authorities at all reasonable times to enter the places where such substances are stored or kept for sale. Where the person receiving such substance is not known to the vendor, the vendor shall require such person to furnish satisfactory particulars of identification (which shall be entered in the register referred to) and to sign his name and address to such register.

MARKETING OF EGGS (DETERMINA-TION OF WHOLESALE DEALERS' PRICES) (No. 24) ORDER (NORTHERN IRELAND), 1939.

(a) (i) For hen eggs purchased from a producer 8\frac{1}{2}d. per lb.

Where the eggs were delivered by the vendor to premises used by a licensed wholesale dealer of Class A for the testing, grading, and packing of eggs, or to a collecting depot specified in the schedule to the above-mentioned Order, an additional halfpenny per lb. shall be paid.

(ii) For hen eggs purchased by a licensed wholesale dealer of Class A from a licensed wholesale dealer of Class B, 8 11-16d. per lb.

Deductions:—Seconds ½d per egg; Rejects 1d. per egg.

(b) For duck eggs purchased from a producer 8d. per dozen.

Where the eggs were delivered by the vendor to premises used by a licensed wholesale dealer of Class A for the testing, grading, and packing of eggs, or to a collecting depot specified in the schedule to the above-mentioned Order, an additional three-farthings shall be paid for each complete dozen so delivered.

Deductions:-Rejects 3d. per egg.

REGULATIONS RESPECTING LIMITED COMPETITIONS FOR THE SITUATION OF SHORTHAND-TYPIST IN THE CIVIL SERVICE OF NORTHERN IRELAND.

- A candidate must be an established typist in an Administrative Department or an established Clerk-Typist in the County Court Service, and must, on or before the date of the Competition have completed satisfactorily one year's service in either post. A prospective candidate must obtain the permission of the authorities of the Department or office in which she is serving to enter the Competition.
- 2. A candidate must be unmarried or a widow.
- A successful candidate must satisfy the Commissioners, in such manner as they may require, that she is duly qualified in respect of health, physical fitness and character.
- 4. The Competition will consist of a written examination in the following subjects:-

Shorthand 100 marks English 100 ... General Paper 50

No candidate will be declared successful who does not pass in Shorthand and secure an adequate percentage of the aggregate marks

allotted to the three subjects. The pass mark in Shorthand and the qualifying percentage of the aggregate marks will be determined by the Commissioners.

- 5. Subject to the fulfilment of the conditions laid down in the penultimate sentence of paragraph 4, the candidates at the head of the Table of Examination Results will be declared successful, up to such number as may be determined by the Commissioners, and will, if found to be qualified under paragraphs 2 and 3 above, be offered appointments as vacancies arise. A candidate who refuses an appointment for any cause whatsoever will have no claim to receive any further offer.
- An application to the Commissioners for permission to sit for the Competition must be made in such manner and at such time as may be laid down in the notice of the Competition.

The Commissioners further give notice that a Competition under the foregoing Regulations will be held in Belfast on the 25th September, 1939, for the purpose of filling a number of vacancies in the grade of Shorthand Typist in Departments of the Civil Service.
