MARKETING OF EGGS (DETERMINA-TION OF WHOLESALE DEALERS' PRICES) ORDER (NORTHERN IRELAND), 1940.

Notice is hereby given that an Order has been made by the Ministry of Agriculture determining that the prices payable by licensed wholesale dealers for eggs delivered during the week ended Saturday, 6th January, 1940, shall be as follows:--

(a) (i) For hen eggs purchased from a producer 1/2d, per lb.

Where the eggs were delivered by the vendor to premises used by a licensed wholesale dealer of Class A for the testing, grading, and packing of eggs, or to a collecting depot specified in the schedule to the above-mentioned Order, an additional halfpenny per lb. shall be paid.

- (ii) For hen eggs purchased by a licensed wholesale dealer of Class A from a licensed wholesale dealer of Class B, 1/27-16d. per lb. Deductions:—Seconds ½d. per egg; Rejects 1¾d. per egg.
- (b) For duck eggs purchased from a producer 1/7d. per dozen.

Where the eggs were delivered by the vendor to premises used by a licensed wholesale dealer of Class A for the testing, grading, and packing of eggs, or to a collecting depot specified in the schedule to the above-mentioned Order, an additional three-farthings shall be paid for each complete dozen so delivered.

Deductions:-Rejects 1<sup>1</sup>/<sub>2</sub>d. per egg.

5. That all arrears of Cumulative preferential dividend in respect of the existing 60,000 "B" Preference Shares shall be cancelled.

6. That the 47,000 Ordinary Shares shall be entitled to an annual dividend of 5% before the said 40,000 Deferred Ordinary Shares shall receive any dividend.

7. That should there be a balance in any year available for payment of dividends after the said dividend of 5% shall have been paid on the said Ordinary Shares, then a dividend will be paid on the Deferred Ordinary Shares up to a maximum of 30%.
