Salisbury, K.G., Her Majesty's Principal Secretary of State for Foreign Affairs, has to-day received a Telegram from Colonel Euan Smith, Her Majesty's Agent and Consul-General in Zanzibar, stating that a Proclamation of Blockade of the continuous line of Continental Coast of the Sultan of Zanzibar, including the Islands of Mafia and Lamu, and the lesser Islands adjoining the Coast, from 2° 10′ South Latitude to 10° 28′ South Latitude, had been issued on the 29th of November, the Blockade to commence at noon on the 2nd of December.

EDUCATIONAL ENDOWMENTS (SCOTLAND) ACT, 1882.

OTICE is hereby given that the Commissioners under the Educational Endowments (Scotland) Act, 1882, have prepared the Draft of a Scheme for the future administration of the Endowment known as St. James' Episcopal School, in the City of Edinburgh, whereof an abstract is appended. The Commissioners will, in terms of the Twenty-fourth Section of said Act, receive and consider any objection made to them in writing by any public body or persons interested respecting such Scheme, and any amendments proposed thereon, provided that the same be delivered at their Office, at No. 46 George Street, Edinburgh, within two calcular months from the date hereof. Scheme, under the Educational Endowments (Scotland) Act, 1882, for the Administration of St. James' Episcopal School, Edinburgh, and

its Endowment, hitherto held and administered under a Codicil and relative addition thereto, made by the late Colonel Francis James Scott, of date 12th January 1821, the said School and Endowment being both Educational Endowments within the meaning of the Educational Endowments (Scotland) Act, 1882.

Preamble.

1, 2. Future Administration, and Transference of Property.

3. Constitution and Election of Governing Body.—The governing body, hereinafter called the governors, shall consist of seven persons, of whom—

Three shall be elected by the School Board of Edinburgh;

Two shall be elected by the Diocesan Council of the Episcopal Church in Scotland for the Diocese of Edinburgh;

Two shall be elected by the Vestry of St. James' Episcopal Church in Edinburgh.

The governors may be elected by the several electing bodies, either out of their own number or The governors elected by the said otherwise. Board and Council shall, in the case of the first election, hold office for a period of five years, and thereafter until the first day of August after the expiration of that period. The governors elected by the said Vestry shall, in the case of the first election, hold office for a period of three years, and thereafter until the first day of August after the expiration of that period. The governors shall, in the case of all elections subsequent to the first, hold office for a period of five years from and after the expiration of the term of office of their predecessors, except as hereinafter provided. Each election shall be made at a meeting convened and conducted according to the ordinary rules and practice of the electing body. Any governor may be re-elected. The first governors shall be elected as soon as conveniently may be after the date of this Scheme. The clerk or other officer of the governors shall, at least one month before the expiry of the term of office of any governor, give notice to the proper electing body, and the electing body shall, as soon as conveniently may be after such notice, elect a governor to hold office from the expiration of said term. Any election not made as aforesaid within three months from the date of this Scheme, or from the date of the notice of expiration of a term of office, or from the date of the notice of a vacancy, as hereinafter prescribed, shall in that case be made by the then existing governors.

4-12. Vacancies; Meetings; Chairman; Quorum and Execution of Deeds; Minutes; Power to appoint Committees; Accounts.

13-17. Business Arrangements; Casual Profits; Powers of Sale and Investment; Audit.

18. First Meeting.—Within two months from the date of this Scheme, a meeting of the governors shall be held, upon the summons of the Sccretary of the Vestry of St. James' Episcopal Church in Edinburgh. At this meeting they shall make arrangements for the conduct of business, and shall elect a chairman, but they shall not at this, or any subsequent meeting, transact any business that is not necessary for the immediate administration of the Endowment until the whole of the first governors are elected or appointed.

19-22. Clauses relating to Transference of Administration, and Discharge of Governing Body.

Application of Income.

23. Application of Income. — The governors, after paying the necessary expenses of management and the burdens and taxes affecting the Endowment, shall apply the free income of the Endowment in the manner hereinafter provided.

24. Maintenance of School-the Conditions. The governors shall apply the whole residue of their annual income, after making provision for the establishment of bursaries as hereinafter provided, in maintaining a school, on condition always that there shall be a master in the said school capable of giving instruction in the higher branches, and that the teaching staff exclusive of that master shall be sufficient, according to the requirements of the Scotch Education Code; for all the children in the school up to and inclusive of those in Standard V. of the said Code. The governors shall give free education in the said school in the higher subjects with books and stationery to ten children whose parents require aid in giving them higher education. They shall select these children from among children attending the school, either by competitive examination, or in such other way as will ensure that the selection is made as a reward of merit; the children so selected shall enjoy free education for such period as the governors may appoint, and shall be selected in such a way that as nearly as possible the same number of children may be elected annually. The said school shall be inspected in such manner as the Scotch Education Department may prescribe, and shall conform to all the conditions required by the Education Act or the Scotch Education Code for earning the Government Grant. In the event of the governors resolving to maintain the school in premises other than those in which it is at present maintained, the new premises shall be as close as conveniently may be to the site of St. James' Episcopal Church, consistently with maintaining the efficiency of the school, and securing a satisfactory attendance. If it shall appear to the Scotch Education Department, on such information and after such inquiry as they may deem necessary, that the said residue is not being efficiently applied in manner foresaid, they shall have power to require the governors to apply it to the purposes of the immediately succeeding section, until they have satisfied the Department that they are prepared to comply with the conditions under which the said annual sum is directed to be applied under this section. In the event of the Department permitting the said residue to be again applied under the provisions of this section, the governors shall, in the first place, make payment of any bursaries awarded by them in the interim.

25. Bursaries for Higher or Technical Education.—The governors shall apply an annual sum of £150, in establishing bursaries for higher education, to be called the Scott Bursaries, each of the yearly value of not less than £10 nor more than £15. These bursaries shall be awarded by competitive examination among pupils attending the school to be maintained by the governors, and failing suitable candidates from among such pupils, or in the event of the discontinuance of the said school, then among pupils attending public or State-aided schools in the City of Edinburgh. In any case the bursars shall be children whose parents or guardians require aid in giving them

higher education, and whose age at the date of the competition shall not exceed fourteen years; the bursaries shall be tenable for such period, not exceeding three years, as the governors may determine, at such schools for higher education or technical instruction as they may approve. In the event of the governors finding it necessary to throw open these bursaries to children attending public or State-aided schools in Edinburgh, it shall be lawful for them to delegate their powers under this section to a committee consisting partly of their own members and partly of any other body awarding bursaries in the same area.

26. Forfeiture of Bursaries.—If, in the judgment of the governors, the holder of any bursary shall be guilty of serious misconduct, or fail to make reasonable progress, they may withdraw such bursary, and their determination in such case shall

be final.

27. Annual Distribution of Bursaries. - The governors shall establish the bursaries herein provided for in such manner as to secure that they shall be awarded in as nearly as nearly as possible

equal numbers in each year.

28. Residue of Income.—The residue of the free annual income, in so far as it has not been applied under the provisions of this Scheme, shall be invested by the governors as soon as it shall amount to £50, and form part of the capital fund of the Endowment.
