HEREAS an Act was passed in the thirtieth and thirty-first years of the reign of Her present Majesty Queen Victoria, intituled 'An Act to consolidate and amend the ' law relating to the Public Health in Scotland'; and by the thirty-first section of the said Act it is enacted that' Whenever any part of the United King-' domappears to be threatened with, or is affected by, ' any formidable epidemic, endemic, or contagious ' disease, the Lords and others of Her Majesty's ' Most Honourable Privy Council, or any three or ' more of them (the Lord President of the Council, 'or one of Her Majesty's Principal Secretaries of State being one), may by Order or Orders by ' them from time to time made direct that the provisions for the prevention of diseases contained in Part III. hereof be put in force in Scotland, or 'in such parts thereof, or in such places therein, as 'in such Order or Orders may be expressed, and 'may from time to time, as to all or any of the parts or places to which any such Order or Orders extend, and in like manner, revoke or renew such Order: and subject to revocation and 'renewal as aforesaid, every such Order shall be in force for six calendar months, or for such 'shorter period as in such Order shall be ex-'pressed; and every such Order of Her Majesty's ' Privy Council, or any Members thereof as afore-

'said, shall be certified under the hand of the Clerk 'in Ordinary of Her Majesty's Privy Council, and 'shall be published in the Edinburgh Gazette, and 'such publication shall be conclusive evidence of 'such Order.'

And whereas by 'The Secretary for Scotland Act, 1885,' it is provided that all powers and duties vested in or imposed on the Privy Council by Part III. of the said Public Health (Scotland) Act, 1867, shall be transferred to, vested in, and imposed on the Secretary for Scotland.

And whereas part of the United Kingdom appears to be threatened with a certain contagious disease, that is to say, the Smallpox; and whereas it is expedient to make provision thereanent:

Now, therefore, in exercise of the powers conferred upon him by the said recited Acts, the Secretary for Scotland does order, and it is hereby ordered, that the provisions for the prevention of diseases, contained in Part III. of the Act thirty and thirty-first Victoria, chapter one hundred and one, be put in force in Scotland for the space of three calendar months after the publication of this Order in the Edinburgh Gazette.

To all the Local Authorities in Scotland within whose District there is a Port or Harbour, in terms of 'The Public Health (Scotland) Act, 1867.'

Whereas the Secretary for Scotland has issued the following Order, dated 14th January 1889:—
'Whereas an Act was passed in the thirtieth and thirty-first years of the reign of Her present Majesty Queen Victoria, intituled "An Act to consolidate and amend the law relating to the Public Health in Scotland"; and by the thirty-first section of the said Act it is enacted, that

'Whenever any part of the United Kingdom appears to be threatened with or is affected by ' any formidable epidemic, endemic, or contagious ' disease, the Lords and others of Her Majesty's ' Most Honourable Privy Council, or any three or ' more of them (the Lord President of the Council ' or one of Her Majesty's Principal Secretaries of State being one), may, by Order or Orders by them from time to time made, direct that the Provisions for the prevention of diseases contained in Part III. hereof be put in force in Scotland, or in such parts thereof, or in such places therein, as in such Order or Orders may ' be expressed, and may from time to time, as to 'all or any of the Parts or Places to which any ' such Order or Orders extend, and in like manner 'revoke or renew such Order: and subject to 'revocation and renewal as aforesaid, every such 'Order shall be in force for six calendar months, ' or for such shorter period as in such Order shall ' be expressed; and every such Order of Her ' Majesty's Privy Council, or any Members ' thereof as aforcsaid, shall be certified under the ' hand of the Clerk in Ordinary of Her Majesty's ' Privy Council, and shall be published in the 'Edinburgh Gazette, and such publication shall be conclusive evidence of such Order.'

'And whereas by "The Secretary for Scotland Act, 1885," it is provided that all powers and duties vested in or imposed on the Privy Council by Part III. of the said Public Health (Scotland) Act, 1867, shall be transferred to, vested in, and and imposed on the Secretary for Scotland.

'And whereas part of the United Kingdom appears to be threatened with a certain contagious disease, that is to say, Smallpox; and whereas it is expedient to make provision thereanent:

'Now, therefore, in exercise of the powers conferred upon him by the said recited Acts, the Secretary for Scotland does order, and it is hereby ordered, that the provisions for the prevention of diseases, contained in Part III. of the Act thirty and thirty-first Victoria, chapter one hundred and one, be put in force in Scotland for the space of three calendar months after the publication of this Order in the Edinburgh Gazette.'

And whereas by the 33d Section of the said Act it is further provided, that when such an Order has been issued, the Board of Supervision for Relief of the Poor in Scotland 'may issue such Directions and Regulations as 'they shall think fit for the prevention, as far 'as possible, or mitigation of such epidemic, 'endemic, or contagious diseases, and from time

'to time may revoke, renew, and alter any such 'Directions and Regulations; and the same shall 'extend to all Parts or Places in which the Provisions of this Act for the prevention and mitigation of disease shall, for the time being, be put in force under such Orders as aforesaid, unless such Directions and Regulations be expressly confined to some of such Parts or Places, and then to such Parts or Places as therein are 'specified; and (subject to the power of revocation and alteration herein contained) such Directions and Regulations shall continue in force so long as the said Provisions of this Act shall under 'such Order be applicable to the same Parts or 'Places.'

And whereas it is enacted by the 35th Section of the said Act that the Board may provide, interalia, 'for any such Matters or Things as may to 'them appear advisable for preventing or 'mitigating such Diseases.'

And whereas by the 38th Section of the said Act it is provided that 'All such Orders for exe'enting this Act shall extend to Ports and Arms
'of the Sea lying within the jurisdiction of
'the Admiralty, and adjacent to the Places to
'which such Orders relate; and the Board may
'issue, under the said Orders, Directions and
'Regulations for cleansing, purifying, ventilating,
'and disinfecting, and preventing disease in Ships
'and Vessels, as well upon Arms and Ports of the
'Sea aforesaid as upon Inland Waters.'

And whereas Smallpox is now prevalent in certain parts of Africa with which this country has communication, and it is expedient that Directions and Regulations should be made by the Board in terms of Part III. of said Act.

Therefore, in exercise of the Authority vested in us as aforesaid, we, the Board of Supervision for the Relief of the Poor and for Public Health in Scotland, do issue the Directions and Regulations hereinafter contained, to extend to all Places in Scotland, and to all Ports and Arms of the Scalying within the jurisdiction of the Admiralty, and adjacent to such Places:—

Definitions.

Art. 1.—

The term 'Ship' includes vessel or boat ;

The term 'Officer of Customs' includes any person acting under the authority of the Commissioners of Customs; The term 'Master' includes the officer or

The term 'Master' includes the officer or person for the time being in charge or command of a ship;

The term 'Local Authority' has the same meaning as in the Public Health (Scotland) Act, 1867;

The term 'Medical Officer of Health' includes any duly qualified Medical Practitioner appointed by a Local Authority to act in the execution hereof;

Every ship shall be deemed infected with Smallpox in which there is or has been during the voyage, or during the stay of such ship in a port in the course of such voyage, any case of Smallpox.

I.—Regulations as to Detention by Officers of Customs.

they shall think fit for the prevention, as far as possible, or mitigation of such epidemic, endemic, or contagious diseases, and from time of any ship, ascertain from the Master of such

ship or otherwise, or have reason to suspect, that the ship is infected with Smallpox, he shall detain such ship, and order the Master forthwith to moor or anchor the same in such position as such Officer of Customs shall direct; and thereupon the Master shall forthwith moor or anchor the ship accordingly.

ART. 3. Whilst such ship shall be so detained, no person shall leave the same.

ART. 4. The Officer of Customs detaining any ship as aforesaid, shall forthwith give notice thereof, and of the cause of such detention, to the Local Authority of the place where the ship shall be so detained.

ART. 5. Such detention by the Officer of Customs shall cease as soon as the ship shall have been duly visited and examined by the Medical Officer of Health; or, if the ship shall, upon such examination, be found to be infected with Smallpox as soon as the same shall be moored or anchored in pursuance of Art. 10 hereof.

Provided, that if the examination be not commenced within twelve hours after notice given as aforesaid, the ship shall, on the expiration of the said twelve hours, be released from detention.

II .- Regulations as to Local Authorities.

Art. 6.—Every Local Authority within whose district persons are likely to be landed from any ship coming foreign shall, as speedily as practicable, with the approval of the Chief Officer of Customs of the port, fix some place within the jurisdiction or district of the Local Authority where any ship may be moored or anchored, for the purpose of Art. 10; and shall make provision for the reception of Smallpox patients and persons suffering from illness removed under Arts. 13 and 14. If the Local Authority have fixed on a place where any ship may be moored or anchored, in terms of Art. 6 of the Order of the Privy Council dated 12th July 1883, the place so fixed shall be held to be the place where any ship may be moored or anchored in terms of this Article.

Arr. 7. The Local Authority, on notice being given to them by an Officer of Customs under Art. 4 hereof, shall forthwith cause the ship in regard to which such notice shall have been given, to be visited and examined by their Medical Officer of Health for the purpose of ascertaining whether she is infected with Smallpox.

ART. 8. The Medical Officer of Health, if he have reason to believe that any ship within the jurisdiction or district of the Local Authority, whether examined by the Officer of Customs or not, is infected with Smallpox, or if she shall have come from a place infected with Smallpox, may visit and examine such ship, for the purpose of ascertaining whether she is so infected; and the Master of such ship shall permit the same to be so visited and examined.

ART. 9. If the Medical Officer of Health on making such examination as aforesaid (whether under Art. 7 or 8), shall be of opinion that the ship is infected, he shall give a certificate in duplicate in the following form, or to the like effect, and shall deliver one copy to the Master and retain the other or transmit it to the Local Authority.

Medical Communications

Medical Officer of Health [or Medical Practioner appointed by the Local Authority.]

ART. 10. The Master of every ship so certified to be infected with Smallpox shall thereupon moor or anchor her at the place fixed for that purpose under Art. 6, and she shall remain there until the requirements hereof have been duly fulfilled.

ART. 11. No person shall leave any such ship until the examination hereinafter mentioned shall have been made.

ART. 12. The Medical Officer of Health shall, as soon as possible after any such ship has been certified to be infected with Smallpox, examine all persons on board of the same, and all persons who shall not be certified by him, as hereafter mentioned, shall be permitted to land immediately on their giving their names and the places of their destination.

ART. 13. Every person certified by the Medical Officer of Health to be suffering from Smallpox shall be dealt with under any regulations that may have been made by the Local Authority under Section 55 of the Public Health (Scotland) Act, 1867; or, where no such regulations shall have been made, shall be removed, if the condition of the patient admit of it, to some hospital or place previously appointed for that purpose by the said Authority; and no person so removed shall leave such hospital or place until the Medical Officer of Health shall have certified that such person is free from the said disease.

If any person suffering from Smallpox cannot be removed, the ship shall remain subject, for the purposes hereof, to the control of the Medical Officer of Health; and the infected person shall not be removed from or leave the ship, except with the consent in writing of the Medical Officer of Health.

ART. 14. Any person certified by the Medical Officer of Health to be suffering from any illness which such Officer suspects may prove to be Smallpox, may be taken to some hospital or other place previously appointed by the Local Authority, and detained there until it be ascertained whether the illness is or is not Smallpox.

Any such person who, while so detained, shall be certified by the Medical Officer of Health to be suffering from Smallpox, shall be dealt with as provided by Article 13 hereof.

ART. 15. The Medical Officer of Health shall in the case of every ship certified to be infected, give such directions, and take such steps as may appear to him to be necessary for preventing the spread of infection, and the Master of the said ship shall forthwith carry into execution such directions as shall be so given to him.

ART. 16. In the event of any death from Smallpox taking place on board of such ship while so detained, the Master shall as directed by the Local Authority or the Medical Officer of Health either cause the dead body to be taken out to sea, and committed to the deep, properly loaded to prevent its rising, or shall deliver it into the charge of the said Authority for interment, and

the Authority shall thereupon have the same interred.

ART. 17. The Master shall cause the clothing and bedding and other articles of personal use likely to retain infection which have been used by any person who may have suffered from Smallpox on board such ship, or who, having left such ship, shall have suffered from Smallpox during the stay of such ship in any Port, to be disinfected or (if necessary) destroyed; and if the Master shall have neglected to do so before the ship arrives in Port, he shall forthwith, or upon the direction of the Local Authority, or the Medical Officer of Health, cause the same to be disinfected or destroyed, as the case may require; and if the said Master neglect to comply with such direction within a reasonable time, the Authority shall cause the same to be carried into execution.

ART. 18. The Master shall cause the ship to be disinfected, and every article therein, other than those last described, which may probably be infected with Smallpox, to be disinfected or destroyed, according to the directions of the Medical Officer of Health.
