

(a.) The detonators and the spaces between the same, and between the sides of the inner package and the said detonators, shall all be filled, as far as practicable, with fine sawdust or other similar material; a layer of cotton wool or other soft elastic material shall be placed between both ends of all the detonators and the interior of the inner package in which the same are placed, in such manner and so secured that both ends of the detonators will rest upon the said cotton wool or other material; every inner package, if of metal, to be lined throughout with paper or other soft material; and

(b.) When the number of such detonators packed for conveyance exceeds in all one thousand (1000), or such greater number as may from time to time be assigned, with the consent of and under conditions approved by a Government inspector, all the inner packages as aforesaid shall be placed inside a substantial case of wood or metal, made and closed so as to prevent any of the inner packages escaping therefrom, and such case shall be placed inside such outer package as is required by the above general rules relating to the packing for conveyance of explosives of the third division of the 6th (ammunition) class, in such manner and so secured as to leave a clear space of not less than three inches between every part of the interior of the said outer package, notwithstanding that such clear space may, if preferred, be filled with sawdust, straw, or other similar material, or may contain a light framework or battens of wood to keep the case aforesaid in position in the outer package.

The Civil Service Commissioners hereby give notice, that the following Regulations have been approved by the Lords Commissioners of Her Majesty's Treasury, viz. :—

SPECIAL REGULATIONS (Supplementary to the General Regulations issued 8th April 1872, and amended by subsequent notices in the London Gazette), respecting Open Competitive Examinations for the situation of Assistant to the Professor of Chemistry at the Royal Military Academy, Woolwich.

N.B.—These Regulations are liable to alteration for future Examinations.

I. The limits of age for this situation are 25 and 30, and Candidates must be of the prescribed

age on the first day of the Competitive Examination.

II. The Competitive Examination will be in the following subjects, viz. :—

1. Chemistry and Heat.

[Skill in the preparation of apparatus, gases, explosives, and compounds required for lectures, and the assistance of students at practical work in the laboratory.]

2. Electricity.

[Skill in the preparation of Batteries, and setting up of apparatus required for lectures, and the assistance of students at practical work.]

* * No Candidate will be eligible who fails to satisfy the Commissioners in either of these subjects.

III. No Candidate can be admitted to the Competitive Examination who has not previously satisfied the Civil Service Commissioners that he possesses the requisite amount of proficiency in the following subjects :—

1. Handwriting.

2. Orthography.

3. Arithmetic (to Vulgar and Decimal Fractions).

With this view, Preliminary Examinations in these subjects will be held at such times and places as the Commissioners may appoint.

IV. Application for permission to attend an Examination must be made in the writing of the Candidate, at such time and in such manner as may be fixed by the Commissioners.

V. A fee will be required from every Candidate attending an Examination, according to the scale laid down under the Order in Council of 22nd March 1879, by notice in the London Gazette of 29th April 1881.

The Civil Service Commissioners further give notice, that an Open Competitive Examination will be held in London, under the foregoing Regulations, on the 14th May 1889, and following days. A Preliminary Examination will be held in London on the 7th May 1889. The number of situations to be filled will be the number vacant at the time of the Examination.

No person will be admitted to Examination from whom the Secretary, Civil Service Commission, has not received, on or before the 26th April, an 'application' in the Candidate's own handwriting, on a prescribed form, which may be obtained from the Secretary at once.
