## EDUCATIONAL ENDOWMENTS (SCOTLAND) ACT, 1882.

OTICE is hereby given that the Commissioners under the Educational Endowments (Scotland) Act, 1882, have prepared the Draft of a Scheme for the future administration of the Endowments known as the Gaff Trust and Falkirk Charity School, in the County of Stirling and Burgh of Falkirk and Parish of Falkirk, whereof an Abstract is appended. The Commissioners will, in terms of the Twenty-fourth Section of said Act, receive and consider any objection made to them in writing by any public body or persons interested respecting such Scheme, and any amendments proposed thereon, provided that the same be delivered at their Office, at No. 46 George Street, Edinburgh, within two calendar months from the date hereof. Scheme under the Educational Endowments (Scotland) Act, 1882, for the Administration of the Endowments known as the Gaff Trust and Falkirk Charity School, at present held and administered under a Scheme No. 3, framed under the provisions of the said Act, and approved by Her Majesty in Council, on 5th March 1885.

#### Preamble.

1. Bursaries at Science and Art School or Evening Classes, and Grants to such School or Classes.—The 24th Section of the said Scheme No. 3 is hereby repealed, and in place thereof it is hereby provided as follows, viz.: The governors shall apply an annual sum of not less than £50, either (1) in establishing bursaries for technical education, each of the yearly value of not more than £5. These bursaries shall be

awarded by competitive examination among pupils attending the public or State-aided schools in the Burgh of Falkirk, or in the Landward School Board District of Falkirk, under such conditions and regulations as the governors may from time to time determine, and shall be tenable for a period not exceeding two years at the Science and Art School at Falkirk, or at such evening classes in the Burgh or Landward School Board District of Falkirk for instruction in higher or technical subjects as the governors may from time to time sanction, the competitors being the children of parents who require assistance to give them higher education; or (2) in maintaining or assisting to maintain the Science and Art School at Falkirk, or such evening classes in the Burgh or Landward School Board District of Falkirk for instruction in higher or technical subjects as the governors may from time to time think fit; and the governors, as a condition of any such grant for maintaining or assisting to maintain such school or classes, shall require the Committee of the said school, or the Managers of said classes, to give free education to ten scholars in the event of the grant amounting to £50, or a corresponding number in the event of the grant amounting to any smaller sum. These scholars shall be selected by the governors for their merit, as the same shall be ascertained by competitive examination, or on the report of their teachers, or in such other way as the governors may from time to time determine, from among scholars who are or have been within such time, not exceeding two years before the date of the selection, as the governors may from time to time determine, in attendance at public or Stateaided schools in the Burgh or Landward School Board District of Falkirk. The scholars shall be children of parents who require assistance in giving them free education, and shall continue to enjoy the free education for a period not exceeding two years. The provisions of the 28th and 29th Sections of the said Scheme No. 3 shall apply to the bursars and scholars hereinbefore mentioned.
