Whereas by the provisions of the Patents, Designs, and Trade Marks Act, 1883, it is, amongst other things, provided:—

That if Her Majesty is pleased to make any arrangement with the Government or Governments of any foreign state or states for mutual protection of inventions, designs, and trade marks, or any of them, then any person who has applied for protection for any invention, design, or trade mark in any such state shall, subject to the conditions further provided and set forth in the said Act, be entitled to a patent for his invention, or to registration of his design or trade mark (as the case may be) under the said Act in priority to other applicants, and such patent or registration

shall have the same date as the date of the protection obtained in such foreign state:

And whereas it has pleased Her Majesty to make an arrangement of the nature contemplated by the said Act, by and in virtue of a declaration signed and sealed by Her Majesty's Ambassador at Paris on the 17th March 1884, duly conveying the accession of Great Britain to the International Convention and Protocol for the protection of industrial property, signed by representatives of certain powers on the 20th day of March 1883, and duly ratified on the 6th day of June 1884, power being reserved to Her Majesty to hereafter accede to the provisions of the said Convention and Protocol on behalf of the Isle of Man, the Channel Islands, and any of Her Majesty's possessions, which declaration of accession was duly accepted by the French Government on behalf of the signatory powers by and in virtue of a declaration dated the 2nd of April 1884:

And whereas Her Majesty was pleased by an Order in Council dated the 26th day of June 1884, to declare that the provisions of the said Act hereinbefore specified should apply to the several countries mentioned in the said Order, and it was further ordered and declared that such Order should take effect from the 7th day of July 1884:

And whereas Her Majesty was pleased by an Order in Council dated the 27th day of January 1885, to declare that the provisions of the said Act hereinbefore specified should also apply to the following country, viz. Santo Domingo, and it was further ordered and declared that such Order should take effect from the date of such Order:

And whereas it has been intimated to Her Majesty's Government that the Government of Santo Domingo, has by a note on their behalf dated the 15th day of March 1888, and addressed to the Government of the Swiss Confederation, given notice of the termination of adhesion to the said Convention; and whereas by Article 18 of the said Convention, it is provided that the provisions of the said Convention shall remain in force as regards any country so terminating its adhesion till the expiry of one year from the date of such notice.

Now, therefore, Her Majesty, by and with the advice of Her Privy Council, and by virtue of the authority committed to Her by the said Act, doth declare, and it is hereby declared, that the provisions of the said Act hereinbefore specified shall cease to apply to the said country, viz. :—

Santo Domingo.

And it is further ordered and declared that this Order shall take effect from the day and date first above written.

Whereas by the provisions of the Patents, Designs, and Trade Marks Act, 1883, as amended by the Patents, Designs, and Trade Marks (Amendment) Act, 1885, it is, amongst other things, provided :—

That if Her Majesty is pleased to make any arrangement with the Government or Governments of any foreign state or states for mutual protection of inventions, designs, and trade marks, or any of them, then any person who has applied for protection for any invention, design, or trade mark in any such state shall, subject to the conditions further provided and set forth in the said Act, be entitled to a patent for his invention or to registration of his design or trade mark (as the case may be) under the said Act in priority to other applicants, and such patent or registration shall have the same date as the date of the application in such foreign state :

And whereas it has pleased Her Majesty to make an arrangement with the Government of Mexico by and in virtue of a treaty entered into between Her Majesty and that state, dated the 27th day of November 1888, and duly ratified on the 11th day of February 1889, as regards the rights to which subjects or citizens of each of the contracting parties shall be entitled in the dominions and possessions of the other in regard to patents for inventions, designs, and trade marks :

Now, therefore, Her Majesty, by and with the advice of Her Privy Council, and by virtue of the authority committed to Her by the said first-mentioned Act, doth declare, and it is hereby declared, that the provisions of the said Acts

hereinbefore specified shall apply to the following country, viz. :—

Mexico.

And it is further ordered and declared that this Order shall take effect, so far as regards patents, at the expiration of seven months, and so far as regards designs and trade marks, at the expiration of four months, from the day and date first above written.

The QUEEN's Most Excellent Majesty in Council.

Whereas by Her Majesty's Order in Council bearing date the twelfth day of February one thousand eight hundred and seventy-six relating to Her Majesty's Civil Service it was provided as follows :—'The salaries of Men Clerks in the Lower Division shall commence at eighty pounds, and shall rise by triennial increments of fifteen pounds to two hundred pounds. Provided that in any office in which a regular attendance of seven hours a day is required, the commencing salary may be ninety pounds, and the maximum salary may be two hundred and fifty pounds.'

And whereas by Her Majesty's Order in Council bearing date the fifteenth day of July one thousand eight hundred and eighty-one, the words of the above-cited provision including and following the word 'provided' were repealed and the following words substituted therefor :—'Provided that in any office where a regular attendance of seven hours a day is required, the commencing salary may be ninety-five pounds and the maximum salary may be two hundred and fifty pounds.'

And whereas the Lords Commissioners of Her Majesty's Treasury have represented unto Her Majesty the advisability of repealing, in respect of Men Clerks in the Lower Division to be hereafter appointed, the aforesaid regulations and of substituting others therefor.

Now therefore Her Majesty by and with the advice of Her Privy Council is pleased to order, and it is hereby ordered, as follows :—

1. From and after the date of this Order the aforesaid regulations shall, in respect of Men Clerks in the Lower Division appointed after the date of this Order, be, and the same are, hereby repealed.

2. In lieu of the regulations so repealed as aforesaid the following regulations are substituted in respect of Men Clerks appointed after the date of this Order.

Men Clerks in the Lower Division of the Civil Service shall give a regular attendance of not less than seven hours a day.

The salaries of such Men Clerks shall commence at seventy pounds per annum, and shall rise by such increments to such sums as may hereafter be fixed by Order in Council.

ON an application by Petition by the Magistrates and Council of the ROYAL BURGH OF PERTH to the Sheriff of the County, he, the said Sheriff, has given the following judgment, viz.:—

Perth, 9th May 1889.

And the Sheriff having now extended the boundaries of the said Burgh, annexes the Districts within the extended boundaries to the existing Wards into which the said Burgh is at present divided, and fixes and rearranges the limits of the said Wards as follows, videlicet:—

THE FIRST WARD

To consist of the territory lying within a line commencing at the River Tay, at the east end of the High Street, and proceeding along that street westward to the High Street Port, and from thence proceeding southward by South Methven Street and King Street to Victoria Street, from thence by a straight line eastward to the River Tay; and from thence northward by said river to the first-mentioned point at the east end of the High Street.

THE SECOND WARD

To consist of the territory lying within a line commencing at the River Tay, at the south-east corner of the First Ward, and proceeding in a straight line to the middle of Victoria Street, and westward along that street to King Street, from thence northward to South Street Port; from thence westward by County Place, York Place, and the Glasgow Road to the Old Toll Bar at the Fehney Industrial School, the boundary being continued in a straight line from that point westward to the Parliamentary Boundary, from thence along the western and southern boundary of the Parliamentary Boundary to the southern corner of the Friarton Pier on the River Tay, thence across the River Tay (passing to the south of the Friarton Island) to the point at which the same is met by the boundary of the respective Parishes of Kinfauns and Kinnoull; thence northward along the boundary of the Parish of Kinfauns to the point at which that boundary touches the Mainland on the east side of the Willowgate, thence northward along the east side of the Willowgate to the Railway Bridge across the Tay, from thence along the south side of the Railway Bridge westward to the Mainland; and from thence along the river northward to the first-mentioned point in a straight line with the middle of Victoria Street.

THE THIRD WARD

To consist of the territory lying within a line commencing at the River Tay, at the east end of the High Street, and proceeding along that street westward to the High Street Port; thence northward along Methven Street to Mill Street, thence eastward along Mill Street to Curfew Row; from thence along Curfew Row and North Port to the west or lower end of Charlotte Street, from thence in a straight line to the Horse Watering-Place on the west side of the River Tay, a short way above Perth Bridge, and from thence southward by the river to the place first above-mentioned as to this Ward at the east end of the High Street; and also all the territory within the Parliamentary Boundary lying on the east side of the River Tay and Willowgate, including the Stanners Island in the River Tay and that part of the Friarton Island to the north of the Railway Bridge.

THE FOURTH WARD

To consist of the territory lying within a line commencing at the foresaid Horse Watering-Place running in a straight line to North Port and along Curfew Row to Mill Street; from thence westward along Mill Street and southward along Methven Street to South Street Port; from thence proceeding westward along County Place, York Place, and the Glasgow Road to the Old Toll Bar at the Fehney Industrial School,—the boundary being continued in a straight line from that point westward to the Parliamentary Boundary, from thence proceeding in a north-easterly direction along the line of the Parliamentary Boundary till it reaches the point at the northern boundary of the Burgh on the right bank of the River Tay, and from thence proceeding southward along said river to the foresaid Horse Watering-Place. Declaring that the boundaries of the said Wards shall be understood to run along the middle of the streets, roads, and river by which they

are described to be bounded, except where the contrary is particularly mentioned,—the said Wards are laid down and delineated on the Plan docketted and subscribed by the Sheriff as relative hereto. And the Sheriff declares the number of Councillors to be elected for each Ward to remain as at present, videlicet:—Seven for the first Ward, and six for each of the second, third, and fourth Wards, and the order of their election to remain as at present. And the Sheriff directs that this, his Deliverance on the Petition, be published as a Notice once in the Edinburgh Gazette and once in each of the next two successive weeks in the three newspapers published in the said Burgh, all in terms of 'The General Police and Improvement (Scotland) Act, 1862,' and 'The General Police and Improvement (Scotland) Supplemental Act, 1865.'
