And whereas in the said representation it is recommended that the said Burial Ground be closed for Burials:

Now, therefore, Her Majesty in Council is pleased to give notice of such representation, and to order that the same be taken into consideration by a Committee of Her Majesty's Most Honourable Privy Council on the 7th day of October next:

that this Order, or notice thereof, be published in the Edinburgh Gazette, and that copies of this Order, or notice thereof, be affixed, as required by the above-mentioned Act, on the doors of the Church of, or on some other conspicuous places within, the Parish affected by such representation, one month before such representation is so considered.

(PLEURO-PNEUMONIA).

By Her Majesty's Most Honourable Privy Council.

HE Lords and others of Her Majesty's Most Honourable Privy Council, by virtue and in exercise of the powers in them vested under The Contagious Diseases (Animals) Acts, 1878 to 1886, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

- 1. Each of the Areas described in the Schedule to this Order is hereby declared to be an Area infected with pleuro-pneumonia.
- 2. This Order shall take effect from and immediately after the twenty-third day of August one thousand eight hundred and eighty-nine.
