This day Sir William Ventris Field was, by Her Majesty's command, sworn of Her Majesty's Most Honourable Privy Council, and took his place at the Board accordingly. At the Court at Windsor, the 21st day of March 1890.

PRESENT,

The QUEEN's Most Excellent Majesty in Council.

Whereas by Orders in Council made by the Queen's Most Excellent Majesty on the twelfth February one thousand eight hundred and seventysix, twenty-seventh June one thousand eight hundred and seventy-six, ninth December one thousand eight hundred and seventy-six, and fifteenth July one thousand eight hundred and eighty-one, Her Majesty did, by and with the advice of Her Privy Council, order, among other matters, that a Lower Division of the Civil Service should be constituted, to consist of Men Clerks and Boy Clerks engaged to serve in any Department of the State to which they might from time to time be appointed or transferred; that no Department throughout Her Majesty's Civil Service should be permanently increased or regulated afresh without providing for the introduction of a system whereby such of its duties as were of a suitable character should be performed by members of such Lower Division; that such situations in Her Majesty's Civil Service as were not suitable to be filled by members of such Lower Division should be excluded from the Orders, and should, until declaration of Her Majesty's further pleasure, be regulated as theretofore; that no vacancies should be filled up nor any new appointments made in any Department, except by appointing Clerks of the Lower Division, until the Commissioners of the Treasury had been satisfied that the number of Clerks

serving in such Department with higher salaries than those of the Lower Division were not in excess of the number sufficient to perform superior duties; that the salaries of Men Clerks in the Lower Division should commence at eighty pounds, and should rise by triennial increments of fifteen pounds to two hundred pounds; but that in any office where a regular attendance of seven hours a day was required, the commencing salary might be ninety-five pounds, and the maximum salary might be two hundred and fifty pounds; that extra pay, not exceeding one hundred pounds per annum, might be attached to certain situations open to Clerks of the Lower Division whose duties involved the superintendence of other Clerks, or were otherwise of a more responsible character than such as the generality of their colleagues had to perform; that promotion from the Lower to the Higher Division of the Service should not be made without a special certificate from the Civil Service Commissioners, to be granted exceptionally, after not less than ten years' service, upon a special recommendation from the Head of the Department, and with the assent of the Treasury; that below the Lower Division of Ordinary Clerks (including Boy Clerks) Men and Boy Copyists might be employed for mere copying and for routine work under direct supervision, on the same conditions of service as those then in force for Civil Service Writers:

And whereas by an Order in Council, dated the twenty-eighth day of May one thousand eight hundred and eighty-nine, it was provided that Men Clerks appointed after the date of that Order should give a regular attendance of not less than seven hours a day, and that the salaries of such Men Clerks should commence at seventy pounds per annum, and should rise by such increments to such sums as might thereafter be fixed by Order

in Council:

And whereas it appears from certain recent Reports made by Sir Matthew White Ridley, Baronet, and others appointed by Her Majesty to be a Royal Commission for inquiring into various questions connected with the organisation of Civil Departments of the State, that further Regulations are required in order to improve the organisation of the Civil Service:

Now, therefore, Her Majesty, by and with the advice of Her Privy Council, is pleased to order,

and it is hereby ordered, as follows:-

1. The name 'Lower Division' is hereby changed to 'Second Division'; but Boy Clerks appointed under the Order in Council, dated the twelfth day of February one thousand eight hundred and seventy-six, shall be held not to belong to the Second Division.

2. This Order shall apply only to the Second Division of the Civil Service, as defined by clause

one.

3. The salaries of Clerks in the Second Division, for a daily attendance of seven hours, shall commence at seventy pounds per annum, and shall rise by annual increments as follows, viz.:—

From seventy pounds to one hundred pounds by

annual increments of five pounds.

From one hundred pounds to one hundred and ninety pounds by annual increments of seven pounds ten shillings.

From one hundred and ninety pounds to two hundred and fifty pounds by annual increments of

ten pounds.

4. A higher grade of the Second Division shall be and is hereby established, with salaries com-

mencing at two hundred and fifty pounds per annum, and rising by annual increments of ten pounds to three hundred and fifty pounds.

5. The annual increments of salary shall not be allowed without an annual certificate from the immediate superior of each Clerk, countersigned by the Head of the Department or such officer as he may designate for the purpose, to the effect that such Clerk's conduct has during the year immediately preceding the date of such certificate

been in all respects satisfactory.

When the salary of any Clerk appointed after the twenty-eighth May one thousand eight hundred and eighty-nine reaches one hundred pounds, a special Report, to be officially recorded in writing, on the competence, character, and diligence of such Clerk, shall be required from the Head of the room, and from the Head of the Division in which, respectively, such Clerk is serving or has served; and until this Report is received and countersigned by the Head of the Department as satisfactory, such Clerk shall not receive any further advance in salary.

When the salary of any Clerk appointed after the twenty-eighth May one thousand eight hundred and eighty-nine reaches one hundred and ninety pounds, he shall not receive any further increment unless he obtain a Report to be officially recorded in writing from his immediate superiors, confirmed by the Head of the Department, that he is thoroughly competent to perform efficiently work of a superior and more advanced character in the

future.

6. Promotion to the higher grade established under clause four of this Order shall be made (subject to the provisions of clause sixteen of this Order) according to positive merit, and not accord-

ing to seniority.

A promotion to the said higher grade shall be made whenever any Clerk, who is not in receipt of extra pay, shall reach a salary of two hundred and fifty pounds; but, irrespective of this condition, the Head of a Department may recommend, and the Commissioners of the Treasury may sanction, as a very exceptional case, the promotion to the higher grade of a specially meritorious Clerk who is in receipt of a salary less than two hundred and fifty pounds.

7. Clerks who are required to attend seven

7. Clerks who are required to attend seven hours a day shall be allowed a half holiday on alternate Saturdays, provided that the Heads of the Departments in which such Clerks are respectively serving are satisfied that the state of

public business will permit.

8. The ordinary annual holidays allowed to Clerks shall not exceed fourteen week-days during each of their first five years of service, and twenty-one week-days thereafter, exclusive in both cases of Christmas Day, Good Friday, the Queen's Birthday, and (subject to the convenience of the public service) the four Bank Holidays. Provided that nothing in this clause shall affect the rights of existing Clerks who, under the Regulations of the respective Departments in which they are serving, are entitled to holidays in excess of those herein prescribed.

9. Sick leave may be granted by the Head of a Department to any Clerk serving in such Department, but subject to the following con-

ditions, viz.:-

(1) After two days' continuous absence, a certificate by a duly qualified medical practitioner shall be required.

(2) If the number of days during which any

Clerk in any year is absent without such medical certificate shall exceed seven in the aggregate, the number of days by which such aggregate period of absence exceeds seven shall be deducted from the amount of ordinary annual holidays which may be allowed under clause eight of this Order.

- (3) Continuous sick leave on full salary shall not be granted for any period longer than six months, but at the expiration of such six months the Head of the Department may at his discretion grant further leave, with salary at half the ordinary rate, for any period not exceeding six months. After twelve months' continuous sick leave no Clerk shall be paid any salary, except with the consent of the Commissioners of the Treasury, who may at their discretion, in special circumstances, allow payment of salary during any further period of sick leave to a Clerk at a rate not exceeding the amount of pension (if any) for which, at the expiration of twelve months' sick leave, the Clerk would have been qualified.
- (4) Cases of repeated but not continuous sick leave amounting in the aggregate to upwards of twelve months during any period of eighteen months shall be reported to the Commissioners of the Treasury, who shall decide the payments in respect of salary to be made during such sick leave
- 10. An Attendance Book shall be kept in every Department, in which the times of arrival and departure of every Clerk shall be daily recorded.
- 11. No Clerk shall be allowed to accept any part in the management of any Society, or any trading, commercial, or financial Company of whatever description, which would require the attendance of such Clerk at any time between the hours of ten a.m. and six p.m.
- 12. Clause eighteen of the Order in Council of the twelfth day of February one thousand eight hundred and seventy-six shall be read as if the words 'eight years' service' were substituted for the words 'ten years' service.'
- 13. All Clerks appointed after the twenty-eighth May one thousand eight hundred and eighty-nine, and all Clerks appointed before that date who shall be promoted to the higher grade of the Second Division established by clause four of this Order, shall be required to give a regular attendance of not less than seven hours daily; and, as regards all other Clerks appointed before the twenty-eighth May one thousand eight hundred and eighty-nine, who are giving, at the date of this Order, an attendance of six hours only, the hours of attendance shall be extended to seven, so soon as circumstances will permit, on the conditions specified in clause fourteen of this Order, subject, in each case, to agreement between the Commissioners of the Treasury and the Heads of the respective Departments in which such Clerks are serving as to the date of such extension of hours, and the reduction in the numbers of such Clerks to be made consequent
- 14. Clerks who were appointed before the twenty-eighth May one thousand eight hundred and eighty-nine, and who may be called upon at any time antecedent to their promotion to the higher grade of the Second Division to attend seven hours instead of six, shall be granted an increase of salary of fifteen pounds per annum from the date on which the extension of hours takes place; but Clerks who at the date of their promotion to

- such higher grade are giving six hours' attendance only shall, on promotion, give the attendance of seven hours without any such increase of salary.
- 15. Clerks appointed before the twenty-eighth May one thousand eight hundred and eighty-nine shall be placed upon the new scale of salary sanctioned in this Order under the following conditions:—
- (1) They shall rotain the salary with extra pay, if any, which they are receiving at the date of this Order.
- (2) They shall receive as from the first April one thousand eight hundred and eighty-nine an increment of salary equal to the proportion of their triennial increment of fifteen pounds (omitting any fraction of a pound sterling) which may have accrued up to that date.
- (3) The next increment after that described in the preceding paragraph shall accrue on the first April one thousand eight hundred and ninety; and this and all following increments shall depend upon the rate of salary, exclusive of extra pay, and shall be determined according to clause three of this Order.

Provided always, that if a Clerk be in receipt of extra pay, and his total emoluments are not less than two hundred and fifty pounds, he shall receive no further increment unless he be certified by the Head of the Department in which he is serving to be thoroughly competent; and if he be not in receipt of extra pay, and his salary be not less than two hundred and fifty pounds (or two hundred pounds in case he be a Clerk who is required to give a daily attendance of six hours only), he shall receive no further increment unless he be promoted under clause six of this Order.

Provided further, that under no circumstances shall a Clerk, with or without extra pay, who is transferred to the new scale under this Order, be allowed to rise beyond a maximum of three hundred and fifty pounds.

- 16. Any Clerk who is in receipt of extra pay shall, when his total emoluments reach two hundred and fifty pounds, be forthwith placed in the higher grade established under clause four of this Order, if he be certified by the Head of the Department in which he is serving to be thoroughly competent; after which he shall rise to a maximum of three hundred and fifty pounds, including extra pay, but no more.
- 17. Clause one of the Order in Council of the twelfth February one thousand eight hundred and seventy-six shall be read, from and after the date of this Order, as if the words, 'and of Boy Clerks,' were omitted therefrom.
- 18. Clause five of the Order in Council of the twelfth February one thousand eight hundred and seventy-six shall be read, from and after the date of this Order, as if the words, 'of the Lower Division,' following the words, 'for Boy Clerks,' were omitted therefrom.
- 19. Clause fourteen of the Order in Council of the twelfth February one thousand eight hundred and seventy-six is hereby repealed.
- 20. Clauses sixteen and seventeen of the said Order in Council, authorising and regulating the grant of extra pay, are hereby repealed.

UNIVERSITIES (SCOTLAND) ACT, 1889. At Edinburgh, the 21st day of March 1890.

HEREAS, by an Act passed in the 52nd and 53rd years of Her Majesty's reign, chapter 55, intituled an 'Act for the better Administration and Endowment of the Universities of Scotland,' the Commissioners under the said Act are empowered by section 16, sub-section 1, to affiliate the University College of Dundee to, and make it form part of, the University of St. Andrews, with the consent of the University Court of the University of St. Andrews, and also of the said College: And whereas the said University Court and the University College of Dundee have consented to affiliation upon the conditions set forth in the Schedule hereunto annexed;

Therefore the Commissioners, under the said Act, have affiliated and do hereby affiliate the said University College of Dundee to, and make it form part of, the said University of St. Andrews, subject to the said conditions, and in terms of the said Statute.

In witness whereof these presents are sealed with the seal of the Commission.

SCHEDULE.

- 1. The said Union shall, as regards duration, be permanent, and dissoluble only by Act of Parliament.
- 2. The fundamental purposes and conditions of the Deed of Endowment of Dundee College shall be preserved and maintained. These are as follows: — 'For the purposes of founding, establishing, endowing, maintaining, and conducting a College for promoting the education of persons of both sexes, and the study of science, literature, and the fine arts, subject to the following as a fundamental condition, viz.:-That no Student, Professor, Teacher, or other officer or person connected with the College, or the operations thereof, shall be required to make any declaration as to his or her religious opinions, or submit to any test of his or her religious opinions, and that nothing shall be introduced in the manner or mode of education or instruction in reference to any religious or theological subject which can be reasonably considered offensive to the conscience.
- The funds and estates of Dundee College shall remain under the management and control of the Council of said College, who shall bear and pay, as they have heretofore done, all the charges and expenses of and incident to the maintenance of the said College, including its buildings, furniture, furnishings, and apparatus of every kind, and all other annual outgoings, including also the salaries of its Principal, Professors, Lecturers, and Officers. But it is hereby provided that the University Court to be established under the Universities (Scotland) Act, 1889, shall be entitled to make and levy an annual assessment upon and from the same to and for the benefit and use of the General University Fund, sufficient, in the judgment of such Court, to meet the proportion justly pertaining to the Dundee College of the amount properly payable out of a University fund for defraying the expenses of and incident to the transaction of the business, including Meetings of the University Court, University Council, and Senatus Academicus, and the expense of Elections and of Graduations, in so far as the Matriculation, Graduation, and Registration Fees received by the University from Students of Dundee College may be insufficient to meet the proportion assessed upon the College; further, that Matriculation, Graduation, and Registration Fees received by the University from others than the Students of Dundee College shall be available for University purposes at St. Andrews as heretofore. The Council of the Dundee College shall regularly transmit to the University Court a copy of their annual Accounts as audited: under the provisions of the Deed of Endowment of said College.

- 4. Subject to the provisions of the Statute, the Council of Dundee College shall elect to the University Court from time to time such number of Representatives as the Scottish Universities Commissioners may fix and allow, and such elected person or persons shall become and be members of the said Court accordingly, but subject thereto; none of the other conditions of section 15 of the said Universities (Scotland) Act, 1889, shall apply to Dundee College, or its Principal or Professors; provided always that none of the Representatives of Dundee College elected under the provisions of this Article shall be entitled to sit and vote in the University Court while any matter falling under Article 8 hereof is under consideration.
- 5. All bequests, gifts, or legacies (afterwards called gifts) that may hereafter be made to or for behoof of Dundee College, or for establishing or maintaining any new or other Chairs therein, shall be applied and administered by the Council of said College, provided, as regards gifts for establishing or maintaining any new or other Chairs therein, that the University Court shall be entitled, in the interest of the whole University, to direct any appropriation of the same by the Council in or in connection with Dundee College in any manner not inconsistent with the terms of the gift.
- 6. The Dundee College and its Principal and Professors, including any persons to be appointed to Chairs now vacant, or under the provisions of the Universities Act to be hereafter established (all afterwards called Professors), are and shall be recognised as part of the University of St. Andrews, and said Professors shall become and be members of the Senatus Academicus, and shall have the same tenure of office and the same privileges as the other Professors of the said University, and shall be subject to the same jurisdiction and authorities; provided always that the matter of pensions, as regards Dundee and its Professors, shall be adjusted and settled by the Scottish Universities Commissioners, established by the said Universities Act, as in all the circumstances such Commissioners may think just and On the death, resignation, retirement, or removal of any Professor, the Council of the Dundee College may appoint his successor, subject to the approval of the University Court, and so far as consistent with and subject to the provisions of the Universities (Scotland) Act, 1889, the same rule shall apply to appointments to Chairs that may hereafter be instituted, in the event of the Donors of the Endowments for such Chairs designating the Council as Patrons, or making the gift to the Dundee College or its Council without any special designation of Patrons.
- 7. The Council of Dundee College shall have no power or jurisdiction over or in regard to the University teaching in the College, save a power to see that the fundamental purposes and conditions of its Deed of Endowment are faithfully adhered to and carried out; nor shall they have any power or jurisdiction on or over the courses for Graduation, the fees for Classes forming part of these courses, or any other academic matters ejusdem generis with those named; but declaring always that provision may continue to be made by the Council for Evening Classes in and connected with the said College, and for implementing the Agreement with Sir David Baxter's

Trustees concerning the Technical Institute, and that the Council shall be entitled to exercise the same powers and control as heretofore over and in regard to said Classes and Agreement, and declaring also that the University Court shall, as far as possible, watch over, extend, and develop the College as opportunity arises, on the lines of its foundation. Further, the University Court shall be entitled to employ the services of any Dundee Professor in St. Andrews, with the consent of such Professor and of the Senatus Academicus, and of the Council of Dundee College, and the University Court may employ the services of any St. Andrews Professor in Dundee, with the consent of such Professor, and of the Senatus Academicus, and of the said Council.

8. All the funds and estates at present belonging to the University of St. Andrews as now existing, or to either of its present Colleges, shall continue to be appropriated to University and College uses respectively in St. Andrews, and all funds which are or shall be vested in or bequeathed to the said University, or to either of the said Colleges, by any deed or writing dated on or before the 31st December 1890, shall, if bequeathed for specific purposes, be appropriated to the purposes for which they have been bequeathed, and if bequeathed without designation of a specific purpose, shall be devoted to the further endowment of the offices of the Principals, Professors, Lecturers, and Class Assistants, and to other University or College uses in St. Andrews; and all funds thereafter gifted or bequeathed to either of the Colleges of the University of St. Andrews at St. Andrews shall also be devoted to the use of the College in St. Andrews to which they are gifted or bequeathed.

9. As regards gifts or bequests to be made by any deed or writing dated after 31st December 1890 to the University generally, or without the designation of any particular College or specific purpose, all Colleges of the University shall participate therein in such proportions and manner as the University Court shall from time to time

fix.

10. Subject to the provisions of the Universities (Scotland) Act, 1889, the Scholarships, Fellowships, and Bursaries now attached to the Colleges and the University of St. Andrews shall continue to be tenable only by students studying at St. Andrews, and the Scholarships, Fellowships, and Bursaries existing at Dundee shall be tenable only by students studying there.

11. All Meetings of the University Council shall be held at St. Andrews, and all Ordinary Meetings of the University Court and of the Senatus Academicus shall also be held at St.

Andrews.
