And whereas it appears to us, after communicating with the Authorities and others interested,

to be expedient to alter the Boundaries of the said Parishes in manner hereinafter provided:

Now therefore we, the Boundary Commissioners for Scotland, do hereby, in pursuance of the powers conferred upon us by the Local Government (Scotland) Act, 1889, determine and order as follows:

- I. Subject to the provisions of the said Act, so much of the Parish of Kirkpatrick-Fleming as lies to the west of the eastern fence of the road forming the eastern boundary of the Estate of Scotsfield shall cease to be part of that Parish, and shall form part of the Parish of Dornock.
- II. This Order shall come into operation on the 15th day of May 1891.
