By the Board of Agriculture.

The Board of Agriculture, by virtue and in exercise of the powers in them vested under The Board of Agriculture Act, 1889, and The Contagious Diseases (Animals) Act, 1878 to 1890, and of every other power enabling them in this behalf, do hereby approve of the following part of the Port of Leith as a landing-place for foreign animals not subject to slaughter or quarantine:—
