A PROCLAMATION.

VICTORIA, R.

WHEREAS Our Parliament stands prorogued to Saturday the twenty-fifth day of October one thousand eight hundred and ninety, We, by and with the advice of Our Privy Council, hereby issue Our Royal Proclamation, and publish and declare that the said Parliament be further prorogued to Tuesday the twenty-fifth day of November one thousand eight hundred and ninety; and We do hereby further, with the advice aforesaid, declare Our Royal will and pleasure that the said Parliament shall, on the said Tuesday the twenty-fifth day of November one thousand eight hundred and ninety, assemble and be holden for the despatch of divers urgent and important affairs: and the Lords, Spiritual and Temporal, and the Knights, Citizens, and Burgesses, and the Commissioners for Shires and Burghs of the House of Commons, are hereby required and commanded to give their attendance accordingly at Westminster, on the said Tuesday the twenty-fifth day of November one thousand eight hundred and ninety.

Given at Our Court at Balmoral, this twenty-first day of October, in the year of our Lord one thousand eight hundred and ninety, and in the fifty-fourth year of Our Reign.

GOD SAVE THE QUEEN.

It is this day ordered by Her Majesty in Council that the Convocations of the Provinces of Canterbury and York be prorogued from the day to which the same now stand prorogued to Wednesday the twenty-sixth day of November one thousand eight hundred and ninety; and the Right Honourable the Lord High Chancellor of that part of the United Kingdom called Great Britain is to cause Writs to be prepared and issued in the usual manner for proroguing the Convocations accordingly.

WHEREAS the Secretary for Scotland has, under the provisions of the Burial Grounds (Scotland) Act, 1855, made a Representation stating that he has received a copy of an Interlocutor of the Sheriff of the Lothians, finding, on a Petition presented to him by two Members of the Town Council of the City of Edinburgh, who are held to be the Parochial Board of the Parish of Canongate, Edinburgh, for the purposes of the Burial Grounds (Scotland) Act, 1855, with the

consent and concurrence of the Edinburgh Ecclesiastical Commissioners, incorporated by Act of Parliament, and the said Ecclesiastical Commissioners, for any right or interest they have in the premises, 'that the Burying Ground or Churchyard of the Parish of Canongate, in the County of Edinburgh, is in a condition 'which is dangerous to health':

And whereas in the said Representation it is recommended that the said Burying Ground or Churchyard be closed for burials:

Now, therefore, Her Majesty in Council is pleased to give notice of such Representation, and to order that the same be taken into consideration by a Committee of Her Majesty's Most Honourable Privy Council on the 8th day of December next.

And Her Majesty is further pleased to direct that this Order, or notice thereof, be published in the Edinburgh Gazette, and that copies of this Order, or notice thereof, be affixed, as required by the above-mentioned Act, on the doors of the Church of, or on some other conspicuous places within, the Parish affected by such Representation one month before such Representation is so considered.

LOCAL GOVERNMENT (SCOTLAND) ACT, 1889.

BURGH OF INVERURIE.

Determination under Section 59.

WHEREAS by Section 59 of the Local Government (Scotland) Act, 1889, it is provided that 'Where the Parliamentary area of a county or burgh differs from its area within the meaning of this Act, the Secretary for Scotland may determine which shall be the administrative and rating authority under the Contagious Diseases (Animals) Acts in any portion of such area; and his determination shall, subject to the provisions of this Act, have the same force and effect as if it were enacted in this Act: Provided that such determination shall not limit the powers of the Boundary Commissioners under this Act.'

And whereas the Parliamentary area of the Burgh of Inverurie differs from its area within the meaning of the Local Government (Scotland) Act, 1889.

Now, therefore, I, the Most Honourable Schomberg Henry, Marquess and Earl of Lothian, K.T., Her Majesty's Secretary for Scotland, hereby determine that the Council of the County of Aberdeen shall be the administrative and rating authority under the Contagious Diseases (Animals) Acts in that portion of the area of the Parliamentary Burgh of Inverurie which is outwith the area of the Burgh of Inverurie within the meaning of the Local Government (Scotland) Act, 1889.

ORDER BY THE BOUNDARY COMMISSIONERS FOR SCOTLAND.

COUNTIES OF KINROSS AND PERTH.

Parishes of Forgandenny and Forteviot.

WHEREAS the Parish of Forgandenny is situated partly in the County of Perth and partly in the County of Kinross :

And whereas a part of the Parish of Forteviot, containing 1006 acres or thereby, and situated at or near Whitehill (being the part marked on the Ordnance Survey Maps Forteviot detached No. 1), is detached from the main portion of the Parish of Forteviot, being separated therefrom by part of the Parish of Forgandenny; and another part of the Parish of Forteviot, containing 1887 acres or thereby, situated at or near Hilton and adjoining the Parishes of Forgandenny, Dunbarney, Perth, and Aberdalgie (being the part marked on the Ordnance Survey Maps Forteviot detached No. 2), is also detached from the main portion of the Parish of Forteviot :
