#### FOREIGN OFFICE, November 4, 1890.

It is hereby notified, for public information, that in pursuance of an Agreement with the Sultan of Zanzibar, the Dominions of His Highness are placed under the Protectorate of Her Britannic Majesty.

The Protectorate comprises the territory recognised as belonging to His Highness in the Articles of Agreement between Great Britain and Germany, recorded in the note from His Excellency Count Hatzfeldt of the 29th October 1886, and in the note from the Earl of Iddesleigh of the 1st November following, with the exception of the territory lying to the south of the River Umba, of the Island of Mafia, and of the districts of Brava, Merka, Magadisho, and Warsheikh.
