REGULATIONS (framed in pursuance of Act 40 and 41 Vict., cap. 57) respecting Open Competitive Examinations for the situation of Junior Clerk in the High Court of Justice, Ireland.

## N.B.—These Regulations are liable to Alteration for future Examinations.

- 1. Competitive Examinations of Candidates for this situation will be held from time to time as may be deemed expedient.
- 2. These Examinations are open to all naturalborn subjects of Her Majesty, being of the prescribed age, and of good health and character.
- 3. The limits of age for this situation are 20 and 30. Candidates must be of the prescribed age on the first day of the Competitive Examination.
- 4. The subjects of Examination will be as follows:—
  - 1. Handwriting.
  - 2. Orthography.
  - 3. Arithmetic (including Vulgar and Decimal Fractions).
  - 4. Copying MS. (to test accuracy).
  - 5. English Composition.
  - 6. Indexing or Docketing.
  - 7. English History.
  - 8. Geography.

Candidates will be at liberty to offer themselves for examination in any or all of these subjects. No subjects are obligatory.

No Candidate can be admitted to the Competition who has not previously satisfied the Civil Service Commissioners that he possesses the requisite amount of proficiency in Handwriting, Orthography, Arithmetic (including Vulgar and Decimal Fractions), and Copying MS. (to test accuracy). With this view, Preliminary Examinations in these subjects will be held at such times and places as the Commissioners may appoint. Application for permission to attend one of these Preliminary Examinations must be made, in the writing of the Candidate, at such times and in such manner as may be fixed by the Commissioners.

5. At each Competitive Examination the number of Candidates to be selected will be the num-

ber required to fill the vacancies existing at the time of the Examination.

6. A fee of 10s. will be required from each Candidate attending a Preliminary Examination, and a further fee of 10s. from every Candidate admitted to a Competitive Examination.

The Civil Service Commissioners further give notice, that an Open Competitive Examination will be held in Dublin, under the foregoing Regulations, commencing on the 7th April 1891.

A Preliminary Examination will be held in Dublin on the 31st March 1891.

No person will be admitted to Examination from whom the Secretary of the Civil Service Commission has not received, on or before the 20th March, an 'application' in the handwriting of the Candidate, on a prescribed form, which may be obtained from the Secretary at once.
