COUNTY OF PERTH.

Parishes of Blackford and Glendevon.

WHEREAS a part of the Parish of Blackford, containing 450 acres or thereby, situated south of the River Devon and adjoining the Parishes of Tillicoultry, Dollar, and Glendevon, is, as shown on the Ordnance Survey Maps, detached or nearly detached from the main portion of the Parish of Blackford:

And whereas it appears to us, after communicating with the Authorities and others interested,

to be expedient to deal with the said part in manner hereinafter provided :

Now, therefore, we, the Boundary Commissioners for Scotland, do hereby, in pursuance of the powers conferred upon us by the Local Government (Scotland) Act, 1889, determine and order as follows :—

I. Subject to the provisions of the said Act, that portion of the Parish of Blackford which is bounded on the north by the *medium filum* of the River Devon, on the west by the Parish of Tillicoultry, on the south by the Parishes of Tillicoultry and Dollar, and on the east by the Parish of Glendevon, shall cease to be part of the Parish of Blackford, and shall form part of the Parish of Glendevon.

LOCAL GOVERNMENT (SCOTLAND) ACT, 1889.
ORDER BY THE BOUNDARY COMMISSIONERS FOR SCOTLAND.

COUNTIES OF LANARK AND RENFREW.

Parishes of Carmunnock, Cathcart, and East Kilbride.

WHEREAS the Parish of Cathcart is situated partly in the County of Lanark and partly in the County of Renfrew :

And whereas a part of the Parish of Cathcart in the County of Lanark, containing 938 acres or thereby, situated at or near Dripps and adjoining the Parish of East Kilbride, in the County of Lanark, is detached from the main portion of the Parish of Cathcart :

And whereas it appears to us, after communicating with the Authorities and others interested, to be expedient to alter and adjust the Boundaries of the said Counties of Lanark and Renfrew, and of the said Parishes of Carmunnock, Cathcart, and East Kilbride in manner hereinafter provided :

Now, therefore, we, the Boundary Commissioners for Scotland, do hereby, in pursuance of the powers conferred upon us by the Local Government (Scotland) Act, 1889, determine and order as follows :—

I. Subject to the provisions of the said Act, the aforesaid detached part of the Parish of Cathcart shall cease to be part of that Parish and shall form part of the Parish of East Kilbride, provided always that nothing herein contained shall affect the School District of Carmunnock, or the powers, duties, and liabilities of the School Board of the said District, or the mode of electing the said School Board.

II. Subject to the provisions of the said Act, so much of the road from Symshill to Croftfoot as lies between Symshill on the west, and the point at which the said road leaves the Parish of Cathcart, 193 yards or thereby west of Croftfoot, on the east, and is within the Parish of Carmunnock, shall cease to be part of the Parish of Carmunnock, and shall form part of the Parish of Cathcart ; and so much of the Parish of Cathcart (as altered in area by this Order) as is situated in the County of Lanark shall cease to be part of that County, and shall form part of the County of Renfrew.

III. This Order shall come into operation on the 15th day of May 1891.

THE PLEURO-PNEUMONIA
(SUPPLEMENTAL) ORDER of 1891, No. 2.

By the Board of Agriculture.

The Board of Agriculture, by virtue and in exercise of the powers in them vested under The Board of Agriculture Act, 1889, and The Contagious Diseases (Animals) Acts, 1878 to 1890, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:—

Revocation of Order.

1. The Pleuro-Pneumonia (Supplemental) Order of 1891, dated the twenty-sixth day of December one thousand eight hundred and ninety, is hereby revoked: Provided that such revocation shall not invalidate or make unlawful anything done under the said Order, or interfere with the institution or prosecution of any proceeding in respect of any offence committed against, or any penalty incurred under, the said Order.

Special Regulations as to Cattle landed from Ireland in a Scheduled District.

2. (1) Notwithstanding anything in Article 12 of The Pleuro-Pneumonia Order of 1891, cattle landed from Ireland at a port or place in a Scheduled District declared by the Board of Agriculture under that Order may be moved out of the Scheduled District to any place of destination, whether such place of destination be within the limits of another Scheduled District or not, on the following conditions:—

(a.) When landed, the cattle shall be moved forthwith by the most direct available route to the nearest available railway station (such station being within the Scheduled District in which the cattle are landed) on the line of railway by which the cattle are to be moved to their place of destination.

(b.) The cattle shall be kept at the said railway station until trucked, and shall then be moved by rail to the place of destination without untrucking.

(2) If any head of cattle landed from Ireland at a port or place in a Scheduled District as aforesaid is moved out of the Scheduled District in contravention of the foregoing conditions, except where it is moved in accordance with the provisions of Article 12 of the said Order of 1891, the owner of the animal, and the person for the time being in charge thereof, and the person causing, directing, or permitting the movement, and the person moving or conveying the animal, and the consignee or other person receiving or keeping it knowing it to have been moved in contravention as aforesaid, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Act of 1878.

Short Title.

3. This Order may be cited as THE PLEURO-PNEUMONIA (SUPPLEMENTAL) ORDER OF 1891, No. 2.

Interpretation.

4. In this Order terms have the same meaning as in The Pleuro-Pneumonia Order of 1891.
