WHEREAS the Boundary Commissioners, duly appointed under the Local Government (Scotland) Act, 1889, have finally made, and published in the Edinburgh Gazette, and brought before Her Majesty an order in the following terms:—

'Whereas a part of the Parish of Tarland Migvie, containing 2398 acres or thereby, situated at or near Deskry and adjoining the Parishes of Glenbucket, Strathdon, Logie-Coldstone, and Towie (being the part marked on the Ordnance Survey Maps Tarland and Migvie detached No. 1), is detached from the main portion of the Parish of Tarland and Migvie; and another part of the Parish of Tarland and Migvie, containing 1969 acres or thereby, situated at or near Glack and adjoining the Parishes of Logie-Coldstone and Towie (being the part marked on the Ordnance Survey Maps Tarland and Migvie detached No. 2), is also detached from the main portion of the Parish of Tarland and Migvie; and another part of the Parish of Tarland and Migvie, containing 8293 acres or thereby, situated at Glen Ernan and almost surrounded by the Parish of Strathdon (being the part marked on the Ordnance Survey Maps Tarland and Migvie detached No. 3), is also detached from the main portion of the Parish of Tarland and Migvie:

'And whereas it appears to us, after communicating with the Authorities and others interested, and considering all objections made to the terms of our Draft Order thereon, to be expedient to alter and adjust in the manner hereinafter provided the Boundaries of the said Parishes of Logie-Coldstone, Strathdon, Tarland and Migvie, and Towie:

'Now, therefore, we, the Boundary Commissioners for Scotland, do hereby, in pursuance of the powers conferred upon us by the Local Government (Scotland) Act, 1889, determine and order as follows:—
