THE BOUNDARY COMMISSIONERS FOR SCOTLAND.

COUNTY OF ROSS & CROMARTY.

ELECTORAL DIVISIONS.

Whereas the Secretary for Scotland has, under the provisions of the Local Government (Scotland) Act, 1889, determined the number of Councillors to be elected to the County Council of Ross & Cromarty to be fifty-five, and has apportioned them as follows, viz.:—For the Burgh of Dingwall, one; for the Burgh of Tain, one; for the Burgh of Fortrose, one; and for the Burgh of Cromarty, one; and for the County, including Police Burghs, fifty-one:

Now, therefore, we, the Boundary Commissioners for Scotland, after due inquiry and consultation with the Authorities concerned de bareby in pursuance of the powers conformed upon us by the science.

Now, therefore, we, the Boundary Commissioners for Scotland, after due inquiry and consultation with the Authorities concerned, do hereby, in pursuance of the powers conferred upon us by the said Act, determine the contents and boundaries of the Electoral Divisions of the County of Ross &

Cromarty to be as follows:-

I	Cromarty and Rosemarkie	I. BLACK ISLE DISTRICT. (1) The Parish of Cromarty, exclusive of the portion included within the limits of the Burgh of Cromarty, and (2) the Parish of Rosemarkie, exclusive of the portion included within the limits of the Burgh of Fortrose.
2	Resolis	The Parish of Resolis.
3	Avoch	That part of the Parish of Avoch which lies to the south of the centre of the line forming the Black Isle Branch of the Highland Railway, as constructed under 53 and 54 Vict. cap. LXI.
4	Rosehaugh	(1) The remainder of the Parish of Avoch, and (2) that part of the Parish of Kilmuir Wester and Suddie (or Knockbain) which lies to the north of the centre of the main road leading from Dingwall to Fortrose.
5	Munlochy	The remainder of the Parish of Kilmuir Wester and Suddie (or Knockbain).
6	Killearnan	The Parish of Killearnan.
7	Kincardine	II. EASTER ROSS DISTRICT. The Parish of Kincardine.
7 8	Edderton	The Parish of Edderton.
9	Tain Landward	The Parish of Tain, exclusive of the portion included within the limits of the Burgh of Tain.
10	Portmahomack	That part of the Parish of Tarbat which lies to the east of a line drawn in a generally northerly direction from a point on the sea-shore opposite the southern extremity of the road leading from Meikle Tarrel to the sea, to and along the centre of the said road and of the road which, leading north from Meikle Tarrel, crosses the county road at North Tarrel, and runs down to the sea at Balcladdich, to the northern extremity of the said road, and thence to the nearest point of the sea-shore.
11	Cadboll	(1) The remainder of the Parish of Tarbat, and (2) that part of the Parish of Fearn which lies to the east of a line drawn first in a south-easterly direction along the centre of the road from Balnagall to Balmuchy School from the point at which the said road enters the Parish
		until it meets the main road from Portmahomack to Hill of Fearn, then in a south-westerly direction along the centre of the last-mentioned road to the point near Free Church of Fearn at which the road to Hilton of Cadboll strikes off, then in a south-easterly direction
		along the centre of the last-mentioned road to the point at which it is joined by the road running along the north-west march of Hilton Farm, then in a south-westerly direction along the last-mentioned road till it meets the road which runs between the farms of Hilton
