LOCAL GOVERNMENT (SCOTLAND) ACT, 1889.

THE BOUNDARY COMMISSIONERS FOR SCOTLAND.

Parishes of Canongate, City of Edinburgh, St. Cuthberts, and South Leith.

Whereas certain parts of Canongate Parish are, as shown on the Ordnance Survey Maps, detached from the main portion of Canongate Parish, videlicet—(1) a part extending to 28 acres or thereby, containing Edinburgh Castle and adjoining the Parishes of City of Edinburgh and St. Cuthberts; (2) a part containing 0.44 of an acre or thereby, situated at or near Bristo Place and adjoining the Parishes of City of Edinburgh and St. Cuthberts; and (3) a part containing 0.56 of an acre or thereby, situated at or near Lothian Street and adjoining the Parishes of City of Edinburgh and St. Cuthberts:

And whereas certain parts of City of Edinburgh Parish are, as shown on the Ordnance Survey Maps, detached from the main portion of City of Edinburgh Parish, videlicet—(1) a part containing 7 acres or thereby, situated at or near Heriothill and surrounded by the Parish of St. Cuthberts; (2) a part containing 19 acres or thereby, situated at or near Broughton Hall and surrounded by the Parish of St. Cuthberts; (3) a part containing 14 acres or thereby, situated at or near Henderson Row and surrounded by the Parish of St. Cuthberts; (4) a part containing 0.35 of an acre or thereby, situated at or near St. Stephen's Church and surrounded by the Parish of St. Cuthberts; (5) a part containing

And whereas certain parts of St. Cuthberts Parish are, as shown on the Ordnance Survey Maps, detached from the main portion of St. Cuthberts Parish, videlicet—(1) a part containing 3 acres or thereby, situated at or near Barony Street and surrounded by City of Edinburgh Parish; (2) a part containing 0.77 of an acre or thereby, situated at or near Broughton Street and surrounded by City of Edinburgh Parish; (3) a part containing 10 acres or thereby, situated at or near St. James' Square and surrounded by City of Edinburgh Parish; (4) a part containing 0.25 of an acre or thereby, situated at or near Leith Street and surrounded by City of Edinburgh Parish; (5) a part containing 0.66 of an acre or thereby, situated at or near Low Calton and adjoining City of Edinburgh Parish and a detached part of South Leith Parish; (6) a part containing 6 acres or thereby, situated at or near Calton New Burial Ground and adjoining the Parishes of Canongate and South Leith; and (7) a part containing 53 acres or thereby, situated at or near Abbeyhill and adjoining the Parishes of Canongate and South Leith:

And whereas certain parts of the Parish of South Leith are, as shown on the Ordnance Survey Maps, detached from the main portion of the Parish of South Leith, videlicet—(1) a part containing 2 acres or thereby, situated at or near High Calton and surrounded by City of Edinburgh Parish; and (2) a part containing 4 acres or thereby, situated at or near North Back of Canongate and adjoining the Parishes of Canongate and City of Edinburgh:

And whereas it appears to us, after communicating with the Authorities and others interested, to be expedient to alter and adjust in manner hereinafter provided the boundaries of the said Parishes:

Now, therefore, we, the Boundary Commissioners for Scotland, do hereby, in pursuance of the powers conferred upon us by the Local Government (Scotland) Act, 1889, determine and order as follows:—

I. Subject to the provisions of the said Act, those portions of Canongate Parish, of St, Cuthberts Parish, and of the Parish of South Leith, which are situated within the boundary line hereinafter described, shall cease to be part of their respective Parishes, and shall form part of City of Edinburgh Parish, viz.:—

A line starting from the point in the centre of the street known as North Back of Canongate, to the south of the Burns Monument, at which the boundary between City of Edinburgh Parish and the main portion of the Parish of South Leith leaves

the boundary of Canongate Parish, and running first in a northerly direction along the said boundary between City of Edin-burgh Parish and the Parish of South Leith until it intersects the street known as Regent Terrace, thence in a north-easterly direction along the centre of the said street to a point opposite the centre of Regent Terrace Lane, thence in a northerly direction to and along the centre of the said lane to the centre of the street known as Royal Terrace, thence in a generally westerly direction along the centre of the last-mentioned street and the centre of the street known as Blenheim Place to the centre of the street known as Leith Walk, and along the centre of the lastmentioned street and the centre of the street known as Picardy Place to the centre of Broughton Street, thence in a northerly direction along the centre of the last-mentioned street, the centre of the street known as Mansfield Place, the centre of the road leading from Mansfield Place to Canonmills, and the centre of the street known as Canonmills to the centre of the Bridge crossing the Water of Leith at Canonmills, thence up the medium filum of the Water of Leith to the centre of the Dean Bridge, thence in a southerly direction along the centre of the Dean Bridge and the centre of the street running along the west side of Randolph Cliff, the west side of Randolph Crescent Gardens, and the west side of Randolph Place, to the west end of the street known as Charlotte Place, thence in an easterly direction along the centre of the lastmentioned street and the centre of the lane or passage on the south side of St. George's Church to the centre of the roadway on the west side of Charlotte Square, thence in a southerly direction along the centre of the said roadway and the centre of Hope Street to its junction with Princes Street, thence in an easterly direction along the centre of the lastmentioned street to a point opposite the boundary between St. Cuthberts Buryingground and West Princes Street Gardens, thence in a southerly direction to and along the said boundary till it reaches the north boundary of the North British Railway line, thence in an easterly direction along the last-mentioned boundary until it meets the boundary of the afore-said detached part of Canongate Parish containing Edinburgh Castle, thence along the northern and eastern boundaries of the said detached part of Canongate Parish until it reaches the centre of the street known as Johnston Terrace, thence in a westerly direction along the centre of the last-mentioned street to a point opposite the west end of the block of buildings in the last-mentioned terrace forming the Married Soldiers' Quarters, thence in a southerly direction to and along the existing boundary of the said detached part of Canongate Parish con-taining Edinburgh Castle by the west side of the said block of buildings till it reaches the Grassmarket at its junction with the street known as King's Stables Road,

thence across the Grassmarket to the north end of the street known as the Vennel, thence in a southerly direction along the centre of the last-mentioned street and of the street known as Heriot's Place to the centre of the street known as Lauriston Place, thence in a generally easterly direction along the centre of the streets known as Lauriston Place, Teviot Place, Lothian Street, South College Street, and Drummond Street to the centre of the street known as the Pleasance, thence in a northerly direction along the centre of the last-mentioned street and the centre of St. Mary Street until it meets the street known as the Canongate, thence across the last-mentioned street to the south end of Cranston Street, thence along the centre of the lastmentioned street and the centre of the road running underneath the North British Railway lines to the centre of the street known as North Back of Canongate, and thence in an easterly direction along the centre of the last mentioned street to the point from which the said line started.

II. Subject to the provisions of the said Act, the aforesaid detached part of City of Edinburgh Parish situated at or near Elm Row, the aforesaid detached part of City of Edinburgh Parish situated at or near Maryfield, and so much of the aforesaid detached part of City of Edinburgh Parish situated at or near Royal Terrace as is not included within the boundary line described in the first section hereof, shall cease to be part of City of Edinburgh!

Parish and shall form part of South Leith Parish; and so much of the remainder of of City of Edinburgh Parish as is not included within the said boundary line shall cease to be part of City of Edinburgh Parish, and shall form part of St. Cuthberts Parish.

III. Subject to the provisions of the said Act, so much of the aforesaid detached part of Canongate Parish containing Edinburgh Castle as is not included within the boundary line described in the first section hereof shall cease to be part of Canongate Parish, and shall form part of St. Cuthberts Parish.

IV. Subject to the provisions of the said Act, the aforesaid detached part of the Parish of St. Cuthberts situated at or near Calton New Burial Ground, and the aforesaid detached part of the Parish of St. Cuthberts situated at or near Abbeyhill, shall cease to be part of the Parish of St. Cuthberts, and shall form part of the Parish of Canongate.

V. This Order shall come into operation on the

15th day of May 1892.

THE HADDINGTONSHIRE PLEURO-PNEUMONIA MOVEMENT ORDER OF 1891.

By the Board of Agriculture.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under The Board of Agriculture Act, 1889, and The Contagious Diseases (Animals) Acts, 1878 to 1890, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:—

Restriction on Movement.

1. No cow in calf or in milk shall be moved into the District of the Local Authority of the County of Haddington from the District of any other Local Authority in England or Wales or Scotland otherwise than in accordance with the following provisions (namely):—

With a Licence of the Local Authority of the county of Haddington, granted on a Declaration of the owner, or of his agent, authorised in writing for the purpose, declaring that, to the best of his knowledge and belief—

- (a.) each of the cows to be moved is not affected with pleuro-pneumonia, and has not been exposed to the infection of pleuro-pneumonia; and
- (b.) each of the cows has been in the District of the Local Authority out of which it is to be moved for a period of at least fifty-six days immediately before the making of the Declaration, and has not during that period been in contact with any cattle which have been brought from Ireland, or during that period been within a distance of one mile of a pleuro-pneumonia infected place, or during that period been exposed in or at any market, fair, exhibition, or public sale; and
- (c.) there is not at the time of the making of the Declaration a pleuro-pneumonia infected place within one mile of the farm or premises from which the cow is to be moved; and
- (d.) the cow while being moved to its place of destination in the County of Haddington will not pass, otherwise than by railway, within one mile of a pleuro-pneumonia infected place.

Disposal of Movement Licence.

2. Cows moved under this Order shall be accompanied by the Licence permitting the movement, and such Licence shall, within two days after the arrival of the cows at their place of destination in the County of Haddington, be delivered to a Police Constable appointed by the Local Authority of that county to receive the same.

Limitation.

3. Nothing in this Order shall be deemed to apply to the movement of cows by railway through

the District of the County of Haddington, without untrucking.

Offences.

4. If a cow is moved into the County of Haddington in contravention of the provisions of this Order, the owner of the animal, and the person for the time being in charge thereof, and the person causing, directing, or permitting the movement, and the person moving or conveying the animal, and the owner and the charterer and the master of the vessel in which it is moved, and the consignee or other person receiving or keeping it knowing it to have been moved in contravention as aforesaid, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Act of 1878.

Short Title.

5. This Order may be cited as THE HADDINGTONSHIRE PLEURO-PNEUMONIA MOVEMENT ORDER OF 1891.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under The Board of Agriculture Act, 1889, and The Contagious Diseases (Animals) Acts, 1878 to 1890, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:—

Restriction of Movement.

- 1.—(1) No cattle shall be moved into the County of Zetland from the District of any other Local Authority in England or Wales or Scotland except as provided by this Order:—
 - (i.) Cattle may be moved into the County of Zetland from the County of Orkney with a Declaration of the owner, or of his agent authorised in writing for that purpose, declaring that, to the best of his knowledge and belief, each of the cattle to be moved is not affected with pleuro-pneumonia, and has not been exposed to the infection of pleuro-pneumonia, and has been in the possession of such owner or agent for a period of at least three months immediately before the making of the Declaration.

- (ii.) Breeding bulls may be moved into the County of Zetland from the District of any other Local Authority in Scotland which District is for the time being free from pleuro-pneumonia in accordance with the following conditions (namely):—
- (a.) The bulls may be moved into the County of Zetland with a Licence of the Local Authority of that County granted on a Certificate of a Veterinary Inspector at the port of shipment certifying that each bull described in the Certificate is in his opinion free from pleuro-pneumonia, and a Declaration of the owner, or his agent authorised in writing for that purpose, declaring that, to the best of his knowledge and belief, each bull described in the Declaration is not affected with pleuro-pneumonia, and has not been exposed to the infection of pleuro-pneumonia, and has been in the possession of such owner or agent for a period of at least three months immediately before the making of the Declaration.
- (b.) Each bull shall immediately after being landed in the County of Zetland and again at the expiration of eight weeks after the date of being landed be inspected by the Veterinary Inspector of the Local Authority of the County of Zetland.
- (2) The Declarations and Certificates required under this Article shall be delivered to the police immediately on the landing of the cattle in the County of Zetland.

Offences.

2. If a head of cattle is moved into the County of Zetland in contravention of the provisions of this Order, the owner of the animal, and the person for the time being in charge thereof, and the person causing, directing, or permitting the movement, and the person moving or conveying the animal, and the owner and the charterer and the master of the vessel in which it is moved, and the consignee or other person receiving or keeping it knowing it to have been moved in contravention as aforesaid, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Act of 1878.

Short Title.

3. This Order may be cited as THE ZETLAND PLEURO-PNEUMONIA MOVEMENT ORDER OF 1891.

Commencement.

4. This Order shall take effect from and immediately after the twenty-eight day of April one thousand eight hundred and ninety-one.

[Ordinance, No. 8—St. Andrews, Aberdeen, and Edinburgh, No. 1. — Libraries and Museums.]

At Edinburgh, the third day of April Eighteen Hundred and Ninety-One years.

Whereas by the Universities (Scotland) Act, 1889, section 6, sub-section 7, the University Court of each University has power, subject to any Ordinances made by the Commissioners under the said Act, to appoint from among members of the University or others, not being members of the Senatus Academicus, one-third of the members of any standing committee or committees charged, by Ordinance of the Commissioners under the said Act, with the immediate superintendence of any libraries or museums, or the contents thereof belonging to the University and College or Colleges thereof, existing at the passing of the said Act, and on

representation made by any of its members, or by any member of the Senatus Academicus, to review any decision which the Senatus Academicus, in the exercise of its powers, may come to in respect of the recommendations of such committee or committees:

And whereas by the said Act, section 7, subsection 2, the Senatus Academicus in each University has power to appoint two-thirds of the members of any standing committee or committees charged by Ordinance of the Commissioners under the said Act with the immediate superintendence of any libraries or museums, or the contents thereof, belonging to the University and College or Colleges thereof existing at the passing of the said Act, and to receive in the first instance all reports by such committee or committees, and subject to the review of the University Court, to confirm, modify, or reject the recommendations in such reports:

And whereas by the said Act, section 14, subsection 16, the Commissioners under the said Act are empowered to repeal or modify any Ordinance made under the provisions of the Universities (Scotland) Act, 1858:

Therefore the Commissioners under the said Act Statute and Ordain as follows:—

- 1. With regard to the Universities of St Andrews and Aberdeen:—
 - (1) In each of the said Universities a Committee, to be called the Library Committee, shall be constituted, consisting of three members of the University or others, not being members of the Senatus Academicus, appointed by the University Court, and of six members appointed by the Senatus Academicus. The said Committee Senatus Academicus. The said Committee in each of the said Universities shall be charged with the immediate superintendence of the University Library, and of the contents thereof, and of any libraries acquired, or to be acquired, for the use of the University or of any class therein. The members of the said Committee, in the proportions aforesaid, shall be appointed by the University Court and Senatus Academicus respectively at their first meeting after the commencement of the Winter Session in each year.
 - 2) In each of the said Universities a Committee, to be called the Museum Committee, shall be constituted, consisting of three members of the University or others, not being members of the Senatus Academicus, appointed by the University Court, and of six members appointed by the Senatus Academicus. The said Committee in each of the said Universities shall be charged with the immediate superintendence of all Museums belonging to the University, and of the contents thereof, and of any collections, furniture, or apparatus, or objects acquired, or to be acquired, for the use of the University or of any class therein. The members of the said Committee, in the proportions aforesaid, shall be appointed by the University Court and Senatus Academicus respectively at their first meeting after the commencement of the Winter Session in each year.
- 2. With regard to the University of Edinburgh:—

- (1) A Committee, to be called the Library Committee, shall be constituted, consisting of not more than seven members of the University or others, not being members of the Senatus Academicus, appointed by the University Court, and of such number of members appointed by the Senatus Academicus as shall be double the number appointed by the Court. The said Committee shall be charged with the immediate superintendence of the University Library, and of the contents thereof, and of any libraries acquired, or to be acquired, for the use of the University or of any class therein. The members of the said Committee, in the proportions aforesaid, shall be appointed by the University Court and Senatus Academicus respectively at their first meeting after the commencement of the Winter Session in each year.
- (2) A Committee, to be called the Museum Committee, shall be constituted, consisting of three members of the University or others, not being members of the Senatus Academicus, appointed by the University Court, and of six members appointed by the Senatus Academicus. The said Committee shall be charged with the immediate superintendence of all Museums belonging to the University, and of the contents thereof, and of any collections, furniture, or apparatus, or objects acquired, or to be acquired, for the use of the University or of any class therein. The members of the said Committee, in the proportions aforesaid, shall be appointed by the University Court and Senatus Academicus respectively at their first meeting after the commencement of the Winter Session in each year.
- 3. The Ordinances of the Commissioners under the Universities (Scotland) Act, 1858, numbered respectively—General No. 7, Ordinance No. 69, and General No. 9, Ordinance No. 89—in so far as they are inconsistent with this Ordinance, are hereby repealed in so far as regards the Universities of St. Andrews, Aberdeen, and Edinburgh.
