The Portuguese Minister in London has addressed a Note, dated the 22nd instant, to the Marquis of Salisbury, Her Majesty's Principal Secretary of State for Foreign Affairs, giving notice, on the part of the Portuguese Government, to terminate the Treaty of Commerce and Navigation between Great Britain and Portugal of July 3, 1842, and the Supplementary Convention of May 22, 1882.

The above mentioned Treaty and Convention will accordingly expire on the 22nd of June 1892.

The Board of Agriculture, by virtue and in exercise of the powers in them vested under The Board of Agriculture Act, 1889, and The Contagious Diseases (Animals) Acts, 1878 to 1890, and of every other power enabling them in this behalf, do hereby revoke their Order, bearing date the twenty-second day of August one thousand eight hundred and ninety, approving of a part of the Port of Dundee as a landing-place for foreign animals not subject to slaughter or quarantine: Provided that nothing herein shall be deemed to invalidate or make unlawful anything done under the said Order before the date of this revocation, or interfere with the institution or prosecution of any proceeding in respect of any offence committed against, or any penalty incurred under, the said Order.

(Port of Dundee—Approval of Landing-Place for Foreign Animals.)

By the Board of Agriculture.

The Board of Agriculture, by virtue and in exercise of the powers in them vested under The Board of Agriculture Act, 1889, and The Contagious Diseases (Animals) Acts, 1878 to 1890, and of every other power enabling them in this behalf, do hereby approve of the following part of the Port of Dundee as a landing-place for foreign animals not subject to slaughter or quarantine:—

All that space situate in the Parish of Dundee, in the Burgh of Dundee, and on certain land, called the Reclaimed Ground, on the north bank of the river Tay, and included within the following boundary, namely, commencing at a point on the water-edge of the said river Tay at a distance of one thousand six hundred and fifty feet or there-

abouts to the east of the East Shipbuilding Yard, thence in a northernly direction for a distance of one hundred and seventy-one feet or thereabouts, thence in a westernly direction for a distance of seventy-eight feet or thereabouts, thence in a northernly direction for a distance of one hundred and eight feet or thereabouts, thence in an easternly direction for a distance of seventy-eight feet or thereabouts, thence in a northernly direction for a distance of thirty feet or thereabouts, thence in an easternly direction for a distance of one hundred and twenty-two feet or thereabouts, thence in a southernly direction for a distance of one hundred and thirteen feet or thereabouts, thence in an easternly direction for a distance of nine feet or thereabouts, thence in a northernly direction for a distance of one hundred and forty-one feet or thereabouts, thence in an easternly direction for a distance of one hundred and two feet or thereabouts, thence in a southernly direction for a distance of eighty-six feet or thereabouts, thence in an easternly direction for a distance of one hundred and fifty feet or thereabouts, thence in a southernly direction for a distance of fifty-five feet or thereabouts, thence in a westernly direction for a distance of one hundred and twenty feet or thereabouts, and thence in a southernly direction for a distance of one hundred and ninety-nine feet or thereabouts, all bounded by wooden fences and brick walls, and thence in a westernly direction for a distance of two hundred and sixty-five feet or thereabouts, and bounded by the said river Tay to the point aforesaid, the front portion of which space is occupied by the wharf or landingplace, and is coloured blue, and the remainder occupied by the lairages and offices is coloured red on the plan of the said landing-place, deposited for the purposes of this Order at the office of the Board of Agriculture, a copy of which is deposited at the office of the Clerk of the Police Commissioners of the Burgh of Dundee.
