Whereas in pursuance of 'The Explosives Act, 1875' (in this Order referred to as the Act), an Order in Council was made on the fifth day of August one thousand eight hundred and seventy-five, classifying explosives, and whereas by the one hundred and sixth section of the Act it is provided that Her Majesty from time to time, by Order in Council, may define for the purposes of this Act the composition, quality, and character of any explosive, and may classify explosives.

Now therefore, in pursuance of the above- ignition s mentioned provisions of the Act, Her Majesty is firework.

pleased, by and with the advice of Her Privy Council, to order as follows:—

The portion of the said Order in Council made on the fifth day of August one thousand eight hundred and seventy-five relating to Class 7 (Firework Class) shall be deemed to be repealed, and in lieu thereof the following shall be deemed to be substituted:—

#### Class 7 (Firework Class).

The term 'Firework' comprises firework composition and manufactured fireworks.

Division 1. The term 'firework composition' means any chemical compound or mechanically mixed preparation of an explosive or inflammable nature which is used for the purpose of making manufactured fireworks and is not included in the former classes of explosives, and also any star and any coloured fire composition subject to the proviso hereinafter set forth.

Division 2. The term 'manufactured firework' means any explosive of the foregoing classes and any firework composition when such explosive or composition is enclosed in any case or contrivance, or is otherwise manufactured so as to form a squib, cracker, serpent, rocket (other than a war rocket), maroon, lance, wheel, Chinese fire, Roman candle, or other article specially adapted for the production of pyrotechnic effects or pyrotechnic signals or sound signals.

Provided that a substantially constructed and hermetically closed metal case containing not more than one pound of coloured fire composition of such a nature as not to be liable to spontaneous ignition shall be deemed to be a 'manufactured firework.'
