LOCAL GOVERNMENT (SCOTLAND) ACT, 1889.
ORDER BY THE BOUNDARY COMMISSIONERS FOR SCOTLAND.

COUNTIES OF LANARK AND RENFREW.

BURGH AND CITY OF GLASGOW AND
BURGH OF RENFREW.

Parishes of Cathcart, Eastwood, Govan, and
Renfrew.

WHEREAS the Parish of Govan is situated partly in the County of Lanark and partly in the County of Renfrew :

And whereas the Burgh and City of Glasgow is situated partly in the County of Lanark and partly in the County of Renfrew :

And whereas the Burgh of Renfrew is situated partly in the County of Lanark and partly in the County of Renfrew, the part in the County of Lanark being in the parish of Govan :

And whereas it appears to us, after communicating with the Authorities and others interested, and after considering all objections to the terms of our Draft Order thereon, to be expedient to alter and adjust the Boundaries of the said Counties of Lanark and Renfrew, and of the Parishes of Eastwood, Govan, and Renfrew in manner hereinafter provided :

Now, therefore, we, the Boundary Commissioners for Scotland, do hereby, in pursuance of

the powers conferred upon us by the Local Government (Scotland) Act, 1889, determine and order as follows :—

- I. Subject to the provisions of the said Act, so much of the Parish of Govan and County of Lanark as is situated within the police limits of the Burgh of Renfrew shall cease to be part of that Parish and of that County, and shall form part of the Parish of Renfrew and of the County of Renfrew.
- II. Subject to the provisions of the said Act, that part of the parish of Govan in the County of Renfrew which is bounded on the east by the boundary of the burgh and City of Glasgow as defined by section four of the City of Glasgow Act, 1891, on the south by the Parish of Eastwood, on the west by the Parish of Abbey, and on the north partly by the Parish of Abbey and partly by the existing boundary between the County of Lanark and the County of Renfrew shall cease to be part of the Parish of Govan, and shall form part of the Parish of Eastwood.
- III. Subject to the provisions of the said Act, so much of the Burgh and City of Glasgow (as defined by section four of the City of Glasgow Act, 1891) as is situated in the County of Renfrew shall cease to be part of that County, and shall, except as hereinafter provided, form part of the County of Lanark.
- IV. Subject to the provisions of the said Act, the Parish of Govan as altered in area by this Order shall, except as hereinafter

- provided, be wholly included in and form part of the County of Lanark.
- V. The present County Councillors for the police burgh of Kinning Park shall cease to act as members of the County Council of Renfrew, and shall, until the next election of a County Council, be additional members of the County Council of Lanark, with all the powers, rights, and duties of County Councillors for a police burgh.
- VI. For the purposes of Registration of Writs in the Divisions of the General Register of Sasines for Scotland, the following provisions shall take effect:— (a) The portions of the Parishes of Cathcart and Eastwood situated within the boundaries of the Burgh and City of Glasgow as defined by section four of the City of Glasgow Act, 1891, and transferred by Article III. hereof from the County of Renfrew shall be included in and form part of the County of the Barony and Regality of Glasgow: (b) The Parish of Govan as altered in area by this Order shall, notwithstanding Article IV. hereof, continue to be included in the County of the Barony and Regality of Glasgow, and the portions of the said Parish disjoined therefrom by Articles I. and II. hereof shall cease to be part of the said County of the Barony and Regality of Glasgow, and shall form part of the County of Renfrew.
- VII. Nothing herein contained shall affect any action or proceeding instituted, raised, or depending, before any Court, civil or criminal, previous to the date on which this Order comes into operation, and any such action or proceeding may be proceeded with, determined, and followed forth, by diligence or otherwise, as if this Order had not been made.
- VIII. Nothing herein contained shall affect any right secured to the Clerk of the Peace of the County of Renfrew by or under the City of Glasgow Act, 1891.
- IX. All proceedings under the Acts regulating the licensing of Public Houses in Scotland relative to the granting of licenses to endure for the year beginning at Whitsunday 1892 in any district affected by this Order shall take place before the Magistrates to whose jurisdiction such district is by this Order transferred, and shall be competent to them only.
- X. This Order shall come into operation for the purposes of Article IX. hereof as soon as confirmed, and for all other purposes on the 15th day of May 1892.

GLASGOW AND SOUTH-WESTERN RAILWAY (No. 2.)

(Vesting in Glasgow and South-Western Railway Company of Undertaking of Ayrshire and Wigtownshire Railway Company; Vesting in Caledonian Railway Company of Bridge Street Station, Glasgow; Agreements; Additional Capital; Repeal and Amendment of Acts.)

NOTICE is hereby given, that application is intended to be made to Parliament in the ensuing session, for leave to introduce a Bill for the following purposes, or some of them (that is to say):—

To authorise and provide for the vesting in the Glasgow and South-Western Railway Company (hereinafter called "The South-Western Company"), of the undertaking of the Ayrshire and Wigtownshire Railway Company (hereinafter called "the Ayrshire Company"), and all their railways, works, lands, estate, rolling stock, plant and effects, rights, powers, and privileges, including all their rights, powers, and privileges over or in connection with the Stranraer and Portpatrick sections of the Portpatrick and Wigtownshire Joint Line and the East Pier at Stranraer (all of which are included in the expression, the Ayrshire Railway, hereinafter used) upon such terms, and subject to such conditions, and from and after such period, as may have been or may be agreed upon, or as may be prescribed or provided by the intended Act; and to empower the South-Western Company to hold and maintain the Ayrshire Railway as part of their

undertaking, and to put the same into a proper and efficient state of repair.

To provide for the winding up and dissolution of the Ayrshire Company, and for the exercise by the South-Western Company in their own name and under the hands of their own directors, officers, and servants, of the rights, powers, and privileges of the Ayrshire Company, whether with reference to the acquisition of lands, the construction and maintenance of works, the levying of tolls, rates, and charges, or otherwise.

To alter and amend sub-section 9 of section 10 of the Girvan and Portpatrick Junction Railway Act, 1872, with reference to proceedings of the Joint Committee appointed under that Act, and to repeal or amend section 29 of the Portpatrick and Wigtownshire Railways (Sale and Transfer) Act, 1885.

To provide for the affording by the South-Western Company to the London and North-Western Railway Company, and the Caledonian Railway Company, and the Portpatrick and Wigtownshire Joint Committee, of such traffic facilities as may have been or may be agreed upon, or as may be prescribed or provided for by the intended Act.

To repeal and cancel the powers conferred upon the South-Western Company by the Girvan and Portpatrick Junction Railway Act, 1865, to subscribe towards and hold shares in the undertaking by that Act authorised, and to raise capital and apply funds for that purpose.

To authorise and provide for the vesting in the Caledonian Railway Company (hereinafter called "the Caledonian Company") solely as part of their undertaking of Bridge Street Station, Glasgow, now belonging to the South-Western Company and the Caledonian Company jointly, and the lines of railway, works, conveniences, buildings, and other property connected therewith, all lying between Bridge Street on the east, Cook Street on the south, Commerce Street on the west, and Clyde Place on the north, upon such terms and subject to such conditions, and from and after such period, as may have been or may be agreed upon, or as may be prescribed or provided by the intended Act.

To make such provision and to confer upon the South-Western Company and the Caledonian Company, and the Ayrshire Company, respectively, all such powers as may be necessary for giving effect to all or any of the objects aforesaid or incidental thereto, and to enable those Companies, or any of them, to enter into and carry into effect agreements with reference thereto, and to confirm and give effect to any agreement which may have been or may be made prior to the passing of the intended Act.

To enable the South-Western Company and the Caledonian Company to enter into and carry into effect agreements with reference to the sale, purchase, or exchange by, to, or between such Companies respectively, of any lands or property jointly or separately belonging to them, and to confirm or give effect to any such agreements which may have been or may be made prior to the passing of the intended Act.

To empower the South-Western Company and the Caledonian Company respectively to increase their capital for the purposes aforesaid, and for such other purposes as may be authorised by the intended Act, and for those purposes to raise further money by the creation of new shares or stock, with or without a guaranteed or preference

dividend or other rights or privileges attached thereto, and by borrowing, and by the creation of debenture stock, or by any of such means, and to apply to all or any of such purposes any capital or funds belonging to the South-Western Company and the Caledonian Company respectively, and to make applicable to any such additional capital raised by the Caledonian Company the provisions of the Caledonian Railway (Conversion of Stock) Act, 1890.

To vary and extinguish any existing rights or privileges which would interfere with the purposes of the intended Act, and to confer other rights and privileges.

To repeal, vary, alter, amend, and extend, so far as may be necessary for all or any of the purposes aforesaid, the several Acts hereinbefore mentioned or referred to, and also the several Acts following, namely, the Glasgow and South-Western Railway Consolidation Act, 1855, and the several other Acts relating to the South-Western Company; the Caledonian Railway Act, 1845, and the several other Acts relating to the Caledonian Company; the Girvan and Portpatrick Junction Railway Act, 1865, and the Ayrshire and Wigtownshire Railway Act, 1887, and all other Acts relating to the Ayrshire Company or their undertaking.

Printed copies of the Bill will be deposited in the Private Bill Office of the House of Commons, when leave has been obtained to introduce the same.
