THE MERCANTILE BANK OF INDIA LIMITED.

(Further Powers to The Mercantile Bank of India Limited; Powers and Provisions with respect to the Creation and Issue of Silver Capital; Amendment of Memorandum and Articles of Association of the said Bank.)

3. To make provision with respect to the amount of Silver Capital to be retained as Reserve Capital, and to alter clause 6 of the Memorandum of Association accordingly.

4. To make all such provisions as are or may be incidental to or necessary or expedient for

any of the purposes of the intended Act.

5. The Bill will vary and extinguish all rights and privileges which would in any way interfere with its objects, and will confer other rights and privileges, and will, if and so far as may be necessary, repeal, alter, extend, and enlarge the Memorandum of Association and the Articles of Association of the Company, dated respectively the 30th day of November 1892.
