

# FACTORY AND WORKSHOP ACTS, 1878 to 1891.

Whereas by Section 8 (1) of the Factory and Workshop Act, 1891, it is enacted that—

'Where the Secretary of State certifies that in his opinion any machinery or process or particular description of manual labour used in a factory or workshop (other than a domestic workshop) is dangerous or injurious to health, or dangerous to life or limb, either generally or in the case of women, children, or any other class of persons, or that the provision for the admission of fresh air is not sufficient, or that the quantity of dust generated or inhaled in any factory or workshop is dangerous or injurious to health, the Chief Inspector may serve on the occupier of the factory or workshop a notice in writing, either proposing such special rules or requiring the adoption of such special measures as appear to the Chief Inspector to be reasonably practicable, and to meet the necessities of the case.'

Now I, the Right Honourable Herbert Henry Asquith, one of Her Majesty's Principal Secretaries of State, do hereby certify that in my opinion such processes carried on in factories and workshops, or parts thereof, as are named in the Schedule hereunder, are dangerous or injurions to health.

# CIVIL SERVICE COMMISSION, June 22, 1894.

The Civil Service Commissioners, with the concurrence of the Lords Commissioners of Her Majesty's Treasury, hereby give notice that in the Regulations respecting Temporary Copyists in Public Departments, the following alterations have been made, viz.:—

In the Regulations numbered 14, the words 'except in conformity with Regulations 12, 13, and 17' have been substituted for the words 'except in conformity with Regulations 12 and 13.'

And the following Regulation, numbered 17, has been added :--

17. If any case of infections disease should occur in the house where a Copyist is living, he must immediately report the fact to the Officer under whom he is employed, and must, if required, at once discontinue his attendance. In cases of such enforced absence from his employment, it is in the discretion of the Head of the Department in which he has been serving to allow the Copyist full pay for seven hours a day for the period for which it is medically certified that his attendance at the office would be likely to be dangerous to his colleagues.
