I beg leave to acquaint you, that in the execution of your orders, per fignal, to look out S. W. I discovered and captured, after a chace of two hours, Le Desespoir French privateer, a lugger, mounting two guns, pierced for ten, commanded by Jean Delaballe, and manned with 28 men; belonging to Hodierne, which she had left only three days before, and I have the satisfaction to add, had made no captures.
