#### POST OFFICE SAVINGS BANK REGULATIONS, 1894.

Whereas under and by virtue of the Post Office Savings Bank Act, 1861, and of all powers and authorities enabling him in that behalf, the Postmaster-General, with the consent of the Treasury, made the Post Office Savings Bank Regulations, 1893 (hereinafter referred to as 'the Principal Regulations').

And whereas owing to the passing of the Finance Act, 1894, certain of the provisions of 'the Principal Regulations' in relation to the payment of duties upon deposits standing in the Post Office Savings Bank in the names of deceased depositors are no longer in accordance with the present law in relation to the payment of duties on the property of deceased persons, and it is therefore expedient to amend 'the Principal Regulations' in relation to the matters aforesaid.

Now I, Her Majesty's Postmaster-General, under and by virtue of all powers and authorities 

#### Title.

1. These Regulations may be cited as the Post Office Savings Bank Regulations, 1894, and these and 'the Principal Regulations' may be cited as the Post Office Savings Bank Regulations, 1893 and 1894.

#### Construction.

2. These Regulations shall be read and construed as one with 'the Principal Regulations,' and shall take effect accordingly.

#### Repeal.

3. Regulation 74 of 'the Principal Regulations' is hereby repealed.

#### Estate Succession and Legacy Duties.

4.—(1) If the total property of any deceased depositor exceeds £100, after deduction of debts and funeral expenses, any sum which may under these Regulations be paid to a survivor in the account (not being a Trustee) whose name has been added to the account at the request of such deceased depositor, or otherwise than to the legal personal representative of the depositor, shall, not-withstanding such payment, be for the purposes of Estate Duty treated as passing under the will or intestacy of the deceased depositor.

(2) The Postmaster-General shall, before making any payment in respect of deposits standing to the credit of a deceased depositor (either alone or jointly with any other depositors (not being a Trustee) whose name has been added to such account at the request of such deceased depositor), to any one but the legal personal representative of such deceased depositor, require a Declaration by the claimant, or one of the claimants, or by the survivor, or survivors in the account (or other evidence to the Postmaster-General's satisfaction), that the total estate of the deceased depositor, including the amount of such deposits, does not, after deduction of debts and funeral expenses, exceed the value of  $\pounds 100$ .

(3) In every such case as aforesaid, where the total estate of the deceased depositor, including such deposits, but after deduction of debts and funeral expenses, exceeds £100, the Postmaster-General shall, before making any payment to any survivor in the account, or to any person other than the legal personal representative of the deceased depositor, require production of a certificate from the Commissioners of Inland Revenue of the payment of the Estate Duty, and of a duly stamped receipt for the Succession or Legacy Duty, payable in respect of such deposits, or of a certificate stating that no Succession or Legacy Duty is payable.

#### **Operation of Regulations.**

5. These Regulations shall come into operation on the day of the advertisement thereof in the London Gazette, and shall apply to all depositors dying on or after the 2nd day of August 1894.

#### WHITEHILLS HARBOUR PROVISIONAL ORDER.

Incorporation of Harbour Commissioners; Provisions for Appointment and Election of Commissioners; Limits of Harbour; Acquisition of Land; Construction of New Harbour; Vesting of Existing and of New Harbour in Commissioners; Construction of Works; Rates; Borrowing and other Powers.

NOTICE is hereby given, that application is intended to be made to the Board of Trade, on or before the 23rd day of December next, by George Findlay, Merchant; Henry Lovie, Fisherman; George Watson, Fishcurer; George Watson, 'Hallie,' Fisherman; Alexander Dey, Blacksmith; George Lovie, Retired Ship Master; George Downie, Fishcurer; James George Murray, Carpenter; and Henry John Watson, Merchant, all of Whitehills, in the County of Banff (hereinafter referred to as 'the Promoters') for a Provisional Order, pursuant to the provisions of 'The General Pier and Harbour Act, 1861,' and 'The General Pier and Harbour Act, 1861, Amendment Act,' for a Provisional Order (hereinafter referred to as 'The Order'), to confer the powers and effect the objects hereinafter mentioned, or some of them, viz.:—

To nominate, appoint, and incorporate a body of Harbour Commissioners by the name or style of 'The Whitehills Harbour Commissioners' (hereinafter referred to as 'the Commissioners') for the purposes of the Order and for carrying the same into effect, and exercising the powers and privileges and fulfilling the duties thereby area of such piers or quays. The piers or quays conferred and imposed.

To provide the proper means for the due election from time to time of fit and proper persons to the office of Commissioners.

To constitute and appoint the Commissioners and their successors in office, the Harbour and proper Pilotage Authority for the existing harbour, and the new or extended harbour and works under the Order, and to grant to the Commissioners all the powers and privileges authorised by the Merchant Shipping Acts, 1854 to 1889.

To define the limits of the harbour within which the Commissioners shall have and exercise their power of a Pilotage and Harbour Authority, and have power to levy rates for the purposes of the Order. The limits within which the Commissioners shall have authority, and which shall be deemed the limits to which the Order and the power to levy rates extend, shall comprise the present harbour at Whitehills and the new harbour to be constructed under the Order, and all works, accommodations, and conveniences connected therewith, and all additions to, and improvements on, the harbour works from time to time to be made by the Commissioners, and the area below the high water mark, bounded by the following imaginary lines :--(1) By a line commencing at a point on the sea-shore at high water mark distant 366 yards or thereby west from the southern angle of the east quay at the entrance to the existing harbour of Whitehills, and extending in a northerly direction for a distance of 320 yards or thereby; (2) by a line commencing at a point on the sea-shore at high water mark distant 350 yards or thereby east from the said southern angle of the east quay of the existing harbour of Whitehills, and extending in a northerly direction for a distance of 266 yards or thereby; and (3) by a line connecting the northern extremities of the above described imaginary lines.

The high water mark above referred to to be held to be the high water mark of equinoctial spring tides or such other limits as may be sanctioned by the Board of Trade, and described in the Order.

To empower the Commissioners to purchase or otherwise acquire land and other property by agreement for the purposes of the harbour and works to be sanctioned by the Order, and to erect such works accordingly.

The works so to be authorised are as follows :-(1) The construction of a pier or quay, commencing at a point on the side of the road leading from Whitehills to Blackpots, distant about 509 feet in an east-north-easterly direction from the north corner of the buildings situated to the north of Watson's Curing Yard, and extending in a north-westerly direction for a distance of 170 feet, thence in a south-west by westerly direction for a distance 363 feet or thereby, and thence in a north-westerly direction for a distance of 211 feet, and there terminating.

(2) A pier or jetty, commencing at a point at the side of the road leading from Whitehills to Blackpots, distant about 230 feet measured in an east by southerly direction from the north corner of the buildings situated to the north of Watson's Curing Yard, and extending in a north-westerly direction for a distance of 207 feet or thereby, and there terminating.

(3) The excavation and removal of rocks, sand, or gravel in the entrance channel and within the '

will be solid.

To alter and improve the existing quay and dockage, and dredge or otherwise deepen the harbour and entrance thereto, and also to alter and divert watercourses, roads, and drains for the purpose of existing and intended new works, and to make and maintain in connection therewith all necessary and proper embankments, quays, jetties, roads, tramways, bridges, approaches, lights, wharves, sheds, warehouses, buoys, beaches, and other works and conveniences.

To deviate laterally in the construction of the said intended new works, within the limits of deviation shown on the plans deposited with reference to the Order, and vertically to the extent to be provided for in the Order.

To vest in the Commissioners in such manner as may be prescribed in the Order the existing quay or pier, harbour, and works at Whitehills aforesaid, and the works and conveniences intended to be constructed as aforesaid for the purposes of the Order, and to enable the Promoters and all other necessary parties to make and enter into all such agreements, deeds, or conveyances as may be necessary for this purpose on such terms as may be provided in the Order.

The said existing harbour and works and the intended new works are and will be situated in the Parish of Boyndie, in the County of Banff, and upon the sea-shore and bed of the sea adjoining thereto in and ex adverso of the said County of Banff.
