FISHERY BOARD FOR SCOTLAND. **REGULATIONS FOR PINING CURED WHITE** HERRINGS.

NOTICE.

WHEREAS by 14 and 15 Vict. cap. 26, entitled 'An Act to amend the Acts relating to the British White Herring Fishery,' power was conferred on the Commissioners for the Herring Fishery to regulate and fix the period which shall intervene between the day on which White Herrings, whether bung packed or repacked, shall be salted, and the day on which the burnels containing such Herrings whether hung packed barrels containing such Herrings, whether bung packed or repacked, shall be entitled to be branded, such period being not more than fifteen clear days after the salting being not more than fifteen clear days after the salting of the same; and whereas, by 45 and 46 Vict. cap. 78, entitled 'An Act to establish a Fishery Board for Scot-land,' all the powers and duties conferred on the Commissioners for the Herring Fishery by the Herring Fishery Acts and the Sea Fisheries Acts, 1868 to 1875, and any Order in Council following thereon, with certain specified exceptions, were vested in the Fishery Board for Scotland thereby established :

Notice is hereby given that the Fishery Board for Scotland have resolved that, on and after the date hereof, (1) barrels or half barrels containing White hereof, (1) barrels or half-barrels containing White Herrings, whether bung packed or repacked, presented for the La. Full, Full, or Mat. Full Brands, shall be entitled to be officially branded if the said Herrings shall have lain ten free days in salt, exclusive of the day of cure and the day on which the barrels or half-barrels were completely packed up for branding, if otherwise found entitled thereto; and (2) barrels or half-barrels containing White Herrings, whether bung packed or repacked, presented for the Spent or Mattie Brands, shall be entitled to be officially branded if the said Herrings shall have lain eight free days in salt, exclusive of the day of cure and the day on which the barrels or half-barrels were completely packed up for branding, if half-barrels were completely packed up for branding, if otherwise found entitled thereto.
