### PRESENTATIONS.

The privilege of making Presentations to The Queen at a Drawing Room is restricted to those Ladies who have themselves been previously presented to Her Majesty, and who are themselves present at the Drawing Room.

Under such circumstances a Lady has the privilege of presenting one Lady only at a Drawing Room in addition to her Daughters or Daughters-in-law.

This restriction does not apply to Ladies who, from official position or other circumstances, are specially privileged to make Presentations to Her Majesty.

The Lady who proposes to present another must send in writing the name of such Lady to the Lord Chamberlain's Office, not later than two days previous to the Drawing Room, in order that the Lord Chamberlain may submit the name to

Her Majesty, when, if it be approved, Presentation Cards will be forwarded.

Printed Forms for this purpose can be obtained at the Lord Chamberlain's Office.

It is particularly requested that the names of the Lady to be presented be very distinctly written on the Presentation Cards to be delivered to the Lord Chamberlain at the Drawing Room, in order that there may be no difficulty in announcing them to The Queen.

The number of Presentations is limited to 200 at the Drawing Room.

It is not expected that Gentlemen will present themselves at the Drawing Room, except in attendance on the Ladies of their families.

Any Gentleman who under these circumstances should desire to be presented to The Queen will observe the same regulations as are in force for Her Majesty's Levees.

# ADJUSTMENT ORDER No. I. (CITY PARISH OF EDINBURGH.)

WHEREAS a new Parish, to be called the City Parish of Edinburgh, will be constituted on the 15th day of May 1895, by my Order, published in the Edinburgh Gazette of the 15th March 1895 (No. XXI.):

And whereas all questions of compensation or adjustment consequential on the said Order were expressly reserved:

And whereas it is desirable to make provision consequential on the said Order regarding the office of Inspector of Poor in the said new Parish:

And whereas the said new Parish will include, inter alia, the whole of the now existing City Parish of Edinburgh and the greater portion of the St. Cuthbert and Canongate Combination:

Now, therefore, I, the Right Honourable Sir George Otto Trevelyan, Baronet, Her Majesty's Secretary for Scotland, do, in virtue of the powers conferred upon me by the Local Government (Scotland) Acts, order as follows:—

- 1. It shall be lawful for the Parish Council of the said new Parish to grant a superannuation allowance, not exceeding Five hundred pounds sterling per annum, to the Inspector of Poor of the now existing City Parish of Edinburgh, on and from the date of his retirement from the office of Inspector.
- 2. On and from such date the existing Inspector of Poor of the St. Cuthbert and Canongate Combination shall hold office as Inspector of Poor of the new City Parish of Edinburgh, subject to the provisions of the Statutes regulating such office.

REVISION OF THE BOUNDARIES OF THE WARDS OF THE BURGH.
