LOCAL GOVERNMENT (SCOTLAND) ACTS. Alteration of Parish Areas.

#### PROPOSED ORDER No. XXXII.

#### PARISHES OF STRANRAER, INCH, AND LESWALT.

WHEREAS it has been represented to me by the Parochial Board of the Parish of Stranraer that I should issue an Order under section 51 of the Local Government (Scotland) Act, 1889, and section 46 of the Local Government (Scotland) Act, 1894, detaching from the Parish of Inch and the Parish of Leswalt respectively the portions of the said Parishes situated within the Police and old Parliamentary Boundaries of the Burgh of Stranraer;

And whereas, after consulting with the Authorities concerned, and causing a local inquiry to be held, I am of opinion that it is expedient to give effect to the said representation;

Now, therefore, I, the Right Honourable Sir George Otto Trevelyan, Baronet, Her Majesty's Secretary for Scotland, do, in virtue of the powers conferred on the Secretary for Scotland by the Local Government (Scotland) Acts, order as follows :---

1. The foresaid portion of the Parish of Inch and the foresaid portion of the Parish of Leswalt shall cease to be parts of the Parishes of Inch and Leswalt respectively, and shall be joined to and form part of the Parish of Stranraer.

2. The Parish Council of Stranraer shall assume responsibility for, and shall relieve the Parish Council of Inch and the Parish Council of Leswalt of all advances which the latter bodies may respectively be called upon to make for or on account of, any pauper whose claim is derived (1) from birth in the said portions of the Parishes of Inch and Leswalt prior to the 15th day of August 1895, or (2) from residence for the statutory period in the said portions of the Parishes of Inch and Leswalt prior to the 15th day of August 1895.

3. The Parish Councillors elected for the foresaid portion of the Parish of Inch and the Parish Councillors elected for the foresaid portion of the Parish of Leswalt shall cease to be Parish Councillors of the said Parishes respectively, and shall become Parish Councillors of the Parish of Stranraer.

4. Nothing herein contained shall affect the rights of Creditors or of persons having vested interests, and all questions of adjustment consequential on this Order are expressly reserved.
