\*Section 8 of the Corn Returns Act, 1882, provides that where returns of purchases of British Corn are made to the Local Inspector of Corn Returns in any other measure than the imperial bushel, or by weight or by a weighed measure, that Officer shall convert such returns into the imperial bushel, and in the case of weight or weighed measure the conversion is to be made at the rate of sixty imperial pounds for every bushel of wheat, fifty imperial pounds for every bushel of barley, and thirty-nine imperial pounds for every bushel of oats.

#### BURGH OF KIRRIEMUIR.

#### NOTICE.

N an Application presented to the Sheriff of Forfarshire by the Commissioners of the Burgh of Kirriemuir, incorporated and acting under the provisions of the Burgh Police (Scotland) Act, 1892, craving his Lordship to Revise and Extend the Boundaries of the said Burgh, by marking out, defining, and specifying the same to be as comprehended within a line drawn as follows:—

From the footbridge across the Gairie Burn at Lochmill behind the house occupied by the Reverend John A. Murray in a straight line in a north-easterly direction across the Glengate Road and a field on the Kinnordy Estate and the Walker Flat Road to the north-west

corner of Stiven's Lands; thence along the north-west boundary of Stiven's Lands for a distance of 167 yards; thence eastward in a straight line across the land of Hillhead to the south-east corner of the land of Hillhead at the public road or street known as The Roods, and a at the public road or street known as The Roods, and a continuation of the same straight line eastwards acrossafield belonging to Gordon's Trustees till it reaches the middle of the Hill Road; thence along the middle of the Hill Road to the north-west corner of the Cemetery; thence along the north boundary of the Cemetery and the boundary of the Quarry Hill Wood on the north, east, and south sides thereof to the Quarry Road; thence southwards along the east side of the Quarry Road to the junction of that road with the Brechin Road; thence slong the warch between Lieden and the Road; thence along the march between Lisden and the Estate of Kinnordy and a straight line in continuation of the said march across the Kirriemuir Branch of the Caledonian Railway and land, part of the Estate of Glasswell, till it meets the Gairie Burn, and along the south side of the said burn in a south-westerly direction to the east boundary of the ground leased by the Com-missioners of the Burgh of Kirriemuir from the Estate of Glasswell; thence southward for a distance of 33 yards along the said east boundary, and then westward along the south side of the Service Road for the manure depôt to the boundary of the land belonging to the said Commissioners; thence southwards in a straight line to the middle of the old road from Kirriemuir to Forfar near to the junction of the road to Denmill Farm; thence north-westward along the middle of the said old Kirriemuir and Forfar Road to the Gairie Burn, which it follows westward along the south side thereof to the north-east corner of the public commonty or bleaching green situated on the south side of the said burn; thence along the east boundary of the said commonty or bleaching green to the south-east corner thereof; thence bleaching green to the south-east corner thereof; thence in a straight line to the middle of the highway from Kirriemuir to Forfar at a point 95 yards south-eastward from the old Turnpike Tollhouse; thence westward along the middle of the said highway and along the middle of the old road leading to the Kirriemuir and Lumley Den Highway, and crossing the said highway and continuing, westward along the middle of the old road leading to the Westmuir to a point opposite the south-west corner of the Southmuir; thence north-westward along the west boundary of the Southmuir to the north-west corner of the Mortar Holes; thence north-eastward along the north side of the Mortar Holes and a straight line to the south-west corner of the gasworks, and along the north-west side of the gasworks to the Gairie Burn; thence along the south-west side of the Gairie Burn in a north-westerly direction to the east point of the portion of the public park situated on the south and west side of the said burn; thence along the south-west and north boundaries of the said portion of the public park till it meets the Gairie Burn which it follows on the north-west side thereof in a north-easterly direction till it joins the point at the footbridge first described; all as the above boundary is delineated and coloured pink on the Sheets of the Ordnance Survey produced with the said Application, and the existing. Burgh Boundary where it differs from the above boundary in the said Sheets of the Transfer of the said Application. is coloured green on said Sheets,—His Lordship was pleased to pronounce the following Deliverance:—
