LOCAL GOVERNMENT (SCOTLAND) ACT, 1889. ORDER BY THE SECRETARY FOR SCOTLAND.

CHANGE OF NAME OF PARISH OF MONZIE.

WHEREAS by section 51 of the Local Government (Scotland) Act, 1889, it is provided that, on the representation of a County Council or of a Town Council, the Secretary for Scotland may, at any time after the expiry of the powers of the Boundary Commissioners, by order, provide for all or any of the things mentioned in the said section, namely (among others):—

- '(d) For uniting several Parishes or parts of Parishes into one Parish, or annexing one or more of such Parish or Parishes or parts of Parishes to a larger Parish; and any Parish so formed by a union of Parishes or parts of Parishes, or enlarged by annexation, shall for all purposes be deemed to be one Parish; ...
- '(f) For the proper adjustment and distribution of the powers, property, liabilities, debts, officers, and servants of any Local Authority, consequential on any

- consolidation, alteration of boundaries,
 or other act done in pursuance of this
 section; and
- '(g) Generally for doing any matter or thing
 'whatever, whether similar or not to those
 above mentioned, which may be required
 'or be expedient for the proper carrying
 'into effect the purposes of this Act,
 'and the settlement of local differences.'

And whereas the County Council of the County of Perth have represented to me that the Parish of Monzie should cease to bear that name, and should in future be known as the Parish of Logicalmond:

And whereas I am of opinion that it is expedient to give effect to the said representation:

Now, therefore, I, the Right Honourable Alexander Hugh, Lord Balfour of Burleigh, Her Majesty's Secretary for Scotland, do, in virtue of the powers conferred on me by the section aforesaid, order as follows:—

- 1. The Parish now known as the Parish of Monzie shall cease to bear that name, and shall be called the Parish of Logicalmond.
- 2. Nothing herein contained shall affect the rights of Creditors or of persons having vested interests.
- This Order shall take effect on the 1st day of January 1896.

DUNDEE HARBOUR.

(Borrowing and Raising of Additional Money, and Securities therefor, including Creation and Issue of Debenture Stock, and Provisions relative thereto and to the Redemption, Transfer, and Discharge thereof; Investment of Trust Funds; Conversion of Existing Securities; Reserve Fund and Application thereof; Alteration of Tolls, Rates, Dues, and Charges, and of Exemptions from and Regulations regarding same; Additional Bye-Laws and Provisions for Regulation of Tay Ferries and Harbour, and of Persons Employed therein, and of Small Boats and Steam Boat Traffic, and for Preventing Betting within Harbour, and as to Lights and Lighting of Harbour, and the Regulation of Traffic on and over the Tay Ferries within the Harbour Limits; Extending Police Jurisdiction to Crimes and Offences Committed within Harbour; Application of Funds and Revenues; Incorporation, Repeal, Amendment, and Extention of Acts; other Powers and Purposes.)

of the Harbour of Dundee (hereinafter called "the Trustees") intend to apply to Parliament in the next Session for a Bill to alter, extend, and amend the following Acts or some of them, or some parts or portions thereof; that is to say, "The Dundee Harbour Consolidation Act, 1875;" "The Dundee Harbour and Tay Ferries Act, 1873;" "the Dundee Harbour and Tay Ferries Act, 1889;" and "the Dundee Harbour (Amendment) Act, 1892" (all hereinafter called "the Special Acts"), and also to confer the powers and effect the objects hereinafter mentioned, or some of them, that is to say:—

1. To authorise the Trustees to exercise all unexhausted powers of borrowing money contained in the Special Acts, or any of them, for the purposes of the Bill and of the Special Acts, and also to borrow or raise additional money for the purposes of the Special Acts and the Bill, and for the execution, maintenance, and improvement of the Works of the Harbour of Dundee and the Tay Ferries (all hereinafter called "the Harbour"), and for the general purposes of the undertaking of the Trustees, on the security of the tolls, rates, dues, and charges leviable, or to be levied by the Trustees, and the other revenues and property of the Trustees, and to grant and issue Bonds, Mortgages, or Assignments, and other Securities for borrowed money, and to provide for the redemption, transfer, and discharge of any such Bonds, Mortgages, Assignments, or other Securities, and also of any existing Bonds, Mortgages, Assignments, or other Securities, and to define, or to alter and vary the rights, privileges, and priorities of the present or any future holders of the Bonds, Mortgages, Assignments, or other Securities granted by the Trustees, or to be granted under the authority of the Special Acts, or the Bill.

2. To provide that the whole or any portion of any money to be hereafter raised or borrowed by the Trustees may be provided for, borrowed, or raised by the creation and issue of Debenture Stock of the Trustees, in the manner provided in and subject to the like conditions, rules, and regulations as are set forth in "the Dundee Harbour and Tay Ferries Act, 1889," applicable to the Debenture Stock authorised to be created and issued under that Act, or otherwise as the Bill may provide.

3. To make provision for the exemption from Stamp Duty of transfers of the Debenture Stock of the Trustees, upon such terms and subject to such payments by way of composition as may be prescribed by the Bill.

- 4. To authorise the Investment of Trust Funds in the securities existing or future of the Trustees, and to exempt the Trustees from liability in respect of notice of any Trust affecting money so invested.
- 5. To make new and additional provisions with respect to the repayment of the existing Loans, Mortgages, Assignments, and Securities of the Trustees, and any additional money to be borrowed or raised by the Trustees, and to provide for the conversion of all or part of such existing Loans, Mortgages, Assignments, and Securities into Debenture Stock of the Trustees.
- 6. To empower any person holding any Mortgage, Bond, Assignment, or Security of the Trustees, and being a person enabled by the "Lands Clauses Consolidation (Scotland) Act, 1845" (Section 7), to sell land under that Act, to consent to the conversion of such Mortgage, Bond, Assignment, or Security into Debenture Stock of the Trustees.
- 7. To empower the Trustees to set aside, annually or otherwise, a specified or other percentage of their gross annual Revenues as a Reserve Fund for meeting and providing against accidents to works, or compensation for injuries to persons injured by accidents or default, and for meeting any other contingencies, and to accumulate and invest such Reserve Fund, and manage, administer, and apply the same as the Trustees may think expedient or as the Bill may prescribe.
- 8. To vary and alter the Tolls, Rates, Dues, and Charges, or some of them, leviable or levied by the Trustees; and to provide for modifications thereof as regards vessels and goods in vessels making a number of voyages to and from the Harbour in any one year, or only discharging part cargo, or discharging goods on through Bills of Lading from foreign ports intended for places beyond Dundee, or otherwise as the Bill may prescribe, and to modify and alter reductions on Tolls, Rates, Dues, and Charges applicable to such vessels or some of them, and such goods or some parts thereof; or to repeal the said Tolls, Rates, Dues, and Charges in whole or in part, and to levy new decreased or increased Tolls, Rates, Dues, and Charges at and in respect of the Harbour, and the Docks, Works, Wharves, Jetties, Conveniencies, and Machinery and Accommodations therewith connected, already made and provided, or to be made and provided.
- 9. To alter, decrease, or increase the Rates and Dues, or some of them, authorised by Sections 6 to 14, both inclusive, of "the Dundee Harbour (Amendment) Act, 1892," and the Schedules of Rates therein referred to and annexed to the said Act, and the exemptions and regulations contained therein, and to impose and levy new or additional Tolls, Rates, Dues, and Charges on Vessels and Boats and Goods, Articles, Animals, and Things, and the Owners and Consignees thereof, and to confer, vary, or extinguish exemptions in whole or in part from payment of Tolls, Rates, Dues, and Charges.
- ro. To authorise the Trustees to alter, extend, and improve the Lights and Lighting of the Harbour, including the Tay Ferries, and to provide, lay, and maintain Gas Buoys and Electric or other Cables and Apparatus within the Harbour, for the purposes of and applicable to such Lights and Lighting.
- 11. To authorise the Trustees to make, publish, and enforce additional Bye-Laws with respect to

the Tay Ferries within the Harbour limits, and the maintenance, use, and management of the Harbour and its Docks, Locks, Slips, Quays, Roads, Streets, Wharves, Jetties, Warehouses, Cranes, Lights and Lighting, and other Property and Machinery, and with respect to dredging for Mussels or other Fish or for any other purpose near to any Cable or other apparatus of the Trustees, and also with respect to all persons frequenting the Harbour, or working or employed within the limits thereof, and to prohibit all persons from Betting or making or settling Bets on or within any part of the Harbour Works; and with respect to the use and management of Small Boats and Steam Boat traffic on the River Tay within the limits of the Harbour, and the carriage or conveyance of carcasses of animals or offensive matter of any kind on the Steam Ferry Boats or other Boats of the Trustees on or over the Tay Ferries or the Harbour generally, and to regulate such carriage or conveyance and the use and management of such Small Boats and Steam Boat traffice; or to authorise the Trustees to deal with and regulate all or any such matters and objects and otherwise as the Bill may define and prescribe.

- 12. To extend the provisions of Sections 183, 184, and 185 of "The Dundee Harbour Consolidation Act, 1875," as amended by section 25 of "The Dundee Police and Improvement Consolidation Act, 1882," and the jurisdiction of the Police Magistrates of Dundee, to ordinary crimes and offences committed within any part of the Harbour as limited and described in the said first-mentioned Act.
- 13.
