<sup>\*</sup>Section 8 of the Corn Returns Act, 1882, provides that where returns of purchases of British Corn are made to the Local Inspector of Corn Returns in any other measure than the imperial bushel, or by weight or by a weighed measure, that Officer shall convert such returns into the imperial bushel, and in the case of weight or weighed measure the conversion is to be made at the rate of sixty imperial pounds for every bushel of wheat, fifty imperial pounds for every bushel of barley, and thirty-nine imperial pounds for every bushel of oats.

#### ABERDEEN DISTRICT TRAMWAYS.

(Construction of Tramways and Works; Gauge; Narrow Spaces; Breaking up and interference with Streets, etc.; Motive Powers; Tolls; Agreements with Town Council of Aberdeen; Application of Funds; Alteration, Amendment, Repeal, and Incorporation of Acts; and other purposes.)

District Tramways Company (in this notice called "the Company") intend to apply to the Board of Trade for a Provisional Order, to be confirmed by Parliament in the ensuing session, for the following or some of the following among other purposes (that is to say):—

1. To enable the Company to make, lay down, form, and maintain, work, and use the tramways hereinafter described, or some of them, with all necessary and proper rails, plates, sleepers, junctions, crossings, passing places, works, appliances, machinery, and plant necessary or convenient for the working of the same by animal or mechanical power (that is to say):—

Description of New Single Line of Tramways in Queen's Road West, Queen's Gate, and Queen's Road:— Tramway No. 1.—Situate wholly in the City Parish, and City and Royal Burgh and County of Aberdeen, commencing at a point in Queen's Road West 14 feet or thereabouts East of the centre of the West boundary wall of Bayview House, and proceeding thence in an Easterly direction along Queen's Road West, Queen's Gate, and Queen's Road for a total distance of 4 furlongs 1.33 chains or thereabouts, terminating in the latter street by a junction with Tramway No. 2 after described, at a point 106 feet or thereabouts West of the centre of lamp pedestal situated in the centre or thereabouts of Queen's Cross.

The proposed line of Tramway No. r will be laid along the centre of the respective roads or streets along which it is intended to pass, and will consist of a single line of tramway, except that at the place next hereinafter specified the tramway will consist of a double line.

(A) From the commencement of the tramway before described to a point 150 feet or thereabouts Eastwards of the commencement.

Description of New Double Line of Tramways in Queen's Road, Queen's Cross, and Albyn Place:—

Tramway No. 2.—Situate wholly in the City Parish, City and Royal Burgh and County of Aberdeen.

A double line of tramway, forming a passing place, commencing by a junction with Tramway No. 1 before described at a point 106 feet or thereabouts West of the centre of the lamp pedestal situated in the centre or thereabouts of Queen's Cross, and thence proceeding in an Easterly direction along Queen's Road, Queen's Cross, and Albyn Place for a total distance of 3.36 chains or thereabouts, and terminating in the latter street by a junction with Tramways Nos. 3 and 4 after described, at a point 116 feet or thereabouts East of the centre of the said lamp pedestal.

Description of Double Line of Tramways in lieu of part of existing passing place in Queen's Cross and Albyn Place:—

Tramway No. 3.—Situate wholly in the City Parish, City and Royal Burgh and County of Aberdeen; a double line of tramways, forming a passing place, commencing in Queen's Cross by a junction with the existing passing place there at a point opposite or thereabouts to the North side of Queen's Road and thence proceeding in an Easterly direction along Queen's Cross and Albyn Place for a total distance of 1.62 chains, and terminating in the latter street by a junction with Tramways Nos. 2 and 4 at a point 116 feet or thereabouts East of the centre of the lamp pedestal situated in the centre or thereabouts of Queen's Cross.

Description of Double Line of Tramways in lieu of existing Single Line in Albyn Place and Alford Place:—

Tramway No. 4.—Situate wholly in the City Parish, City and Royal Burgh and County of Aberdeen, commencing in the former street by a junction with Tramways Nos. 2 and 3 at a point 116 feet or thereabouts East of the centre of the lamp pedestal situated in the centre or thereabouts of Queen's Cross, and proceeding thence in an Easterly direction along Albyn Place and Alford Place for a total distance of 4 furlongs 2.96 chains, and terminating by a junction with the existing double line of tramways in Union Street.

The proposed Tramway No. 4 will consist of a double line of tramway, and will take the place of the existing single line of tramway along the same route, and will be laid so that on the North side for a length of 893 yards 1 foot measured in an Easterly direction from the junction of Tramway No. 4 with Tramways Nos. 2 and 3 a less distance than 9 feet 6 inches will intervene between the outside of the footpath and the nearest rail of the tramway.

The intended tramways will be situate wholly in the City Parish and City and Royal Burgh of Aberdeen and County of Aberdeen.

- 2. All the said tramways will be constructed on a gauge of 4 feet  $8\frac{1}{2}$  inches, and it is not intended to run on the said tramways carriages or trucks adapted for use on railways.
- 3. To empower the Company to make, maintain, and alter and remove from time to time, either temporarily or permanently, such crossings, passing places, sidings, loops, junctions, and other works, in addition to those specified herein, as may be necessary or convenient to the efficient working of the tramways or any of them.
- 4. To empower the Company from time to time when by reason of the execution of any work in, or the alteration, widening, or improvement of any street, road, highway, or thoroughfare in which tramways shall be laid, it is necessary or expedient so to do, to alter, remove, or discontinue all or any part of such tramways, and to make and lay down temporarily, in the same or any adjacent street, road, highway, or thoroughfare, a substituted tramway or temporary tramway, or to re-lay in another position any tramways removed from a road or street hereafter widened or improved.
- 5. To empower the Company for all or any of the purposes of the Order to stop up, break up, alter, remove, cross and interfere with, temporarily or permanently, public and private streets, roads, highways, footways, tramways, sewers, drains, gas, water mains, valves, hydrants, pipes, tubes, and telegraph, telephone, electric lighting, and other apparatus.
- 6. To enable the Company for any of the purposes of their tramway undertaking, to purchase or otherwise acquire by agreement, and to take on lease lands and hereditaments, and easements thereover, and to use any lands now belonging to them, and to erect offices, buildings, stables, sheds, carriage, engine, boiler, and dynamo houses, and other conveniences thereon, and to erect and hold offices, buildings, waiting rooms, and other conveniences on any such lands or in any such streets or roads.
- 7. To authorise the Company to use on the tramways carriages drawn or propelled by animals, steam, gas, compressed air, electricity, or any mechanical power or having wheels adapted to run on or in an edged, grooved, or other rail on such tramways.

- 8. To authorise the Company to levy tolls, rates, and charges for the use of the proposed tramways by carriages passing along the same, and for the conveyance of passengers, and other traffic upon the same, and to confer exemptions from tolls, rates and charges.
- 9. To empower the Company, on the one hand, and the Lord Provost, Magistrates, and Town Council of the City, and Royal Burgh of Aberdeen, and other bodies having respectively the control or management of any streets or roads along which tramways are at present laid, or are intended to be laid, or any of them, on the other hand, to enter into and carry into effect contracts or agreements with respect to the alteration of the widths and levels of any such streets or roads, the laying down, maintaining, renewing, repairing, working, and using of the proposed tramways and the existing tramways, and the paving, rails, plates, sleepers, and works connected therewith, and for facilitating the passage of carriages and traffic over and along the same, and to confirm any agreements already entered into, or to be entered into for any of such purposes.
- 10. To provide that the tramways to be authorised by the Order shall be part of the Company's undertaking for all purposes, including the levying of tolls and the working and use thereof by means of mechanical or animal power, or by either of those means.
- 11. To enable the Company to apply for the purposes of the proposed tramways and of the Order any capital or other funds now or hereafter belonging to them or under their control.
- 12. To confer upon the Company all powers, rights, and authorities which are or may have become necessary for carrying the objects of the order into complete and full effect; to vary or extinguish all rights and privileges which would in any way impede or interfere with the objects and purposes of the Order, and to confer other rights and privileges.
- 13.
