DELIVERY OF PARCELS OF TEA FROM CUSTOMS WAREHOUSES FOR TRANS-MISSION BY PARCEL POST TO PLACES OUT OF THE UNITED KING-DOM.

In pursuance of the Rules Publication Act, 1893, Her Majesty's Postmaster-General hereby gives notice that a Warrant, dated the 2nd day of December 1895, has been made on the recommendation of the Commissioners of Her Majesty's Customs, and of Her Majesty's Postmaster-General, by the Commissioners of Her Majesty's Treasury, in pursuance of 'The Post Office (Parcels) Act, 1882,' ordering, directing, and declaring that

on and from the first day of January one thousand eight hundred and ninety-six, Parcels of Tea may, subject to the provisions of the said Warrant, and in accordance with the regulations therein contained, be delivered from Customs Warehouses to the Post Office, for transmission by Parcel Post to places out of the United Kingdom.
