REGULATIONS

TO BE OBSERVED AT THE QUEEN'S DRAWING ROOMS.

By Her Majesty's Command,

The Ladies who propose to attend Her Majesty's Drawing Room are requested to bring with them to the Drawing Room two large cards, with their names clearly written thereon, one to be left with The Queen's Page in Attendance, and

the other to be delivered to the Lord Chamberlain. who will announce the name to The Queen.

PRESENTATIONS.

The privilege of making Presentations to The Queen at a Drawing Room is restricted to those Ladies who have themselves been previously presented to Her Majesty, and who are themselves present at the Drawing Room.

Under such circumstances a Lady has the privilege of presenting one Lady only at a Drawing Room in addition to her Daughters or Daughters-in-law.

This restriction does not apply to Ladies who, from official position or other circumstances, are specially privileged to make Presentations to Her Majesty.

The Lady who proposes to present another must send in writing the name of such Lady to the Lord Chamberlain's Office, not later than two days previous to the Drawing Room, in order that the Lord Chamberlain may submit the name to Her Majesty, when, if it be approved, Presentation Cards will be forwarded.

Printed Forms for this purpose can be obtained at the Lord Chamberlain's Office.

It is particularly requested that the names of the Lady to be presented be very distinctly written on the Presentation Cards to be delivered to the Lord Chamberlain at the Drawing Room, in order that there may be no difficulty in announcing them

to The Queen.

The number of Presentations is limited to 200

at each Drawing Room.

It is not expected that Gentlemen will present themselves at the Drawing Room, except in attendance on the Ladies of their families.

Any Gentleman who under these circumstances should desire to be presented to The Queen will observe the same regulations as are in force for Her Majesty's Levees.

SCOTTISH UNIVERSITIES COMMISSION.

ORDINANCE No. 148.

[GENERAL, No. 33.—REGULATIONS FOR DEGREES IN ARTS, SUPPLEMENTARY TO ORDINANCES Nos. 11 and 44.]

> At Edinburgh, the twenty-fifth day of February eighteen hundred and ninety-six

Whereas on the third day of February eighteen hundred and ninety-two years, the Commissioners under the Universities (Scotland) Act, 1889, issued an Ordinance No. 11, General No. 6, regulating the course of study for graduation in Arts; and whereas on the thirteenth day of December eighteen hundred and ninety-three years, the said Commissioners issued an Ordinance No. 44, General No. 16, supplementary to the said Ordinance No. 11; and whereas it is expedient that the said Ordinances should be amended as hereinafter provided, the Commissioners under the said Act declare and ordain as follows:

I. Section III., sub-section 1, of the first recited Ordinance shall be read and construed as if after the word "Italian" there were inserted the words, "or such other language as the Senatus. Academicus may approve."

II. Section XII. of the first recited Ordinance shall be read and construed as if at the end of the section there were added as a new sub-section the words-"(4) Every candidate shall have obtained " a certificate of his attendance on the class of "Latin or Greek, under sub-sections (1) or (2) of "this section, before he offers himself for examina-"tion in his Honours group of subjects."

III. Candidates for Honours in Philosophy who have included Latin, but not Greek, as one of the subjects in which the standard of examination is the same as that required for the ordinary degree of Master of Legislature of the British Possession hereinafter Arts, shall be deemed to have satisfied the pro-

visions of Section XII., sub-section (2), of the first recited Ordinance, if, before they offer themselves for the Honours Examination in Mental Philosophy. they shall have passed a special examination in translating into Euglish passages from the works of Greek philosophical authors, including passages from the works of such authors not previously prescribed.

IV. This Ordinance shall come into force at the beginning of the first academical year after the date on which it is approved by Her Majesty in

Whereas by the first section of "The Colonial Probates Act, 1892," it is enacted as follows:-

"Her Majesty the Queen may, on being satisfied that the Legislature of any British Posses-" sion has made adequate provision for the recog-" nition in that Possession of Probates and Letters " of Administration granted by the Courts of the "United Kingdom, direct by Order in Council that this Act shall, subject to any exceptions and modifications specified in the Order, apply " to that Possession, and thereupon, while the "Order is in force, this Act shall apply accord-"ingly."

Now, therefore, Her Majesty, by virtue and in exercise of the powers by the above-recited Act in Her Majesty vested, is pleased, by and with the advice of Her Most Honourable Privy Council, to order, and it is hereby ordered, as follows:—

PRESENT,

The QUEEN's Most Excellent Majesty in Council.

Whereas, by an Order in Council made on the fifteenth August one thousand eight hundred and ninety, Her Majesty was pleased to make certain Regulations in order to secure greater uniformity in the rules governing officers of higher rank than the Second Division in the several Departments of the Civil Service:

And whereas it is expedient that similar Regulations, so far as circumstances admit, should be made with respect to pensionable officers in the Consular Service of her Majesty:

Now, therefore, Her Majesty, by and with the advice of Her Privy Council, is pleased to order,

and it is hereby ordered, as follows:-

1. This Order shall apply to all such Consular officers and other persons employed in or in connection with the Consular Service as are entitled to receive superannuation allowances under the Superannuation Acts, 1834 to 1892, and any

Acts amending those Acts.

2. Except in the case of officers appointed by Commission from Her Majesty, every person hereafter certificated by the Civil Service Commissioners for appointment to the Consular Service shall be subject to a strict probation for a period of two years, during which his conduct and capacity in the transaction of business shall be subject to such tests as may be determined by the Secretary of State, and he shall not be finally appointed to the Consular Service unless his probation shall furnish to the Secretary of State satisfactory proof of his fitness to be permanently employed in the Consular Service.

3. Promotion of officers in the Consular Service shall be strictly according to merit, and shall take place subject to the following conditions:—

(1) That there is a vacancy which, under the arrangements sanctioned for the time being by the Commissioners of the Treasury, it is competent for the Secretary of State to fill up;

(2) That the work of the Consular Service

requires such vacancy to be filled up;

(3) That the officer proposed for promotion appears to the Secretary of State to be fit to discharge the duties of the higher office.

4. Every officer hereafter appointed to the Consular Service shall be required to retire at the

age of sixty-five on such pension as by the length of his service he is qualified to receive.

Officers heretofore appointed to the Consular Service shall be required to retire at the age of seventy.

If in any special case the Secretary of State is satisfied that the retirement of an officer would be detrimental to the interests of the public service, he may, with the concurrence of the Commissioners of the Treasury, from time to time extend that officer's employment for such period or periods, not exceeding five years, as he may determine.

Nothing in this Article shall affect any existing power of the Secretary of State to require any officer to retire from the Consular Service if he has ceased, from whatever cause, to be fully competent for the performance of his duties.

5. The Consular Service shall be governed by such instructions as may from time to time be issued by a Secretary of State with the approval, in so far as such instructions may affect the expenditure of public funds, or the receipt and application of fees, of the Commissioners of the Treasury.

6. This order may be cited as "The Consular Service Order in Council, 1896."

PRESENT,

The QUEEN's Most Excellent Majesty in Council.

Whereas under and by virtue of an Order in Council dated the eighth day of February one thousand eight hundred and ninety, and the New Consolidated Tables of Duties referred to in and approved by an Order in Council dated the twenty-fourth day of November one thousand eight hundred and ninety-one, it is provided that there shall be paid for every ship, whether British or Foreign, entering or departing from the Port of London from or to the southward, if on a voyage to or from ports in the Bay of Biscay, ports south of Cape Finisterre, Gibraltar, and ports within the Straits, America, and the West Indies, the toll of three-sixteenths of a penny per ton of the burden of every ship for each time of passing or deriving benefit from the light-vessels known as the "Edinburgh Channel" and the "Black Deep" at the entrance to the River Thames.

And whereas by virtue of section six hundred and forty-five of "The Merchant Shipping Act, 1894," Her Majesty may by Order in Council increase, vary or reduce any light dues payable in respect of any lighthouse, buoy or beacon for the time being under the management of a general lighthouse authority.

And whereas the provisions of section one of "The Rules Publication Act, 1893," have been

complied with.

And whereas it is fit and proper that the Light Duties payable in respect of the said "Edinburgh Channel" and "Black Deep" Lights should be varied in manner hereinafter mentioned:

Now, therefore, Her Majesty doth by this Order in Council order and direct that, after the date of this Order, there shall be paid for every ship, whether British or Foreign, entering or departing from the Port of London from or to the southward, if on a voyage to or from ports in the Bay of Biscay, ports south of Cape Finisterre,

Gibraltar, and ports within the Straits, America, and West Indies, the toll of three-sixteenths of a penny per ton of the burden of every such ship in respect of each of the said lights known as the "Edinburgh Channel" and the "Black Deep," for every time of passing each of the said lights. Save and except that such Light Duties shall be payable once only in respect of the same voyage, if such voyage commences or terminates at a port within the following limits, that is to say, the coast of the United Kingdom, the Channel Islands, and the Isle of Man, and the Continent of Europe between the River Elbe and Brest inclusive.

Save as hereinbefore mentioned, the said tolls shall be levied subject to the regulations, exemptions, and abatements or discounts contained or referred to in the said New Consolidated Tables of Light Duties, or to such other regulations, exemptions, and abatements or discounts as may from time to time be duly sanctioned.
