COMMERCIAL RELATIONS OF GREAT BRITAIN AND THE DOMINICAN RE-PUBLIC.

FOREIGN OFFICE, August 19, 1896.

The Secretary of State for Foreign Affairs has received, from the Minister for Foreign Affairs of the Dominican Republic, a Note, dated the 14th ultimo, denouncing the Treaty of Friendship, Commerce, and Navigation, signed between Great Britain and Dominica on the 6th of March 1850. This notice of denunciation, which is in conformity with the provisions of Article X. of that Treaty, as supplemented by the terms of the subsequent Declaration of the 7th of September 1860, has been accepted by Her Majesty's Government, and the stipulations of the Treaty,—excepting those relating to peace and friendship between the two countries and their subjects and citizens,—will cease and determine accordingly on the 14th of July 1897.
