ACT OF ADJOURNAL REGULATING

THE FEES OF THE HIGH COURT OF JUSTICIARY.

At Edinburgh, the Eighteenth day of December Eighteen hundred and ninety-six.

Present: The Lord Justice-General.
The Lord Justice-Clerk.
Lord Adam.

Clerk, and Lords Commissioners of Justiciary, in pursuance of the powers conferred upon them by section 2 of "The Courts of Law (Fees), Scotland, Act, 1895"; and CONSIDER-ING that by an Act passed in the Third Session of the Second Parliament of King Charles the Second, chapter sixteen, entituled "Act concerning the Regulation of the Judicatories," it is, after providing for the new modelling of the Court of Justiciary, inter alia, enacted, "That it be left and recommended to the Judges of the said Court to regulate the inferior officers thereof, and to order every other thing concerning the said Court"; and whereas, by section 8 of "The Summary Prosecutions Appeals (Scotland) Act, 1875," the High Court of Justiciary is empowered from time to time, and as often as it sees occasion, to make rules and orders to regulate, inter alia, the Fees of Court to be paid in reference to Cases sent to it for opinion and stated and signed under the provisions of said last mentioned Act; and having had laid before them a Table of the Fees presently in use to be paid in the High Court of Justiciary, and the

Books kept in connection with said Fees, together with a Report thereon by the Clerk of Justiciary, and considered the same:—The said Lords do hereby make the following Rules and Regulations, and ENACT and DECLARE:—

I. On and after the First day of January next the existing Table of Fees in use in the High Court of Justiciary, and the Fees payable to the Clerks of the High Court of Justiciary on Circuit, shall be discontinued, and in place thereof the Fees to be payable and paid in said Court shall be those contained in the Table appended hereto, for or on account of the several writs, steps of procedure, and other matters therein specified respectively.

II. The time of payment of said Fees shall be the time when the writ is lodged, or the step of procedure taken, or when the act is done (as the case may be) in respect of which the Fee is chargeable; and said Fees shall be exigible by, and payable to, and in the office of, the Clerk of Justiciary, with the exception of Fees for auditing Accounts of Expenses, which are payable in the department of the Auditor of the Court of Session; and with the exception farther that Fees for business performed on Circuit shall be paid at the Circuit Town to the Circuit Clerk.

III. The said Fees shall be paid in Law Court Stamps, which shall be affixed and cancelled according to the present practice.

1V. The form of Books to be kept in connection with said Fees shall be the form at present in use; provided that it shall be in the discretion of the Clerk of Justiciary to alter said form, should

it appear to him to be expedient to do so with a view to simplify the form, or to facilitate inspection of the Books by the Court or the Lords of Her Majesty's Treasury.

REGULATIONS repecting Open Competitive Examinations for the situation of Female Learner in Edinburgh, Dublin, Liverpool, Glasgow, Newcastle-on-Tyne, Cardiff, and Belfast, in the Department of the Postmaster-General.

These Regulations will come into force on the 1st
January 1897. They are liable to alteration
for future Examinations.

- 1. Candidates will be required to satisfy the Civil Service Commissioners—
  - (a) That their age on the day of the Examination is not less than 15 nor more than 18.
  - (b) That they are duly qualified in respect of health and character.
  - (c) That they are unmarried or widows.
- 2. At each Examination the number of Candidates to be selected will be such as the Postmaster-General may from time to time fix.
- 3. The Examination will be in the following subjects, viz.:—
  - 1. Handwriting.
  - 2. Orthography.
  - 3. English Composition, to be tested by a short essay or letter on a simple subject.
  - 4. Arithmetic, including Vulgar and Decimal Fractions and Percentages.
  - 5. Geography (general).
- 4. Candidates must be at least 5 feet in height. No officer, however, will be retained in the Service who does not attain the height of 5 feet 2 inches before completing her 19th year.
- 5. No Candidate will be admitted to examination who does not, at such time as may be fixed by the Civil Service Commissioners, produce an undertaking, signed by her Parent or Guardian, that she will, if successful, reside within a suitable distance from the Post Office, either with her Parents or Guardians, or with relations or friends approved by them.
- 6. Persons holding situations in the Civil Service will not be eligible unless they produce to the Civil Service Commissioners the written permission of the authorities of their Department to attend the Examination, dated before the commencement of the Competition.
- 7. Application for permission to attend an Examination must be made at such times and in such manner as may be fixed by the Civil Service Commissioners.
- 8. A fee of 3s, will be required from every Candidate attending the Examination.

Note.—Female Learners will be required to resign their appointments on marriage.
