LOCAL AUTHORITIES LOANS (SCOT-LAND) ACTS, 1891 and 1893.

(54 and 55 Vict. c. 34, and 56 Vict. c. 8.)

ORDER of the Secretary for Scotland confirming Resolutions of the Town Council of the Royal Burgh of Dunfermline for the creation of Redeemable Stock.

Whereas by section 6 of the Local Authorities Loans (Scotland) Act, 1891 (hereinafter called the first recited Act), as amended by section 4, sub-section (2) of the Local Authorities Loans (Scotland) Act, 1891, Amendment Act, 1893 (hereinafter called the second recited Act), it is provided that a resolution of a Local Authority, as in section 5 of the first recited Act, shall not take effect unless and until—

(1) It is confirmed at a subsequent meeting of the Local Authority held after the resolution has been published in the prescribed manner, and after the expiration of the prescribed time, being not earlier than fourteen days after the first publication of such resolution; and (2) It is confirmed by the Secretary for Scotland with or without modifications by an Order under his hand and seal of Office.

And whereas the Town Council of the Royal Burgh of Dunfermline are the Local Authority in the said Burgh for the purposes of the first and second recited Acts.

And whereas resolutions for the creation of redeemable stock under the said Acts were adopted by the Town Council of the Royal Burgh of Dunfermline at a meeting held on the 8th day of February 1897, and were confirmed by the said Town Council at a subsequent meeting held after the resolution had been published in the prescribed manner, and after the expiration of the prescribed time, on the 8th day of March 1897.

And whereas these resolutions have been submitted to me for confirmation with or without modifications in terms of the aforesaid Acts.

Now, therefore, I, the Right Honourable Alexander Hugh, Lord Balfour of Burleigh, Her Majesty's Secretary for Scotland, do hereby confirm the said resolutions in the form in which they appear in the schedule appended to this Order.

SCHEDULE OF RESOLUTIONS.

prescribed time, being not earlier than Resolved, First,—That under the authority and fourteen days after the first publication of subject to the provisions of the Local Authorities such resolution: and Loans (Scotland) Acts, 1891 and 1893, the Town

Council do hereby, in exercise of their several statutory powers, create Stock, to be called Dunfermline Corporation Redeemable Stock, and to be issued to an amount which shall be sufficient for the following purposes, but not exceeding one hundred and fifty thousand pounds.

- (a) For raising sums (amounting in the aggregate to the sum of one hundred and twentyfour thousand one hundred pounds which has not be raised), that is to say:—
- (1) The sum of one hundred thousand pounds on account of the money which the Town Council have authority to raise by borrowing under the powers conferred upon them by the Burgh Gas Supply (Scotland) Act, 1876, for the purpose of paying the price of the works and undertaking of the Dunfermline Gas-Light Company Limited, which the Town Council have purchased under the powers of the said Act, paying off the mortgages granted by the said Company, under burden of which their said undertaking has been acquired, paying the expenses of and incident to the arbitration under which the said price was fixed and determined, and the transference of the said undertaking to the Town Council, and of meeting the cost of extension of the Gas Works.
- (2) The sum of two thousand five hundred pounds on account of the money which the Town Council have authority to raise by borrowing under the powers conferred upon them by the Burgh Police (Scotland) Act, 1892, for widening, improving, and causewaying the public streets and roads within the Burgh, and other purposes of the said Police Act.
- (3) The sum of six hundred pounds on account of the money which the Town Council have authority to raise by borrowing under the powers conferred upon them by the Burgh Police (Scotland) Act, 1892, for the purpose of providing, establishing, improving, or extending fit shambles or slaughter-houses for the purpose of slaughtering cattle.
- (4) The sum of three thousand pounds on account of the money which the Town Council have authority to raise by borrowing under the powers conferred upon them by the Public Health (Scotland) Act, 1867, and Acts amending the same, for the purpose of providing and constructing sewers for the drainage of the Burgh, and providing a Hospital for the treatment of persons suffering from contagious or infectious diseases.
- (5) For raising as required such sums as may be necessary, but not exceeding in the aggregate the sum of sixteen thousand five hundred pounds, to meet expenditure upon any capital work for which the Town Council have a statutory power to borrow within the meaning of the Local Authorities Loans (Scotland) Acts, 1891 and 1893.
- (6) For raising the sum of one thousand five hundred pounds, or such less sum as may be required, to meet the expenses incidental to the creation of stock, including any sums payable as compensation to the

- holders of existing securities, for which purposes the Town Council are authorised to raise money by borrowing under the provisions of section 21 (3) and section 60 (1) of the Local Authorities Loans (Scotland) Act of 1891.
- (b) For raising, instead of re-borrowing, the sum of sixteen thousand six hundred and fifty pounds required by the Town Council for the purpose of paying off when due sums amounting to sixteen thousand six hundred and fifty pounds, which will fall due on or before the 15th day of May 1902, being a portion of their debts now subsisting on the security of outstanding securities granted by the Town Council for raising money for the purposes of the following Acts, that is to say:—
- (1) The sum of three thousand two hundred and fifty pounds borrowed under the powers of the General Police and Improvement (Scotland) Act, 1862, and the Burgh Police (Scotland) Act, 1892.
- (2) The sum of one thousand five hundred pounds, borrowed under the powers of the said Police Acts for providing a public slaughter-house; and
- (3) The sum of eleven thousand nine hundred pounds, borrowed under the powers of the Public Health (Scotland) Act, 1867, and Acts amending the same; and which sums the Town Council are under those Acts authorised to re-borrow.
- (c) For raising the sum of nine thousand two hundred and fifty pounds for repaying the amount temporarily borrowed by the Town Council from the Common Good Account of the Burgh, in order to enable the Town Council to meet sums which amount to nine thousand two hundred and fifty pounds, being a portion of their debt secured on outstanding securities granted by the Town Council for raising money for the purposes of the Dunfermline Water Act, 1876, and which sum the Town Council are under that Act authorised to re-borrow.

Resolved, Secondly,—That such stock shall be issued at the price and shall bear the dividends, and be transferable in the manner hereinafter specified, that is to say:—

- (a) The minimum price of issue to be £102 per centum, the first Dividend to be payable on the 11th day of November 1897.
- (b) Tenders for stock to be made to the Burgh Chamberlain, Dunfermline, or to the Head Office, or any of the branches of the Commercial Bank of Scotland Limited, on or before the 22nd April 1897.
  - A deposit of 5 per cent. on the amount of stock tendered for, together with the premiums offered, if any, to be paid at the Head Office, or any of the branches of said Bank at the time of the delivery of the tender.
- (c) The balance of the said tenders, when accepted, to be payable on the 15th May 1897.
  - In case of default in the payment of the balance at its proper date, the deposit previously paid will be liable to forfeiture.

(d) Dividends at £3 per centum per annum, payable half-yearly at 15th May and 11th November.

(e) Dividends on the total amount of stock (calculated from the 15th day of May 1897) to be payable on the 11th of November 1897.

(f) Stock certificates in name of registered holders, or, in the option of applicants, script certificates to bearer, with coupons attached for the Dividends, payable 11th November 1897, and 15th May 1898, and subsequent half-years, to be issued in exchange for the provisional receipts.

(g) In the event of the receipt of tenders for a larger amount of stock than that proposed to be issued at or above the minimum price, the tenders at the lowest price accepted to be subject to proportionate

diminution.

(h) Stock to be issued in sums of not less than £10.

(i) Stock to be transferable by deed.

Resolved, Thirdly,—That such stock shall be redeemable at the option of the Town Council at par, as follows :-

On 15th May 1917, or at any term of Whitsunday or Martinmas thereafter, the whole to be redeemed on or before 15th May 1947. Three months' notice to be given to stockholders of intention to redeem stock.

Resolved, Fourthly,—That an agreement be entered into with the Commissioners of Inland Revenue for the payment to them of composition under the provisions of the Customs and Inland Revenue Act, 1891, for the Stamp Duty on transfers of stock issued under the foregoing resolutions.
