And whereas Her Majesty is satisfied that the law of the Island of Jamaica as respects the duty leviable in respect of property situate in the United Kingdom when passing on death is to the like effect as the provisions of sub-section (1) of the aforesaid section:

Now, therefore, Her Majesty, by virtue and in exercise of the power by the aforesaid Act in Her Majesty vested, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, that the twentieth section of "The Finance Act, 1894," shall apply to the Island of Jamaica.

The Civil Service Commissioners hereby give notice that the following Regulations have been approved by the Lords Commissioners of Her Majesty's Treasury, viz.:—

SPECIAL REGULATIONS (supplementary to the General Regulations issued 8th April 1872, and amended by subsequent Notices in the London Gazette), respecting Open Competitive Examinations for the situation of Clerk in the Departments of Her Majesty's General Register House, Edinburgh.

N.B.—These Regulations are liable to alteration for future Examinations.

- 1. The limits of age for these situations are 18 and 20, and Candidates must be of the prescribed age on the first day of the Examination. Persons already serving as Engrossing Clerks in the Register House Departments will be eligible in respect of age if their service commenced when they were under 23, if their age does not at the date of the Examination exceed 33, and if their service has been continuous or nearly continuous up to the same date.
- 2. No Candidate will be elegible who has not within the last five years served for at least two years in the office of a Conveyancer in Scotland. or as Engrossing Clerk in the Register House Departments. Evidence on this point must be sent in at such times and in such manner as the Civil Service Commissioners may appoint.

 - Book-keeping.

No Candidate will be eligible who fails to pass in the subject numbered 1.

- 4. Application for permission to attend an Examination must be made in the writing of the Candidate, at such time and in such manner as may be fixed by the Commissioners.
- 5. A fee of £2 will be required from every. Candidate attending the Examination.
