rogued to Thursday the second day of December one thousand eight hundred and ninety-seven; We, by and with the advice of Our Privy Council, hereby issue Our Royal Proclamation, and publish and declare that the said Parliament be further prorogued to Tuesday the eighth day of February one thousand eight hundred and ninety-eight; and We do hereby further, with the advice aforesaid, declare Our Royal will and pleasure that the said Parliament shall, on the said Tuesday the eighth day of February one thousand eight hundred and ninety-eight, assemble and be holden for the despatch of divers urgent and important affairs; and the Lords Spiritual and Temporal, and the Knights, Citizens, and Burgesses, and the Commissioners for Shires and Burghs of the House of Commons, are hereby required and commanded to give their attendance accordingly at Westminster, on the said Tuesday the eighth day of February one thousand eight hundred and ninety-eight.

Given at Our Court at Windsor this twenty-sixth day of November, in the year of our Lord one thousand eight hundred and ninety-seven, and in the sixty-first year of Our Reign.

# WILD BIRDS PROTECTION ACTS, 1880 to 1896

#### COUNTY OF DUMBARTON.

ORDER by the Secretary for Scotland. .

IN pursuance of the powers conferred upon meby the "Wild Birds Protection Act, 1894," and upon application by the County Council of the County of Dumbarton, I, the Right Honourable Alexander Hugh, Lord Balfour of Burleigh, Her Majesty's Secretary for Scotland, do hereby make the following Order:—

1. The taking or destroying the eggs of the following species of Wild Birds is prohibited throughout the entire County of Dumbarton during the currency of this Order, viz.:—

Dotterel (Eudromias morinellus). Black-capped or Black-headed Gull (Larus ridibundus). Barn Owl (Strix flammea). Long-eared Owl (Asio otus). Short-eared Owl (Asio accipitrinus). Tawny Owl (Syrnium aluco). Tern-Common (Sterna fluviatilis). Curlew (Numenius arquatus). Goatsucker (Caprimulgus europœus). Grebe (Podicipes fluviatilis). Kittiwake (Larus tridactylus). Mallard (Anas boscas). Sealark or Dunlin (Tringa Alpina). Snipe (Gallinago cœlestis). Teal (Querquedula crecca). Wigeon (Mareca penelope). Woodcock (Scolopax rusticula). Osprey (Pandion haliaëtus).

- 2. The taking or destroying the eggs of the Lapwing (Vanellus cristatus) is prohibited throughout the entire County of Dumbarton, after the 15th day of April in each year during the currency of this Order.
- 3. This Order shall take effect on the 1st day of January 1898, and shall remain in force until the 31st day of December 1898.
