WILD BIRDS PROTECTION ACTS, 1880 to 1896.

COUNTY OF PERTH.

Order by the Secretary for Scotland.

In pursuance of the powers conferred upon me by the "Wild Birds Protection Act, 1894," and upon application by the County Council of the County of Perth, I, the Right Honourable Alexander Hugh, Lord Balfour of Burleigh, Her Majesty's Secretary for Scotland, do hereby make the following Order:—

1. The taking or destroying the eggs of the following species of Wild Birds is prohibited throughout the entire County of Perth during the currency of this Order, viz.:—

Black-throated Diver (Colymbus arcticus). Dotterel (Eudromias morinellus). Dunlin (Tringa alpina). Eider Duck (Somateria mollissima). Goldfinch (Carduelis elegans). Goosander (Mergus merganser). Great Crested Grebe (Podicipes cristatus). Golden Plover (Charadrius pluvialis). Golden Eagle (Aquila chrysaëtus). Kingfisher (Alcedo ispida). Kite (Milvus ictinus). Owl, Barn (Strix flammea). Owl, Long-eared (Asio otus): Owl, Short-eared (Asio accipitrinus). Owl, Tawny (Syrnium aluco). Osprey (Pandion haliaëtus). Pochard (Fuligula ferina). Red-breasted Merganser (Mergus serrator). Sheldrake (Tadorna cornuta).

- 2. The taking or destroying the eggs of the Lapwing (Vanellus cristatus) is prohibited throughout the entire County of Perth, after the 15th day of April in each year, during the currency of this Order.
- 3. The "Wild Birds Protection Act, 1880," shall apply within the County of Perth during the currency of this Order to the following species of Wild Birds as if they had been included in the Schedule to the said Act, viz.:—

Bullfinch (Pyrrhula europæa).
Golden Eagle (Aquila chrysaëtus).
Linnet (Linota cannabina).
Kite (Milvus ictinus).
Osprey (Pandion haliaëtus).
Siskin (Chrysomitris spinus).

This Order shall take effect on the 1st day of January 1898, and shall remain in force for one year from that day.
