WILD BIRDS PROTECTION ACTS, 1880 to 1896.

COUNTY OF ABERDEEN.

ORDER by the Secretary for Scotland.

In pursuance of the powers conferred upon me by the "Wild Birds Protection Act, 1894," and upon application by the County Council of the County of Aberdeen, I, the Right Honourable Alexander Hugh, Lord Balfour of Burleigh, Her Majesty's Secretary for Scotland, do hereby make the following Order:—

1. The taking or destroying the eggs of the following species of Wild Birds is prohibited throughout the entire County of Aberdeen during the currency of this Order, viz.:—

Peregrine (Falco peregrinus), known also as "Hunting Hawk," "Blue Hawk," "Blue Sleeves."

Kestrel (Falco tinnunculus), known also as "Windhover."

Merlin Hawk (Falco æsalon). Long-eared Owl (Asio otus). Short-eared Owl (Asio accipitrinus). Barn Owl (Strix flammea).

Tawny Owl (Syrnium aluco).

Night Jar (Caprimulgus europœus), known also as "Goatsucker," "Night Hawk," "Churn Owl." and "Fern Owl."

Black-headed Gull (Larus ridibundus). Herring Gull (Larus argentatus). Kittiwake (Larus tridactylus). Common Gull (Larus canus). Golden Plover (Charadrius pluvialis). Lark (Alauda arvensis). Crossbill (Loxia curvirostra).

- 2. The taking or destroying the eggs of the Lapwing (Vanellus cristatus) is prohibited throughout the entire County of Aberdeen, after the 15th day of April in each year, during the currency of this Order.
- 3. The "Wild Birds Protection Act, 1880," shall apply within the County of Aberdeen during the currency of this Order to the following species of Wild Birds as if they had been included in the Schedule to the said Act, viz.:—

Peregrine (Falco peregrinus), known also as "Hunting Hawk," "Blue Hawk," "Blue Sleeves."

Kestrel (Falco tinnunculus), known also as-

Merlin Hawk (Falco æsalon). Crosssbill (Loxia curvirostra).

This Order shall take effect on the 1st day of January 1898, and shall remain in force for one year from that day.

## INFANT LIFE PROTECTION ACT, 1897.

ORDER by the Secretary for Scotland.

IN pursuance of the powers conferred on me by section 6 of the Infant Life Protection Act, 1897 (60 and 61 Vict. cap. 57), I, the Right Honourable Alexander Hugh, Lord Balfour of Burleigh, Her Majesty's Secretary for Scotland, do hereby direct that an Abstract of the provisions of the said Act in the form annexed to this Order shall be posted as a Notice or Handbill throughout the parish at the places where such Notices are usually posted, and at any other places deemed suitable by the Parish Council.

# INFANT LIFE PROTECTION ACT, 1897.

NOTICE TO PERSONS RECEIVING INFANTS FOR HIRE OR REWARD.

The above-mentioned Statute requires that on and after the 1st January 1898:—

- Every person\* receiving more than one infant under the age of five years for maintenance, apart from their parents, for hire or reward for a longer time than forty-eight hours, shall give notice thereof within forty-eight hours to the Parish Council. The Notice shall truly state the names, ages, and sex of the infants, and the names and abode of the persons receiving, and the persons from whom the infants were received.
- 2. If any such infant is transferred from the care of a person who has so received it, notice must forthwith be given of the name and address of the person to whom it has been transferred.
- 3. Any person receiving an infant under two years for a lump sum not exceeding £20, without any agreement for further payment, shall give notice within forty-eight hours. In default, any sum received is liable to be forfeited.
- 4. All such notices shall be in writing, and shall either be delivered at or be sent by registered letter to at
- 5. In case of the death of any such infant, notice must be given to the Procurator-Fiscal within twenty-four hours, by the person having care of the infant.
- 6. All persons receiving such infants must admit the Inspector of Poor without obstruction to inspect the infants and the premises in which they are retained.
- 7. They must also obey the directions of the Parish Council with regard to the number of infants who may be received in any premises, and with regard to the removal of any child from their care to a poorhouse or place of safety.
- 8. All persons whatsoever must admit to their premises, and refrain from obstruct-

- ing an Inspector of Poor acting on the authority of a Search Warrant issued under this Act.
- 9. No infant shall be received for hire by any person who has been deprived of the care of any child under this Act, or has been convicted of any offence under the Protection of Children Acts, unless the Parish Council consent in writing.
- Every person who disobeys the foregoing provisions of the law is liable to be fined £5, or sent to prison for six months.
