LOCAL GOVERNMENT (SCOTLAND) ACTS.

Alteration of Parish Areas.

ADJUSTMENT ORDER No. XVI.

(CITY PARISH OF EDINBURGH AND PARISH OF LIBERTON.)

WHEREAS a new Parish, called the City Parish of Edinburgh, was constituted on the 15th day of May 1895 by the Order of the Secretary for Scotland published in the Edinburgh Gazette of the 15th March 1895 (No. XXI.);

And whereas all questions of compensation or adjustment consequential on the said Order were expressly reserved;

And whereas the Parish Council of the Parish of Liberton submitted claims to me for compensation consequential on the said Order;

And whereas I declined to grant compensation in respect of loss of income consequent on alteration of rateable area;

And whereas I appointed Sir John Cheyne, Advocate, Q.C., Sheriff of Renfrew and Bute, to inquire (inter alia) into such claims, and "to report whether any, and, if so, which of the claims are claims for compensation in respect of loss of income consequent on alteration of rateable area, and whether any, and, if so, what further Order or Orders should be issued under the Local Government (Scotland) Acts with a view to provide for the adjustment and disposal of the property, debts, and liabilities of the various authorities affected by the Order aforesaid, and for the settlement of differences arising out of the Order";

And whereas the said Sir John Cheyne has held an inquiry, and has reported;

And whereas I am of opinion that the liability of a Parish Council to maintain during the continuance of their then chargeability the paupers on the roll of the Parish at the date of an alteration of Parish boundaries is a liability which may be adjusted in terms of the said Acts; that the average duration of such chargeability may be taken as seven years; and that the number of paupers effeiring to the portion of Liberton Parish transferred to the City Parish of Edinburgh (hereinafter called the transferred area) should be fixed in proportion to the assessable rental of the transferred area as compared with the assessable rental of the remainder of the Parish of Liberton;

And whereas the liability of the Parish Council of Liberton so ascertained in respect of paupers

effeiring according to rental to the transferred area exceeds the liability to maintain paupers deriving a claim from birth or residence in the transferred area, which was by the Order aforesaid imposed on the Parish Council of the City Parish of Edinburgh, by the amount specified at the end of the Schedule annexed hereto:

Now, therefore, I, the Right Honourable Alexander Hugh, Lord Balfour of Burleigh, Her Majesty's Secretary for Scotland, do, in virtue of the powers conferred upon the Secretary for Scotland by the Local Government (Scotland) Acts, order as follows:—

The Parish Council of the City Parish of Edinburgh shall pay to the Parish Council of Liberton the sum of one thousand six hundred and eighty pounds on the fifteenth day of May 1898, with interest thereon at the rate of five per cent. per annum from the said date until it is paid; or alternatively, in the option of the first-named Parish Council, the sum of four hundred and seventy-seven pounds on the fifteenth day of May in the year 1898, the sum of four hundred and twenty-two pounds on the fifteenth day of May in the year 1899, the sum of three hundred and sixty-seven pounds on the fifteenth day of May in the year 1900, the sum of three hundred and twelve pounds on the fifteenth day of May in the year 1901, and the sum of two hundred and fifty-seven pounds on the fifteenth day of May in the year 1902, with interest on each annual payment at the rate of five per cent. per annum from the date when such annual payment became due until it is paid.

^{*}Section 8 of the Corn Returns Act, 1882, provides that where returns of purchases of British Corn are made to the Local Inspector of Corn Returns in any other measure than the imperial bushel, or by weight or by a weighed measure, that Officer shall convert such returns into the imperial bushel, and in the case of weight or weighed measure the conversion is to be made at the rate of sixty imperial pounds for every bushel of wheat, fifty imperial pounds for every bushel of barley, and thirty-nine imperial pounds for every bushel of oats.
