FORRES WATER (H.L.)

Petition for Additional Provision to the Bill under the above Name or Short Title, to Authorise the Police Commissioners of the Royal Burgh of Forres to Purchase the Undertaking of the Forres Water Company Limited; Application to Police Commissioners of the Powers, Duties, and Liabilities proposed to be conferred or imposed on the Company by the Bill; Power to Police Commissioners to Borrow, and other Purposes.

OTICE is hereby given that application is intended to be made to Parliament, in the present Session, by Petition for additional provision for leave to introduce into the Bill, which has been deposited in Parliament under the above name or short title (hereinafter called "the Bill"), clauses or amendments for all or some of the following purposes (that is to say):—

1. To empower the Commissioners of Police of the Royal Burgh of Forres (hereinafter called "the Commissioners") to purchase by agreement the undertaking of the Forres Water Company, Limited (hereinafter called "the Company"), as and from the 28th day of May 1898, or as and from such other date as the additional clauses and amendments of the Bill may provide, and to make provision for carrying out any agreement made or to be made between the Company and the Commissioners for the purchase and transfer of the said undertaking, lands, buildings, water works, easements, mains, pipes, filters, plant, machinery, ducts, plans, and other assets, real leasehold, and personal, and all the authorities, powers, rights, and privileges of the Company, including the benefit of and subject to the conditions, restrictions, and obligations of any agreements which the Company have entered into, for or in respect to the supply of water, for such price or consideration, and generally subject to and upon the terms and conditions set forth in any such agreement, or upon such other terms and conditions as may be defined in or

provided for by the additional clauses and amendments and the Bill, and to constitute the purchased premises, powers, rights, and privileges, and any extensions thereof, made under the powers of the Bill the Water Undertaking of the Commissioners.

- 2. To enable the Commissioners to enter into and fulfil any agreements, and to confirm and if need be to vary any agreements which may have been or which during the progress of the Bill may be entered into by the Company or the Com-missioners for or relating to any of the purposes of the Bill.
- 3. To confer upon or make applicable to the Commissioners so far as may be necessary or expedient, the powers, authorities, duties and obligations proposed to be conferred or imposed on the Company by the Bill in connection with the existing undertaking of the Company, and the construction of new works or otherwise.
- 4. To empower the Commissioners to borrow money for the purposes of any such agreement and of the purchase and carrying on the existing undertaking of the Company, and for the construction and maintenance of the new works proposed to be authorised by the Bill, and for all or any other purposes connected with the undertaking of the Water Company when acquired by the Commissioners and of the Bill.
- 5. To provide that the money so borrowed shall be secured on the undertaking of the Company when purchased, and on the water rates proposed to be authorised by the Bill, or other rates leviable by the Commissioners under the Burgh Police (Scotland) Act, 1892, the Public Health (Scotland) Act, 1897, or otherwise, or on such other security or by such other means as the additional clauses and amendments and the Bill may provide.
