INEBRIATES ACT, 1898. SCOTTISH OFFICE, WHITEHALL, February 15, 1899.

Notice is hereby given, in terms of Section 21 (2) of the Inebriates Act, 1898, that the Secretary for Scotland has made the following Regulations under the Act, and that the same will come into effect on the 15th day of March 1899:—

REGULATIONS for Certified Inebriate Reformatories in Scotland under the Inebriates Act, 1898 (61 and 62 Vict. c. 60).

I.—General Regulations.

The Managers.

1. The Managers of a certified inebriate reformatory shall keep a minute book at the institution, in which they shall record their proceedings, and it shall be open to the Inspector appointed by the Secretary for Scotland.

2. Rules not inconsistent with the Regulations shall be prepared by the Managers for the domestic arrangements of the reformatory and management and treatment of the inmates, and shall be submitted to the Secretary for Scotland for his approval.

3. The Managers shall cause an abstract of the regulations and rules affecting inmates to be hung in the workroom or some conspicious place.

4. The Managers shall, with such assistance as may be necessary, prepare an annual report, to be submitted to the Secretary for Scotland, showing the work of the institution and the receipts and expenditure incurred; and the Managers shall, from time to time, give to the Secretary for Scotland such information as he may require.

5. The Managers shall make application to the Secretary for Scotland for the Treasury Grant in aid of the reformatory funds quarterly, but the grant will only be made in event of the Secretary for Scotland being satisfied that the institution is being conducted in a satisfactory manner.

Officers Generally.

6. A sufficient number of officers shall be appointed by the Managers to maintain discipline, and to instruct the inmates, and keep them employed in suitable kinds of labour or industry.

 $\tilde{7}$. No resident officer, so long as he is in the service of the reformatory, shall use spirituous or

intoxicating liquors.

8. An officer shall not receive directly or indirectly, under any pretence whatsoever, any fee or present from any person in connection with his duties.

The Superintendent:

9. The Superintendent appointed by the Managers shall make himself acquainted with the latest and best views as to the nature and preatment of inebriety, and shall in the performance of his duties, and in the spirit in which he governs the establishment, have regard to the fact that the purpose of the Institution is reformatory. He will, so far as he can, ascertain the previous history of each individual inmate, and make himself acquainted with his character, and endeavour to acquire a personal influence over him for his good. He shall consult with the Medical Officer, Chaplain, and others connected with the institution in all matters in which they can help him. He will keep a record, so far as he can, of the future history of the inmates.

10. The Superintendent shall be the head of the whole establishment where the reformatory is intended for males or for males and females. Where the reformatory is intended for females only, the Superintendent shall, if possible, be a female officer.

11. The Superintendent shall report the reception of every inmate to the Secretary of Scotland, sending a copy of the commitment or order of

court.

12. The Superintendent shall keep a journal and such other records as may be prescribed, which shall be open to the inspection of the Managers and Inspector.

13. The Superintendent shall give effect to the written recommendation of the Medical Officer for the alteration of the treatment of any inmate, or for the supply of any additional articles to any

inmate on medical grounds.

14. The Superintendent shall without delay report to the Managers, for the immediate information of the Secretary for Scotland, any case in which the Medical Officer shall be of opinion that the life of any inmate will be endangered by further detention, or that any sick inmate will not survive his sentence, or is totally and permanently unfit for reformatory discipline. He shall similarly report any case in which the Medical Officer has reason to believe that the mind of any inmate is becoming impaired by continual detention.

15. In any case in which the sickness of any inmate has, in the opinion of the Medical Officer, assumed an aspect of danger, the Superintendent shall inform the relatives.

16. The Superintendent may award to inmates punishments as provided under regulations for offences, recording the same in such manner as

may be ordered.

17. The Superintendent shall have power to examine all persons and vehicles entering or leaving the reformatory, and he may exclude any person who may refuse to be examined, and he shall have power to remove from the reformatory any visitor to the reformatory, recording the same

in his journal.
18. The Superintendent shall take care that proper precautions againt fire are adopted, and that the fire engine and other appliances for the extinction of fire are at all times kept in good order and ready for use. He shall take care that practical instructions are given as to the steps to be taken in case of fire, and that the officers and inmates are acquainted with their duties on such occasions.

19. Upon the death of an inmate the Superintendent shall give immediate notice thereof to the Managers, to the Procurator-Fiscal having jurisdiction, to the Inspector, and, whenever practicable, to the nearest relative of the deceased.

20. The Inspector shall have every facility and assistance given to him in carrying out his duties when visiting a Certified Inebriate Reformatory.

The Medical Officer.

- 21. The Managers shall appoint a Medical Officer to each Certified Inebriate Reformatory. He shall also be responsible for the health and medical treatment of the inmates with a view especially to their reformation. Every inmate shall on admission be carefully examined by the Medical Officer as to his general health and how it has been affected by drink, particularly as to how the functions of the nervous system, kidneys, and other organs have been affected, entering in detail the state of each nervous and mental function, all the results of his examination being systematically recorded in the case book, the form of which shall be arranged by the Medical Officer and approved by the Secretary for Scotland. shall endeavour to ascertain and shall record the history and heredity of each case. He shall also keep a detailed history of the health and conduct of each inmate so long as he remains in Where the reformatory is for the reformatory. females only, the Medical Officer should if possible be a woman.
- 22. When any inmate is about to be removed from the reformatory, the Medical Officer shall duly examine him, and certify as to his fitness to leave the reformatory, and as to such other particulars regarding him as may be required.

Admission, Discharge, and Removal.

23. A certified inebriate reformatory should, if possible, be restricted to the reception of one sex. Where circumstances render this impracticable, due provision shall be made for the separation of the sexes at all but defined hours.

24. A register of admissions shall be kept, giving a detailed history of the inmate before his reception, and for so long as he remains in the Institution, and until his final discharge, according to a form approved by the Secretary for Scotland.

25. Female inmates shall be in the charge of

female officers.

26. Any inmate may be searched. Female inmales shall be searched by female officers.

27. All inmates must obey the officers having charge over them. The Superintendent shall take care that every inmate having a complaint to make or request to prefer to him shall have ample facilities for doing so, and he shall redress any grievance, or take such steps as may seem necessary, recording the same in his journal. The Super-intendent shall inform the Managers or Inspector of the desire of any inmate to see them.

28. Upon sufficient cause being shown, the Sheriff shall have power, upon the application of the Managers, to direct that an inmate committed to a certified inebriate reformatory shall be removed to another certified inebriate reformatory which may be willing to receive him.

29. In the event of the Managers being unable properly to control any inmate, it shall be lawful for them to present a petition to the Sheriff for a warrant for his transfer to a State Inebriate Reformatory for the remainder of his sentence, and if they shall satisfy him by evidence of such inability, it shall be lawful for him to grant a warrant for such transfer, provided always that no such warrant shall have any effect until the sanction in writing of the Secretary for Scotland has been obtained, but the maintenance of such inmate shall be a charge on the Managers who wish him removed.

30. The Sheriff, on the recommendation of the Managers, may, at any time after the inmate has spent six months in a Certified Inebriate Reformatory, by licence under his hand, permit such inmate to live with any trustworthy and respectable person or in any approved Institution named in the licence willing to receive and take charge of him for a definite time, subject to the following conditions and such further conditions as the Secretary for Scotland may determine :-

a. The licensed person shall sleep in a dry and well ventilated bedroom with a comfortable

bed and sufficient blankets.

b. Clothing will be provided by the Managers, but the guardian shall see that the licensed person has two full suits of clothing for wear, and that the articles are kept clean and in good repair.

c. The guardian shall provide the licensed person with suitable food sufficient in

quantity and properly cooked.

d. The guardian shall see that the licensed person is fully employed, as far as health permits, for the usual working hours of the district.

e. The guardian shall, with the sanction of the Managers or the Inspector, appoint a person or persons to act for him in his absence. The guardian shall give such length of notice as may be agreed on before giving up his guardianship.

f. The guardian shall treat the licensed person kindly as one of his own family or servants, or if he be sent to an Institution, similarly

to the other inmates.

g. The licensed person shall have daily outdoor exercise if not employed at work in the open air.

h. A Medical Officer shall be called in when required in case of an accident to or illhealth of the licensed person, and his instructions shall be carefully carried out.

i. The guardian shall, as far as possible, prevent

the escape of a licensed person, and his tasting spirituous or intoxicating liquors.

 The guardian shall at once report to the Managers any escape, accident, illness, misconduct or contravention of the conditions of his licence by the licensed person, and shall give every facility to anyone authorised to visit the licensed person.

31. The Managers, on the recommendation of the Superintendent, may, at any time after the inmate has spent three months in a Certified Inebriate Reformatory, by licence, permit such inmate to live with any trustworthy and respectable person, or in any approved Institution, named in the licence, willing to receive and take charge of him, for any period not exceeding one week, subject to the preceding conditions. The Managers may at any time revoke such licence.

32. No inmate shall be allowed to be absent over night without a licence. During the day, the Superintendent may, subject to such conditions as the Managers may determine by permit signed by himself, allow an inmate to be outside the reformatory grounds. Such inmate shall show his permit, on demand, to any Magistrate, or officer of the reformatory or police, and for any misconduct is liable to be apprehended by such officer and at once taken back to the reformatory.

33. Every licensed person shall be visited by persons appointed by the Managers as often as

they deem necessary.

34. Any licence may be revoked at any time by the Sheriff on the recommendation of the Managers, and thereupon the licensed person to whom the licence shall relate may be taken back to the reformatory.

35. The time during which a licensed person is absent from a reformatory under such licence shall, except when the licence is forfeited or revoked, be deemed part of the time of his detention in

such reformatory.

- 36. When such licence is forfeited or revoked, any time during which the licensed person was absent from a reformatory subsequent to such forfeiture or revocation, shall be excluded in computing the time during which he may be detained in a reformatory, unless a revocation is ordered for reasons unconnected with the licensed person's conduct.
- 37. An inmate absent from a reformatory under a licence who escapes from the charge of the person or Institution in which he has been placed is liable to a fine not exceeding twenty pounds, or imprisonment for a term not exceeding three months, with or without hard labour, and the time during which he is imprisoned shall not be computed in reckoning the period of detention in a reformatory, unless the Secretary for Scotlandshall otherwise direct.
- 38. A licensed person who fails to comply with any of the conditions of his licence shall be considered thereby to have forfeited the licence, and may thereupon be taken back to a reformatory.
- 39. Any unauthorised absence from a reformatory of a person ordered to be detained therein shall not be included in computing the time during which he may be detained.
- 40. The Superintendent shall satisfy himself that an inmate understands the regulations and conditions under which he is allowed to be absent on licence from a certified inebriate reformatory.
- 41. The granting, revoking, or forfeiting of any licence shall be reported to the Inspector.

42. All licences granted, revoked, or forfeited shall be reported to the Secretary for Scotland at such times and with such particulars as he may require.

Food.

43. A sufficient dietary for the inmates shall be prepared and submitted to the Secretary for Scotland for approval, and the Medical Officer shall at frequent intervals inspect the food of the inmates, reporting thereupon to the Superintendent when necessary.

44. No inmate shall be allowed to taste any spirituous or intoxicating liquor without the order in writing of the Medical Officer, and no such order shall be issued until after the Superintendent has been informed thereof by him, except

in cases of emergency.

45. No spirituous or intoxicating liquor or drug of any kind shall be admitted into the reformatory under any pretence whatever, except on the written order of the Medical Officer.

Clothing.

46. Suitable clothing shall be provided for any inmates who are not allowed to wear their own

clothing.

47. Every inmate shall be required to keep himself clean and decent in his person, and to conform to such rules as may be laid down for the purposes of health, cleanliness, and order.

Employment.

48. The full and regular employment of the inmates shall be a leading principle of the certified inebriate reformatory, and the hours of labour shall, as far as possible, be those for similar occupations in the district.

49. The position of an inmate, and the privileges granted to him, shall be determined by

industry, good conduct and character.

50. The proceeds of the labour of the inmates shall be applied as the Managers may direct, but they may grant to deserving inmates a part of their earnings.

51. The inmates shall be encouraged and as-

sisted in improving their education.

52. Such literature, recreations and means of amusement as are approved by the Superintendent and the Managers shall be provided.

53. Smoking shall be allowed in the day-room, or exercise yard and grounds, during recreation hours, under regulations which shall be prescribed by the Managers from time to time.

Visits and Letters.

54. Subject to the control of the Superintendent, inmates may be allowed to receive visits and to write and receive letters.

Religious Observances.

- 55. Provision shall be made for daily prayers, Sunday services, and religious instruction of the inmates.
- 56. The Managers shall, so far as practicable, arrange for inmates of any particular religious persuasion receiving instruction from ministers of that persuasion, or such other person as may be delegated by those ministers. They may authorise any person to visit the reformatory for religious or reformatory purposes, but no inmate shall be compelled to receive such visits against his will.

Offences and Punishments.

57. An inmate shall be guilty of an offence who shall-

, · · š

(a) Disobey any order of the Superintendent | or of any other officer.

(b) Treat with disrespect any officer or servant of the reformatory, or any visitor, or any person employed in connection with the reformatory.

(c) Be idle, careless, or negligent at work, or refuse to work.

(d) Behave irreverently at Divine Service or pravers.

(e) Swear, curse, or use any abusive, insolent, threatening, or other improper language.

(f) Be indecent in language, act, or gesture.

Assault any person.

(h) Make any unnecessary noise, or give any unnecessary trouble.

(i) Escape from or without permission leave his appointed location, or his place of work.

(j) In any way disfigure or injure any part of the reformatory, or any article to which he may have access.

(k) Commit any nuisance.

(1) Have in his possession any article he is not allowed to have.

(m) Refuse or neglect to conform to regulations and orders laid down.

(n) In any other way offend against good order and discipline.

(o) Take any spirituous or intoxicating liquor except when prescribed by the Medical Officer.

(p) Attempt to do any of the foregoing acts.

58. The following are the methods of punishment authorised for offences within the reformatory:

(a) Deprivation of work for a period.

(b) Isolation at exercise.

(c) Isolation at chapel. (d) Reduction of diet.

(e) Solitary confinement.

(f) Deprivation of the privilege of association, conversation, visits, letters, absence on parole or smoking.

(g) Forfeiture of marks. (h) Forfeiture of gratuity.

59. Punishment may be awarded by one or ore of such methods. No other method of more of such methods. punishment shall be used within the reformatory.

60. No punishment or privation of any kind shall be awarded to an inmate by any officer of a reformatory except the Managers, or the Superintendent, or, in his absence, the officer appointed to act for him.

61. An inmate shall not be punished until he has had an opportunity of hearing the charges and evidence against him and of making his

62. The Superintendent shall not order any inmate to be placed in solitary confinement for any term exceeding 24 hours, nor shall the Managers order any inmate to be placed in solitary confinement for any term exceeding 7 days.

63. Every inmate in confinement shall be visited during the day by an officer at intervals of not more than 2 hours.

64. The Superintendent shall not have power to impose the punishment of bread and water for more than 24 hours, or any reduction of diet for more than a week.

65. No punishment shall be inflicted on any

such inmate is not in a fit condition of health to undergo such punishment.

66. Every inmate shall be deemed to have committed a breach of these regulations who shall be guilty of any of the following offences:

(a) Mutiny or incitement to mutiny.

(b) Violence to the serious injury of the person committed upon any officer or servant or upon a fellow inmate.

(c) Any other Act of gross misconduct or insubordination requiring to be suppressed by extraordinary means.

(d) Escaping or attempting to escape from the reformatory, or aiding or abetting another to escape.

(e) Introducing intoxicating liquors or drugs into the reformatory.

(f) Entering any premises in which intoxicating liquors are sold or taking any intoxicating liquor.

67. An inmate who has committed any of the offences specified in the immediately preceding regulation shall be liable on summary conviction before the Sheriff to a fine not exceeding £20 or to imprisonment, with or without hard labour, for a term not exceeding three months.

II.—REGULATIONS prescribing Conditions under which a Certificate to maintain a Certified Inebriate Reformatory will be granted by the Secretary for Scotland.

The application for certificate shall set out the following particulars :-

1. The name of the proposed reformatory.

2. The names of the managers, secretary, and treasurer.

3. A description and plan of the site for the reformatory and ground attached there-

4. The plans of the buildings and of the arrangements in connection therewith. These should be countersigned by the medical officer of health of the district.

5. The number and sex of inmates whom it is proposed to receive.

6. The particulars of the staff which it is proposed to employ.

7. The work upon which the inmates would be employed and the arrangements for affording them industrial training.

8. The rules framed for the management of the reformatory, which shall be in accordance with the regulations for certified inebriate reformatories approved by the Secretary for Scotland.

9. The reformatory should, if possible, be restricted to the reception of one sex. Where circumstances render this impracticable, due provision must be made for the separation of the sexes at all but defined hours.

Notes.

The site selected for a reformatory should be dry and airy, and have, if possible, a southern exposure.

It is desirable that the approval of the Secretary for Scotland of the site and buildings inmate if the Medical Officer shall certify that | should be obtained before any expenditure is

This Licence will be revoked if the Holder does not observe the following Conditions.

Conditions.

1. He shall faithfully obey the instructions of his guardian, or, in the guardian's absence, of those whom he shall place in authority over him.

2. He shall co-operate with his guardian for his own reformation.
