Whereas We have deemed it expedient that a Commission should forthwith issue to inquire into the causes of the accidents, fatal and non-fatal, to servants of Railway Companies and of truck owners, and to report on the possibility of adopting means to reduce the number of such accidents, having regard to the working of railways, the rules and regulations made, and the safety appliances used by Railway Companies:

And We do by these Presents anthorise and empower you, or any five or more of you, to visit and personally inspect such places as you may deem it expedient so to inspect for the more effectual carrying out of the purposes aforesaid, and to employ such persons as you may think fit to assist you in conducting any inquiry which you may hold.

And We do by these Presents will and ordain that this Our Commission shall continue in full force and virtue, and that you Our said Commissioners, or any five or more of you, may from time to time proceed in the execution thereof, and of every matter and thing therein contained, although the same be not continued from time to time by adjournment.

And We do furthur ordain that you, or any five or more of you, have liberty to report your proceedings under this Our Commission from time to time if you shall judge it expedient so to do.

And Our further will and pleasure is that you do, with as little delay as possible, report to Us under your hands and seals, or under the hands and seals of any five or more of you, your opinion upon the matter herein submitted for your consideration.

And for the purpose of aiding you in your inquiries, We hereby appoint Our trusty and well-beloved Alfred Herbert Higgins, Esquire,

Barrister-at-Law, to be Secretary to this Our Commission.
