TENDERS FOR LOANS ON TREASURY BILLS.

- 1. - 4. The Bills will be issued and paid at the Bank of England.
- 5. The persons whose Tenders are accepted will be informed of the same on Saturday the 1st proximo, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England not later than three o'clock on Thursday the 6th proximo.
- 6. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.
