### At the Court at Windsor, the 14th day of July 1899.

#### PRESENT,

The QUEEN's Most Excellent Majesty in Council.

WHEREAS by the "Burial Grounds (Scot-land) Act, 1855," as amended by "The Secretary for Scotland Act, 1885," it is enacted that it shall be lawful for Her Majesty from time to time, by Order in Council, upon the Representation of the Secretary for Scotland, that a copy of an Interlocator of a Sheriff of a County of Scotland under certain provisions of the said Act has been received, in pursuance thereof, to order that no new burial ground shall be opened within certain limits specified in such Order, save with the previous approval of the Secretary for Scotland (or as the case may require) that after a time mentioned in such Order burials within certain limits, or in certain burial grounds or places of burial shall be discontinued wholly or subject to any exceptions or qualifications men-tioned in such Order, and that such Order in Council shall thereupon have like force and effect as if the same were embodied in the said Act: Provided always that notice of such Representation, and of the time it shall please Her Majesty to order the same to be taken into consideration by the Privy Council, shall be transmitted to the Crown Agent in Edinburgh, and the Sheriff-Clerk of the County in which such burial ground in situated; and that the same shall be by them respectively published in the Edinburgh Gazette, and fixed on the doors of the Church of, or on some other conspicuous places within, the Parishes affected by such Representation, one month before such Representation is so considered ;

And whereas the Secretary for Scotland has made a Representation stating that he has received a copy of an Interlocutor by the Sheriff-Substitute of the County of Perth finding (1) that the Old Graveyard of Dunbarney Parish, on the Estate of Dunbarney, surrounded by the farmland of Eastfield, and situated two hundred yards or thereby to the north of the road leading from Bridge of Earn to Dunbarney House, is in a condition offensive and contrary to decency; (2) that the Churchyard adjoining Dunbarney Parish Church, in the Village of Bridge of Earn, is in a condition which is dangerous to health and offensive and contrary to decency:

And whereas in the said Representation it is recommended that the said Old Graveyard and Churchyard should be closed, subject to certain reservations :

And whereas notice of the said Representation, and of the time when it pleased Her Majesty to order the same to be taken into consideration by a Committee of the Lords of the Privy Council, has been duly published in the Edinburgh Gazette, and has been fixed as required by the said Act:

Now, therefore, Her Majesty, by and with the advice of Her Privy Council, is pleased to order as follows, viz. :---

- That burials be forthwith discontinued in the said Old Graveyard of Dunbarney Parish, and in the Churchyard adjoining Dunbarney Parish Church, subject to the following reservations, viz. :---
  - (1) In favour of the widows and widowers of those already buried there, and of unmarried persons who are over forty years of age on the date of the Order in Council closing the aforesaid
